Installing the Video Adapter

- 1. Connect the USB Host Connection to an available USB Port, on the Host Computer.
 - Note: This adapter is supported on Windows only
- 2. Connect an HDMI, DisplayPort, or VGA Cable (sold separately) from the Video Output on the USB Video Adapter, to the HDMI, DisplayPort, or VGA Input on the Display.
- 3. Arrange the display using Window's built-in Display Settings.
- 4. (Optional) Change the default **Audio Device** to the **USB Video Adapter** using **Window's** built-in **Sound Settings**.

Note: VGA does not support audio output
