

Description of the product	The main purpose of MN NSXm is used for emergency off or failsafe remote tripping applications on ComPacT NSXm and PowerPact B devices. The MN release instantaneously opens the circuit breaker when its supply voltage drops to a value below 35% of its rated voltage.
Functional unit	To trip the circuit breaker when the control voltage drops below 35% of its rated voltage. Between 35% and 70% of the rated voltage opening is possible but not ensured. This function is provided for 10 years. It complies with IEC 60947-2 standard.
