# 4 – First Aid Measures

**Ingestion (Swallowed):** Aspiration Hazard. DO NOT induce vomiting. Call physician, poison control center or the WD-40 Safety Hotline at 1-888-324-7596 immediately.

**Eye Contact:** Flush thoroughly with water for 15 minutes. Remove contact lenses if present after the first 5 minutes and continue flushing. Get medical attention if irritation persists.

Skin Contact: Wash with soap and water. If irritation develops and persists, get medical attention. Inhalation (Breathing): If irritation is experienced, move to fresh air. Get medical attention if irritation or other

symptoms develop and persist.

**Most Important Symptoms (acute and delayed):** Harmful or fatal if swallowed and entered airways. If swallowed, may be aspirated and cause lung damage. May cause moderate eye and skin irritation. Prolonged skin contact may cause drying of the skin. Inhalation may cause nasal and respiratory irritation and central nervous system effects such as headache, dizziness and nausea.

Indication of Immediate Medical Attention or Special Treatment: Immediate medical attention is required for ingestion.

## 5 – Fire Fighting Measures

**Extinguishing Media:** Use water fog, dry chemical, carbon dioxide or foam. Do not use water jet or flooding amounts of water. Burning product will float on the surface and spread fire.

**Special Fire Fighting Procedures:** Firefighters should always wear positive pressure self-contained breathing apparatus and full protective clothing. Cool fire-exposed containers with water.

**Unusual Fire and Explosion Hazards:** Highly flammable liquid and vapor. Keep away from ignition sources and open flames. Vapors are heavier than air and may travel along surfaces to remote ignition sources and flash back. A vapor and air mixture can create an explosion hazard in confined spaces.

## 6 – Accidental Release Measures

**Personal Precautions, Protective Equipment and Emergency Procedures:** Avoid contact with eyes, skin, and clothing. Eliminate all sources of ignition and ventilate area. Wear appropriate protective clothing (see Section 8).

#### 10 – Stability and Reactivity

The oral toxicity of this product is estimated to be greater than 5,000 mg/kg based on an assessment of the ingredients. This product is not classified as toxic by established criteria. It is an aspiration hazard.
