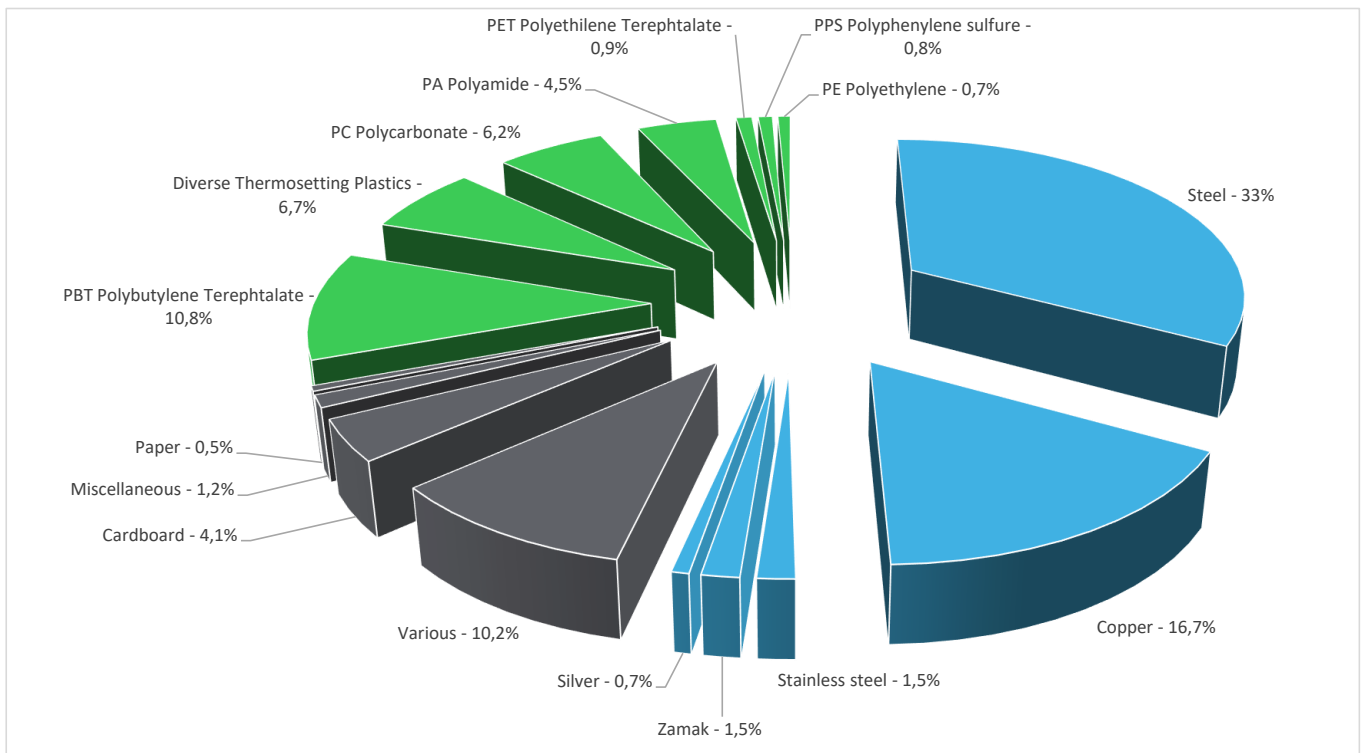


General information

Description of the product	The ComPacT NSX250F 3P circuit breaker equipped with a thermal-magnetic (TM-D) trip unit is designed to provide protection to industrial and commercial electrical distribution systems (with assigned voltage up to 690VAC and rated current up to 250A) against overloads and short-circuits.
Functional unit	Protect during 20 years the installation against overloads and short-circuits in circuit with assigned voltage up to 690V AC and rated current up to 250A. This protection is ensured in accordance with the following parameters: <ul style="list-style-type: none"> - Number of poles = 3P - Rated breaking capacity = F 36kA 415V AC - Tripping curve = Type C [LI = long time, instantaneous] - IP degree of protection = IP40 conforming to IEC 60529 - IK degree of protection = IK07 conforming to IEC 62262
