#### **KEY RESPONSIBILITIES:**

#### **Income Generation**

- Work closely with EDT colleagues to identify and prioritise funding gaps within EDT's HE/FE programmes – particularly the well-established Headstart and Inspire programmes
- Research and write fundraising applications to trust and foundations, statutory bodies and corporate partners
- Prospect and profile potential funders (trust and foundation, statutory bodies and corporates) to build a sustainable pipeline of income generation and engagement opportunities
- Provide the Director of Fundraising with regular updates on targets
- Working with the Director of Fundraising, develop a six-figure income generation plan for EDT's HE/FE programmes, including a weighted pipeline to August 2020 and beyond

# **Relationship Management**

- Ensure effective systems and processes are in place for research, engagement and stewardship to deliver a professional fundraising programme across EDT's HE/FE programmes
- Monitor the progress of HE/FE programmes, ensuring payments are received on time and reports submitted as required
- Develop a clear benefits track for all HE/FE partnerships
- Work with colleagues across EDT (including Headstart & Inspire Programme Team and Key Account Managers) to ensure all funding partners receive excellent stewardship and partnership development opportunities are identified and developed

- As appropriate, attend events to meet and get to know donors and potential supporters, representing EDT
- Facilitate cultivation events and networking opportunities in line with strategic priorities
