The aim of the Project Workers' posts is to provide information on Violence Against Women (VAW) and in particular Gender Based Violence (GBV) to men in communities where this is known to be practiced.

Trainee Men's Project Worker post is to build trust by providing One to One support to people from these communities, in order to:

- Help with language barriers and assisting men to access services
- Raise awareness of human rights and responsibilities
- Raise awareness among men about VAW and GBV and the consequences of it
- Motivate men to participate in challenging VAW and GBV among their families and communities

Job description

Trainee Men's Project Worker

- 1. Provide support to individuals in relation to general issues by signposting to other organisations
- 2. Provide One to One support and information to individuals within the target groups
- 3. Assist men to have access to main stream services

- 4. Assist men with interpreting where appropriate
- 5. Carry out the administration of information sessions for groups or individuals
- 6. Assist with organising and facilitating discussions and group seminars
- 7. Build links and capacity with organisations within practicing communities
- 8. Maintain databases and analysis of evaluation forms as required
- 9. Adhere to legal requirements and best practice especially in relation to protection of children and vulnerable adults
- 10. Attend training or events as required
- 11. Maintain high levels of confidentiality
- 12. Carry out any further appropriate duties which might arise to further the interests of the client group and of CIS
- 13. Support the ethos and aims and objectives of Community InfoSource at all times

This post is subject to a 6 month probationary period with a review at 3 months.
