Freelance Grant Assessor

We are looking for a diverse group of Grants Assessors with knowledge and experience of different aspects of the economy to support our grant application processes and make objective assessments of full (second stage) applications for funding.

We are particularly interested in people with the following knowledge and expertise:

- 'Lived experience' of being marginalised in economic policy issues and/or of addressing systemic structural inequalities. This means a special focus on those who hold social identities across racialisation, class, gender, disability, age, faith, sexuality, age, class and geographic location.
- Non-mainstream perspectives on the economy (e.g. decolonial; ecological; green/recovery; feminist, foundational)
- In-depth knowledge about corporate and investor behaviour change (particularly asset management industry, business structures, tax behaviours)
- Experience/expertise in local level work, be that from a Local Authority, community coalitions that take on wider projects, another funder etc
- Democratising land-based assets, and the link between local economies/communities and land use and national policy

We are also keen to recruit Assessors from across the four nations of the UK and would particularly encourage applications from people based in Northern Ireland, Scotland and Wales.

In this role you will be asked to undertake a review of application documents followed by either a telephone or face-to-face interview with the applicant so you can really get a feel for what they are proposing. We then ask you to produce a written report and work with us to finalise recommendations for whether the proposal should be funded.

The position is a part-time, freelance commitment, for occasions when we have a large number of applications. Applications are submitted quarterly but we cannot guarantee work every quarter. You will be paid a flat fee of £200 per assessment, plus travel expenses when accompanied by receipts. You will also be asked to attend a half day application review meeting which will be paid at £50.

About the role

The purpose of the role is to make objective assessments of full (second stage) applications for funding made to Friends Provident Foundation. The assessment involves a review of application documentation followed by either a telephone or face-to-face interview with the applicant and a written report. The position is a part-time, freelance commitment. We estimate that the time required per assessment is likely to 1-2 days (from setting up the interview to write-up).

The Foundation has four funding rounds per year but we will only contact you on occasions when we have a large number of applications, we also understand that you may not be available every quarter.

We will provide applications for assessment to you as soon as possible after the submission deadline, electronically. You will need to be responsive to applicants' requirements in arranging assessments which may require flexibility.

It is an important feature of this process that assessors can assess the structure and viability of the applicant organisation and the proposals for their projects while retaining independence in decision-making.

Experience of assessing is desirable as is an understanding of the legal framework relating to the funding of charitable activity. Assessors must be able to identify issues that need to be investigated in order to give a full picture of the organisation, proposed work and the fit with the Foundation's objectives.

The task of the assessor is to review application materials from both stages of the application process, the comments provided by staff/trustees and the advisory group on the first stage application, and develop a method for clarifying, confirming and understanding the proposed work.



About the role continued

The aim is to formulate an analysis of the information gathered and a sense of:

- The purpose, financial health and governance structure of the organisation leading to a judgement on its capacity to undertake the work.
- The feasibility of the proposal: in terms of match between aims and methods, timescale, budget and strategic impact.
- The organisation's approach and commitment to equality and social justice and to tackling climate breakdown.
- The level of risk the proposal represents along key dimensions.
- The legal framework of the work within the Foundation's legal guidelines.
- A draft statement on the fit of the proposal with the Foundation's objectives.
- A draft recommendation for funding for discussion with the Foundation's grants team as part of a portfolio review discussion.

Assessors will submit a report using the Foundation's assessment template and take part in a portfolio review meeting with us where assessment outcomes and recommendations will be discussed and considered. Assessors should note that their recommendation is made to the Foundation team who may decide on a different recommendation to Trustees subject to wider strategic or grants portfolio considerations.

Location

Assessors are expected to work remotely. In the future the option of working from the Foundation's office in York may be available if desirable. Assessors will be required to attend a meeting with staff and fellow assessors once per grant round. These are currently held online but may involve face to face meetings in the future.

- Analytical skills
- Ability to interpret financial information
- Ability to assess feasibility of projects
- Good communication skills
- Ability to meet tight deadlines
- Ability to write reports with clarity
- Good computer skills
- A good understanding of the voluntary sector

Desirable:

- Experience of assessing (including transferable experience)
- An understanding of one or more of the policy areas highlighted below:
- o 'Lived experience' of being marginalised in economic policy issues and/or of addressing systemic structural inequalities. This means a special focus on those who hold social identities across racialisation, class, gender, disability, age, faith, sexuality, age, class and geographic location.
- o Non-mainstream perspectives on the economy (e.g. decolonial; ecological; green/recovery; feminist, foundational)
- o In-depth knowledge about corporate and investor behaviour change (particularly asset management industry, business structures, tax behaviours)

What we collect and why

When you apply to us for a role you will be providing personal data about yourself, through which you can be identified. We have written this notice to let you know how we will handle and protect your information.

Information which may be collected during a recruitment process, may include:

- Name
