JOB DESCRIPTION:

This is an exciting opportunity for someone with the enthusiasm and experience to lead our policy work to create real and lasting change and make a difference to the lives of children and young people in Scotland. The Legal Policy Manager will work as part of the Clan Childlaw team and develop our relationships with key influencers and policy makers.

At Clan Childlaw, we work with children and young people every day, so we can see when the law not working properly to protect children's rights. We ask decision makers and lawmakers to change the law and the way the law is used to make sure that children and young people's rights are a reality in Scotland. To date, Clan Childlaw has successfully used the law to tackle a number of issues affecting children in Scotland including sibling rights, right to privacy, access to justice, voice of the child, minimum age of criminal responsibility, impact of childhood offending in later life, and care leavers rights. We work collaboratively with voluntary sector organisations, lawyers and other professionals working in the field of children's rights to identify ways to use the law to further children's rights in Scotland. We are committed to delivering on The Promise Scotland and to the implementation of the United Nations Convention on the Rights of the Child.

- Contribute to briefings and submissions
- Work closely with the Communications Manager on communications to drive forward policy aims, including publicity and promotion and responses to media and enquiries on policy issues.
- Work collaboratively with voluntary sector organisations, lawyers and other professionals working in the field of children's rights in support of policy outcomes.
- Evaluate the impact of policy work and write reports for funders
- Represent Clan Childlaw at different public forums and be the face of our policy work
- Manage and coordinate policy related events and groups

REQUIREMENTS:

- Demonstrable experience of
 - o delivering policy outcomes
 - o influencing external policy/decision making
 - o campaigning, publicity and working with the media
 - o managing projects
- Understanding of the relevant areas of public policy which may include, but is not limited to one or more of the following: children's rights, human rights, and social welfare law in Scotland
- Relevant degree or equivalent professional experience or qualification
- Excellent written and oral communication skills including an ability to analyse complex material and present the results in a clear and concise, accessible manner
- Experience dealing with sensitive and confidential information and GDPR compliance.
- Good judgement and ability to manage own workload
