School of Hard Knocks works with unemployed adults and school children at risk of exclusion to give participants the tools to improve their lives. This is principally achieved by teaching a strong set of values, attitudes, behaviours and skills. Physical activity and class-based session are combined to teach, demonstrate and impress the key messages.



Sessional Behaviour Specialist -Scotland

Job Summary

The Sessional Behaviour Specialist will work alongside SOHK Lead Behaviour Specialist and Facilitators to lead on the non-sporting activities of the SOHK for Schools Programme delivery in Scotland, predominantly Edinburgh, Glasgow and Central Belt. This includes group workshops, one-to-one mentoring and liaising with school staff. This role is centred around helping the pupils we work with increase their wellbeing and self-awareness; ultimately to take responsibility for the areas of their lives that are directly within their control.

SOHK for Schools is a 3-year intervention, working with groups of around 20 pupils from S1 until they finish S4 and complete their Nat 4/5s. The pupils will be chosen by the school and will typically be the 'hardest to reach' young people. We will work with them for half a day every week, delivering rugby training, classroom sessions on subjects such as growth mindset, goal setting and choices and we'll deliver weekly 1:1s. The programme will be evaluated by SOHK staff, teachers, parents and the pupils themselves.



Key Responsibilities

- Working with the SOHK Scotland team to maintain the highest possible quality in their Schools programme
- Leading on the delivery of the SOHK mentoring programme for S1-4 pupils, on a 1:1 basis and in a whole group setting
- Working with Lead Behaviour Specialist in reviewing and improving the SOHK group mentoring programme around the core principles of School of Hard Knocks, The 5 Cs (Confidence, Communication, Commitment, Cohesion and Control) that suit the needs of the group
- Facilitating and delivering wellbeing and personal development sessions
- Providing information and advice to enable pupils to make choices about their own learning, behaviour and attendance. Working with SOHK Scotland on monitoring and evaluation, admin and data input - making sure all records are accurate and timely
- Being aware of and supporting differences along with ensuring all pupils on the programme have equal access to mentoring
- Being aware of, and complying with, policies and procedures relating to child protection; health and safety; confidentiality and data protection, reporting all concerns to the programmes manager
- Working with SOHK Scotland Schools team to ensure best practice and share ideas, skills and information
- Safeguarding children effectively- using SOHK and school's policies, referring concerns appropriately to the SOHK and school leads



Skills, experience and Person Specification

- Knowledge & understanding of the developmental stages of children and young people and appropriate intervention approaches
- Ability to build rapport with young people with a variety of needs
- Have proven skills and experience in engaging with challenging children and young people
- Ability to deal with exposure to distressing information. Be able to communicate a positive, caring attitude, and actively listen to the child or young person and others involved in their care
- Maintaining & enhancing effective working relationships with SOHK and school staff
- Comprehensive understanding of Safeguarding best practice, including how and when to disclose information and to refer participants to healthcare professionals
- Ability to tailor interventions to meet the needs of the students on the programme and support staff to maintain these interventions.
- You will be full of enthusiasm and positive energy and a great role model to those on our programme
- You will have a growth mindset, always ready to accept new challenges
- You will be extremely driven and passionate to deliver the charity's objectives, in line with its values of Integrity, Excellence, Empowerment and Commitment
- You will set standards in your own delivery, being meticulous in your preparation and reviews.
