You'll also take responsibility for additional tasks in support of Maitri's grant management function, as needed.

As a Grants Manager you'll:

- Manage a portfolio of partnerships supporting them through Maitri's grant cycle, managing risk and monitoring progress.
- Build open and trusting relationships with partners to ensure the most impactful use of Maitri's funds.
- Assist with the identification of potential new grantees and conduct robust due diligence on those with whom we partner.
- Co-ordinate the production of grant proposals and write summaries and updates for presentation to the Maitri Board.
- Work collaboratively with the rest of the Maitri team, particularly the Grants Management team and Head of Learning.
- Undertake international travel as appropriate to conduct field visits and attend conferences.
- Represent the Trust at external events, conferences, meetings and webinars.
