### **FUNDRAISING & ENGAGEMENT DEPARTMENT**

JDRF receives no direct government funding so all our income is voluntary income raised by the fundraising department. Our enthusiastic and committed fundraising team works in a diverse range of income generating activities with successful mutually rewarding relationships with our supporters always at the heart of what we do.

### **PURPOSE OF THE ROLE**

To lead on the development and implementation of JDRF's fundraising strategy in Scotland, responsible for growing income and delivering a strong ROI across DIY fundraising, corporate, trusts, major donor and events streams (working in concert with Active Events team on sporting events).

To identify and deliver new opportunities for income generation in Scotland, working closely with UK-wide teams, and overseeing management and development of existing portfolio of activities (eg Edinburgh Ball).

To increase the visibility of JDRF's activities through engagement with key stakeholders and decision makers in policy development and delivery in public health Scotland relating to type 1 diabetes, resulting in increased donations and support.

## **KEY RESPONSIBILITIES**

The Head of Scotland (Fundraising) will be responsible for developing and implementing a comprehensive fundraising strategy in the nation that achieves our ambition to build income by 45% from £350k in the current financial year to £500k plus+ by financial year 2026. The Head of Scotland (Fundraising) will collaborate with public affairs and community engagement as well as income generation teams. This will enable the postholder to access the strategic policy thinking in the nation, stewarding relationships with key senior stakeholders to drive growth and engagement across Scotland. The postholder will hold a key



co-ordinating and development role helping to deliver on organisational mission in Scotland. Key responsibilities will be

- To work closely with the Deputy Director of Fundraising to develop JDRF's strategy for fundraising in Scotland, incorporating UK wide initiatives and bespoke national approaches to suit the local context.
- To lead cultivation of major donor and corporate prospects in Scotland and provide ongoing stewardship/account management to grow value, including developing proposals and reporting, working with internal teams.

To steward JDRF's relationships with key decision makers in the Scottish government, NHS Scotland, academic institutions, charities and patient groups relating to type 1 diabetes in order to further JDRF's mission goals and income growth.

- To contribute to the delivery of JDRF's Fundraising and Engagement strategy as a member of the departmental senior leadership group, The Fundraising Management Team
- To manage the JDRF Scotland team of two Fundraisers, providing support, development and guidance.
- To recruit and deliver ongoing stewardship to DIY fundraisers in Scotland, offering advice, materials and support, to maximise income and build lasting relationships, allocating resources using the data-driven principles of relationship fundraising.
- To lead management of events in Scotland, including the Edinburgh Ball and One Walk, working with supporter committees, and JDRF Special Events and Active Events teams, recruiting and stewarding participants to ensure activities deliver on budget.
- To identify and develop new initiatives and recruit participants in Scotland to national fundraising campaigns and events through relationship fundraising to drive income from supporters, working in concert with other teams as required.
- To lead team's involvement in the digital space, focusing on guidance to supporters on use of digital platforms, working closely with Supporter Care & Stewardship, Finance, Digital and the Database team to ensure consistent practice UK-wide.
- To lead on fundraising admin in Scotland, including income processing as required, working with Finance and other teams to maximise efficiency.



- To provide, with their team, first contact support for supporters who contact JDRF Scotland by phone, email and other channels.
- To work closely with other Fundraising teams to pitch JDRF's fundraising offer to SMEs, schools and other groups in Scotland, primarily via relationship fundraising with committed individuals.
- To support volunteers as required, in pursuit of JDRF's fundraising objectives.
- To undertake other duties as required.
