Job Advert

The Children and Young People's Centre for Justice (CYCJ) ensures that Scotland's approach to children and young people in conflict with the law is <u>rights-respecting</u>, contributing to better outcomes for our children, young people, their families and communities. Based at the University of Strathclyde, we produce robust internationally ground-breaking work, embedding children and young people's contributions, research evidence, practice wisdom and system know-how to operate as a leader for child and youth justice thinking in Scotland and beyond.

Current system changes including the Children (Care and Justice) Bill, Children's Hearing Re-design, and potential increase in the Age of Criminal Responsibility starkly highlight the urgent need for a national intervention approach to increase workforce competence and increase community confidence in these changes. To successfully uphold the UNCRC, #KeepThePromise, and remove children from adult justice systems we need robust child-friendly alternatives.

We are looking to recruit a Practice Development Associate to support work funded by the Promise Partnership. To work with the CYCJ practice team to develop and deliver training to support a national developmental intervention approach, suitable for a wide workforce (police/education/social work-children and families & justice/residential and secure care/third sector/foster carers/health).

The approach will be built on the founding principles of UNCRC, the Promise, and the GIRFEC national practice model to ensure that it can be embedded within universal practice and be non-stigmatising/labelling.

The post holder should be experienced in supporting the development and delivery of training.

To be considered for the role, you will have a good honours degree and/or equivalent professional experience) in appropriate discipline. You will have sufficient breadth or depth of knowledge in the relevant discipline/s to contribute the existing work of the Department. You will have the ability to conduct individual projects, work directly and independently with external partners.

Job Description

Brief Outline of Job:

This post will join the practice and policy team within the CYCJ to support the development and delivery of a national developmental intervention approach, suitable for a wide workforce (police/education/social work-children and families & justice/residential and secure care/third sector/foster carers/health). This will include:

- A practical training package, delivered to the wider workforce, on the best ways to respond to children's distressed behaviour to reduce the criminalisation of children in care
- Training for the wider workforce in retaining 16- and 17-year-olds within the children's hearing system
- A developmental trauma-informed intervention approach that helps map the developmental milestones achieved and collaboratively plan goals to meet any unmet need (including domains of attachment/self-regulation/cognitive skills/social skills/adaptive living skills/healthy sexuality).
- A practical training package on the intervention approach, delivered to those working to support the meeting of developmental milestones.
- To undertake a range of analysis relating to policy in Scotland; to establish a personal knowledge exchange portfolio and plan knowledge exchange proposals, with assistance from senior colleagues as required; to engage where required in relevant research and teaching; and input to administrative activities.

Main Activities/Responsibilities:

- Contribute to the development of training material through a variety of means (on-line, written, face to face) to meet requirements with the UNCRC, GIRFEC and The Promise.
- 2. Contribute to the delivery of training, across Scotland to different professionals, through different means, including face to face and through on-line resources.
- 3. Contribute to the development and implementation of different pieces of work within CYCJ Practice team, making links to the participation and research workstreams.
- Share learning of the training and wider CYCJ work through planning and implementing national and local events, training, conferences and formal communications. This will include identifying and developing relevant themes for those working in the youth and criminal justice sector and communication through a range of knowledge exchange publications and resources, which will engage and inform others in the field.
- 5. Collaborate with colleagues to promote, communicate, and disseminate knowledge and information with relevant professional bodies across Scotland, Britain and internationally to advance knowledge exchange.
- Participate in effective communications internally and externally through networks, written reports, publications, and a range of media; liaise with Local Authorities, Scottish Government and other relevant organisations and professional bodies to promote the work of the CYCJ and ensure project deliverables are achieved in order to improve practice in youth and criminal justice.
- 7. Ensure that your work in the CYCJ practice work stream is underpinned by research and evidence-based practice, through keeping up to date with new research and publications.
- Work in partnership with colleagues to communicate and engage with all youth justice stakeholders to support practice development, specifically ensuring that the views and experiences of children, young people and their families are taken into account.
- 9. Assess and evaluate outcomes of specified projects and activities, reflecting on practice and using this to develop further ideas for new initiatives to improve youth and criminal justice practice.

- In collaboration with colleagues, provide detailed reporting of CYCJ activities to enable activity and impact reporting of your work within the sector to the relevant governance body and funders.
- Promote and support the mission, vision, values and principles of governance of the CYCJ, and, by personal example and quality of contribution, promote a culture across the youth justice sector of reflective, evidence-informed practice.
- 12. Contribute to research within the CYCJ and youth justice teaching in social work education in Scotland.

Conditions of Employment

Knowledge Exchange Staff



1. GENERAL CONDITIONS

Members of staff are subject to the Charter and Statutes and the Ordinances and Regulations of the University, published in the Calendar, and to any amendments or additions thereto approved by the University Court and, in the case of the Charter and Statutes, the Privy Council. Staff are also expected to familiarise themselves with, and adhere to, general University policies and procedures, as published on University web pages.

The University Court recognises Strathclyde Universities and College Union (SUCU) as the sole body with which it will negotiate and consult on all collective issues concerned with the terms and conditions of employment of Knowledge Exchange Staff. Such terms and conditions may be varied by the University Court after negotiation and consultation with SUCU.

Each member of staff is responsible for the proper performance of allocated duties to the person or persons specified in the member of staff's letter of appointment and any accompanying papers.

The University is committed to ensuring that its business is conducted in an open and transparent manner and will take all appropriate steps to address risks of bribery or corruption. Members of staff are required at all times to act honestly and with integrity and to safeguard the resources for which they are responsible. The University has in place a robust Public Interest Disclosure (Whistleblowing) Policy to enable concerns to be brought to its attention. This is available at www.strath.ac.uk/publicinterestdisclosure. Other relevant policies, e.g. Fraud Prevention and Conflicts of Interests, can also be found on the University's website.

Any member of staff may at any time be exposed to commercially sensitive information, information related to potentially valuable intellectual property or information which may otherwise be of a confidential nature. This information, which could be found anywhere in the University, may be written or disclosed orally, can include information of a commercial or technical nature, and may be owned by the University or by third parties. The University requires all employees to keep any such information confidential in the first instance and not disclose, publish or otherwise disseminate it without prior consent of the University. Such confidentiality obligations are commonplace and in the commercial interests of the University. When in doubt advice should always be sought from Research and Knowledge Exchange Services prior to disclosure.

The University operates probationary periods for new staff, the duration of which will be specified in individual letters of appointment. The normal probation period for posts in this staff category is 9 months for those at grades 6 and 7, and 12 months for grades 8 and above. 2. SALARY

Appointments are made at an appropriate salary point on the University's grading structure, with initial placing determined according to qualifications and experience. Increments are paid to staff on the 12 month anniversary of their appointment. Where this is not the first of the month, the increment will be paid on the first of the month directly

after the 12 month anniversary. This allows 1 progression to the next point on the salary scale until the top guaranteed point of the scale is reached.

Salaries are paid directly to staff members nominated bank account, normally on the second last working day of the month.

3. HOURS OF WORK

Working time is that required to fulfil the duties of the post. The University Court recognises that Knowledge Exchange staff carry out their duties in a variety of ways appropriate to the nature of their role, but expects work to generally be performed during normal working hours on week days. There are exceptions to this pattern which may involve contact at other locations or in the evenings, or at weekends, but these arrangement will be made with the agreement of the member of staff concerned.

Duties may, by arrangement with Head of Department/School/Director, include some teaching associated with the post (up to a maximum of 40 hours per semester) for which no additional payment will be made.

Additional work which does not fall within the scope of that described above may by arrangement attract payment which must be authorised and processed through the payroll.

4. HOLIDAYS

Annual leave entitlement is 31 days per year to be taken by agreement with the line manager. For staff members working on a part-time basis, holidays will be calculated on a pro-rata basis.

In addition to annual leave there is an entitlement to eleven public holidays per year which should be taken on days that the University is closed for this purpose. The University presently closes for four additional days over the Christmas and New Year period. These additional days count against the annual leave entitlement.

For staff members working on a part-time basis, public holiday entitlement will be calculated on a pro-rata basis.

Annual leave and public holiday entitlements should be taken in the leave year to which they relate. Up to five days leave can be carried forward into the new leave year subject to line management agreement. In exceptional circumstances, Heads of Department/School/Director may approve carry forward of accrued annual leave in excess of five days.

The University's expectation is that staff take all accrued holidays prior to their termination date. If staff have exceeded their entitlement the University will deduct an equivalent number of days pay from final salary payments.

5. SICKNESS ABSENCE

During any period of absence through illness or injury provided the appropriate notification and certification procedures have been followed the University will pay a member of staff (having taken account of the aggregate of all periods of absence due to illness during the twelve months immediately preceding the first day of the current absence) as follows:

In order to manage the University's sick pay scheme the University requires to maintain sickness absence records on individual members of staff. When making payments after the expiry of statutory sick pay the University will deduct an amount equivalent to any benefit normally payable by the Department of Work and Pensions. 6. PENSIONS

If you are under age 75 at the date your appointment commences you will automatically become a member of the pension scheme operated by the University — the Universities Superannuation Scheme (USS). You will be admitted to the career revalued benefits scheme called the USS Retirement Income Builder; the contribution rate that currently applies is 9.8% of pensionable salary. A threshold applies to the maximum salary that counts towards the USS Retirement Income Builder. The current threshold from I April 2023 is £41,004 per year. Contributions based on salary above the monthly equivalent rate of the threshold are paid to the defined contribution section of the scheme called the USS Investment Builder. The scheme booklet is called 'Your Guide to the Universities Superannuation Scheme'.

The University operates a salary exchange arrangement, Pensions Plus, for members of the USS. Pensions Plus enables pension contributions to be made in a manner so that both employees and the University can benefit from available National Insurance Contribution savings. You will be automatically included in Pensions Plus, provided it does not adversely affect your take-home pay or your ability to claim certain state benefits. If your earnings fall below the Pension Plus pay protection limit you will be opted out of Pension Plus. This will not affect your membership of the USS.

New members of staff may opt out of USS within three months of taking up appointment and will then be treated as if they had never been a member of the scheme. After three months members of staff who wish to withdraw from USS during their employment will be required to give a minimum of 28 days' notice in writing to the University. Any member of staff who wishes to opt out should contact the Pensions Section, Finance, in the first instance (pensions@strath.ac.uk). Please note that if you are a member of Pensions Plus and withdraw from USS with less than two years of membership, or cease employment with the University and have less than two years of USS membership, the option of a refund of pension contributions will not be available to you. Instead, USS must provide you with a pension benefit that is payable from your Normal Pension Age. Regardless of whether you participate in Pensions Plus, if you are a member of the pension scheme for two years or more you are not entitled to a refund of pension contributions on leaving the scheme, you will be entitled to a pension benefit.

The University reserves the right to alter or withdraw Pensions Plus as it sees fit or as required to comply with legislative changes. Withdrawal or amendment of Pensions Plus will not affect your membership of USS. If you do not wish to participate in Pensions Plus but wish to remain in

the pension scheme please contact the Pensions Team who will provide you with a non-participation form.

7. PLACE OF WORK AND RESIDENCE

Members of staff will be based on the John Anderson Campus, unless otherwise stated in the letter of appointment. The Department/School in which the post is initially placed will be specified in the letter of appointment although there will be an expectation to work at such other places as required in the course of employment.

If the need arises for members of staff to work outside the UK for a period (or periods) of more than one month then such arrangements will be subject to mutual agreement. Members of staff would then be provided with a statement in advance setting out the terms covering such periods of employment.

The University does not normally place specific restrictions upon the place of residence of members of staff. All staff are, however, expected to reside in a location which is compatible with the satisfactory fulfilment of all the duties associated with their appointment.

8. CONSULTANCY/FURTHER ACTIVITIES

To support the strategic objectives of the University and to facilitate individual professional development, the University encourages staff to engage in professional activities with outside bodies related to their field of work. In many cases, such activity will be approved on the basis that it represents University knowledge exchange activity and should therefore be treated as part of the individual's overall workload and managed through the University's systems. It is also recognised that there will be some cases where an activity is entirely separate from the University and should thus be notified/approved as a personal business activity. 9. DISCIPLINARY AND GRIEVANCE PROCEDURES

10. NOTICE AND TERMINATION

The employment of a member of staff is terminable by at least three months notice in writing, on either side; except during probationary period when the notice period is one month. If notice is being given by a member of staff earlier release may be granted if this can be arranged without detriment to the work of the department or area. If the appointment is for a fixed term it will expire at the end of the period without the necessity for notice. Fixed term contracts may be terminated by either party short of the expiry date by the serving of one months' notice in writing. The University is not obliged to continue a fixed term appointment beyond the employment period.
