The Beacons Initiative

Liber8's Beacons Project is four Recovery focused venues in the four localities of South Lanarkshire, Hamilton/Blantyre: Cambuslang/Rutherglen: Clydesdale / Lanark and East Kilbride. Due to the success of the past four years, we are significantly expanding our team and require counsellors to join this dynamic project.

The Beacons provide a range of recovery focused activities and opportunities to people in their recovery journey to help maintain and continue with their journey. There are also activities and services available to families of loved ones in recovery.

Liber8 are seeking to recruit 3 part time Counsellor / Therapists to join our Beacons team and to support the ongoing successful Beacons Project.

The post holders would be expected to deliver evidence-based techniques, recommended by NICE/SIGN as, effective approaches in addictions, mental health issues, and associated issues. Essentially, they will be competent in designing and delivering psychoeducational group programmes and workshops. Further they will contribute to the Beacons ethos of having open, welcoming and Psychologically Informed Environments.

Job Description and Job Specification

Job Role: Counsellor / Therapist

Purpose of Job Role

The postholder, will provide specialist counselling/therapy and group work to people, who have experienced alcohol and or substance use and associated issues. Demonstrable experience of working in the area of alcohol and or substance use and facilitating, or co-facilitating groups is a requirement for this post.

The post holder will work closely with the Beacons team including the mental heal and wellbeing practitioners to promote, encourage and celebrate recovery. They will be able to foster a culture and and maintain a psychologically informed environment. We are looking for counsellors/ therapists who work in an integrative way, rather than being confined to a single therapeutic approach. We also welcome applications from those who are able to bring experience of expressive and creative therapies to their work.

Key responsibilities

- Operate a suitable appointment system flexible to the needs of providing a scheduled drop-in service if an identified need.
- Provide participants with a range of psychosocial and psychological group work sessions/workshops/programmes on a variety of topics e.g. anxiety/ social skills /social anxiety/ emotional regulation / relapse prevention.
- Contribute to the evaluation of the project by using a range of clinical wellbeing, evaluation and measurement tools, including CORE System.
- Provision of effective clinical assessments and evidence-based treatment plans
- Be able to understand clinical presentations and needs, and to develop an effective approach to meeting these, using established counselling and/or psychotherapeutic models.
- Develop and facilitate theme-based supportive discussion groups and awareness sessions for participants, working alongside the recovery workers.
- Supporting clients to set and achieve identified goals, positive outcomes and assessing and demonstrating progress to ensure timely completion of treatment.
- Develop and maintain adequate records of clinical work: maintain accurate and up to date records of all work undertaken and to produce evaluative reports and presentations when required.
- Working to BACP/COSCA/BABCP, Standards and Ethical Frameworks.
- Maintaining own professional standards and accreditations, including CPD and any other requirements
- To deliver group work relating to substance use, relapse prevention and recovery management.
- Delivering a structured therapeutic programme through one-to-one intervention.
- Where required, take responsibility for the planning and delivery of psycho- educational workshops.
- To work in accordance with Liber8s policies, procedures and working practice agreements.
