About Alzheimer Scotland



About the role

The purpose of the Specialist Dementia Carer Link Worker role is to provide specialist dementia expertise and support to those affected by dementia, with a specific focus on family carers. The Specialist Dementia Carer Link Worker will support families referred to the service.



Key responsibilities

Role specific responsibilities

 To provide specialist evidenced based intervention, practical advice and emotional support for family carers of people with dementia and where appropriate people with dementia themselves at all stages including bereavement.

- To meet the multiple and often complex needs of family carers affected by dementia through ongoing assessment of health and well-being, including risk assessment, developing, implementing and evaluating intervention plans.
- To advise on, recommend and provide a range of effective evidence-based interventions at all stages of the families experience of dementia, paying particular attention to loss, transitions and changing relationships.
- To provide a range of evidence-based interventions to promote health and assist with the alleviation, prevention and management of stress, depression, anxiety and other mental health needs of carers.
- To offer expertise and guidance to professional colleagues, the public and others in supporting family and relationship-centred approaches and best practice in dementia care.
- To assist with the development, evaluation and audit of the interventions and specialist advice. Support the development of the Specialist Dementia Carer Link role.
- To provide up to date advice, support, liaison and in negotiated circumstances education and training to other staff/agencies.
- To assist families affected by dementia and/or colleagues, to develop skills and competencies in understanding and develop coping strategies, in both individual and group situations. For example, managing complex conditions, adapting responses when supporting the person with dementia, changes in relationships, distressed presentations.
- To act as advocate for family carers (with permission) to facilitate access to services and influence care provision.
- To identify development options for addressing inequality and to contribute to strategies designed to improve access to services for people with dementia and carers who are socially excluded.
- To recognise the limits of their own competency and professional boundaries and to make appropriate and timely referral in respect of clients' needs.
- To facilitate and participate in case conference meetings, network meetings and similar, giving feedback and liaising with all concerned.

Other responsibilities

- Ensure Health and Safety is actively monitored and implemented and identify and manage risk in line with Alzheimer Scotland's operational guidance.
- Use IT systems appropriate to the role, including Microsoft Office suite, ALIS (intranet), and iTrent (HR and People system) and ensure all required measures to relating to the safe and secure use of sensitive and personal data are adhered to at all times.
- Actively collaborate with peers and colleagues both internally and external to the Charity, as appropriate to the role, in developing positive working relationships and collaborative, flexible approaches.
- Operate within the context of all Alzheimer Scotland policies and procedures.
- Participate fully in team meetings, learning and development opportunities and CPD/ CPL activities, and personal review and appraisal meetings.

- Adopt and maintain a positive approach in supporting, contributing to, and enabling effective employee voice.
- Actively support and promote the integration of volunteer activity and effective volunteer voice.
- Work flexibly and undertake any other appropriate duties commensurate with the general remit of the role, as required.
