CHAIRPERSON'S STATEMENT

Thank you for your interest in joining the Board of Community Transport Glasgow (CTG). CTG is one of the largest Community Transport Organisations in Scotland. We currently provide transport to 75,000 passengers per annum equating to 140,000 journeys.

CTG offers affordable, reliable, accessible transport provision to the communities of Glasgow and the surrounding areas. We provide an array of transport solutions including registered bus services, door to door transport, group transport to other third sector and community organisations, Assisted Support for Learning School Transport and transport for the NHS. We also operate a Transport Hub co-ordinating transport, training and an employability pathway programme.

We work with a number of stakeholders including other Third Sector and Community Organisations, Strathclyde Partnership for Transport, NHS Boards and Glasgow City Council.

Over the coming months we will be developing a new strategy for the next 3 to 5 years and we are looking to expand our Board so that we have the necessary expertise and knowledge in key areas. It is an exciting time for the Community Transport Sector in Scotland with a number of future opportunities that we want to ensure we are equipped to able to deliver.

INTRODUCTION

Community Transport Glasgow (CTG) was established in 2005 and became a Charity and Company Ltd by Guarantee in 2009. Its aim is to provide relief to communities of Glasgow and the surrounding areas who are in need due to age, mobility, mental and physical disability, illness and poverty.

This is achieved by providing affordable, reliable, accessible transport solutions to the local communities we serve who include older adults and those with mobility issues and disabilities. We provide transport solutions to over 75,000 passengers per annum equating to over 140,000 journeys

CTG has an ambitious strategy with a vision to develop a community-centric transport system which is multi-model, more accessible, less polluting, better co-ordinated, flexible and above all shared. This means we take a holistic approach to transport and as well as providing transport solutions we also provide training, an employability pathway programme, transport co-ordination through our Transport Hub and are working towards a low carbon fleet.

Our Vision

"For increased and enhanced community transport services across Greater Glasgow, which are more frequently used by people isolated through location or circumstance, in order to improve their quality of life; and to widen the social and economic impact of community transport in these same communities."

Our Mission

"Is to provide quality, sustainable and reliable community transport and related services to meet the needs of local communities in Glasgow and the surrounding areas."

Our Drivers

We will deliver our mission by:

- Promoting the community transport sector to communities, funders and service commissioners, through evidence based research
- Developing and delivering a range of different community transport services locally, across Greater Glasgow, to socially or geographically isolated communities
- Working in partnership with community transport operators to deliver community transport and other Demand Responsive Transport (DRT) services
- The development of a Training and Learning Centre that will provide training courses and programmes that cover the specific skills and qualifications required of those working or volunteering with organisations providing transport of one form or another
- Providing an affordable and transparent vehicle repair and maintenance service for CTG's own minibus fleet, minibuses operated by other organisations providing community transport, as well as local car owners.
- The establishment of a Transport Co-ordination Centre that will provide a single point of contact for communities to access transport solutions.
