You will work with the wider team and Day Services Manager to ensure safe practice and delivery of high-quality, person-centred, therapeutic Registered and Commissioned Services/Community Connections, ensuring practice complies with Alzheimer Scotland's policies. You will contribute to evidencing, reviewing and continually improving the quality of the services and will participate in internal audit and Care Inspectorate inspections.

You may operate within a building-based Day Care or as part of a community connection team delivering Community Groups and Outreach services across an allocated area. At times, this will involve working without supervision in the absence of the Day Services Manager.

You will work with the wider team to evidence that services meet Alzheimer Scotland's Quality Guarantees, Scotland's Health and Social Care standards and other quality frameworks including those of the Care Inspectorate where relevant. This includes ensuring that the activities and support offered meet the identified personal outcomes of those attending the services.

#### **Key responsibilities**

- Supporting the Day Service Manager to ensure a collaborative culture of continual improvement and creativity to ensure that a range of planned and evidence based therapeutic activities are offered, reviewed and evaluated.
- Lead on a range of planned and evidence based therapeutic activities that meet agreed outcomes for each person supported, monitoring progress and adopting safe practice.
- Ensure a therapeutic, warm and welcoming environment conducive to delivering high quality services.
- Develop mutually trusting relationships with people with dementia and their families to support person centred planning and ensure collaborative partnerships with everyone involved in the care.
- Support and develop the implementation of life story books in partnership with the person with dementia and their families.
- Deliver a high standard of personalised and person centred support to people living with dementia, working to achieve good outcomes for each person.
- Assist the Day Service Manager to manage referrals for the day service, ensuring the provision of high-quality individual assessments and personalised support planning and service provision, ensuring families and/or carers are included.
- Organise and facilitate reviews for the people we support in line with organisational policy and Care Inspectorate registration requirements.
- Support the implementation of high-quality individual assessments and contribute to personalised support planning and service provision, ensuring families and/or carers are included.
- Contribute to reviews for the people we support, taking a responsibility to raise any concerns and provide regular updates to the Day Services Manager.
- Contribute to evidencing, reviewing and continually improving the quality of the services and participate in internal audit and Care Inspectorate inspections.
- Supporting people living with dementia and carers to achieve good outcomes using a range
  of therapeutic interventions, resources and activities as appropriate.
- Maintaining records of those using the service, including evidence of outcomes, in line with organisational standard and quality.
- Work with the Day Service Manager to ensure safe practice and high-quality delivery of each
  of our services in line with the organisation's Quality Guarantees.
- Be responsible for ensuring your practice, knowledge and learning is maintained at a required level, by attending at all mandatory and other learning events and opportunities, delivered in person or online learning through the Skills Development Hub.
- Achieve and maintain the required knowledge, skills, learning, professional development, and Promoting Excellence Framework standard to meet Alzheimer Scotland's Quality Guarantees.

#### Other responsibilities
