Responsibilities

• Deliver Verture's financial strategy, monitoring financial sustainability

- Supporting Programme Managers with effective resource allocation as needed
- Manage all aspects of financial operations including accounting, budgeting, financial reporting, and compliance
- Provide financial advice to the CEO, Leadership Team and Board of Trustees to support decision-making
- Develop and monitor financial systems, controls and procedures to safeguard the organisation's assets
- Lead on financial risk management, identifying potential risks and developing mitigation strategies
- Oversee financial aspects of funding agreements, contracts and partnerships
- Prepare and present clear financial reports to internal and external stakeholders
- Manage the annual audit process and ensure compliance with all statutory requirements
- Contribute to business planning and organisational development from a financial perspective
- Develop financial models to support the organisation's strategic objectives
- Support the financial and budgeting elements of funding applications and proposals, working collaboratively with the Head of Income Generation (when appointed)

Strategy, business development and financial planning

- Develop and monitor the Verture financial model to support Verture's five-year strategy
- Manage annual financial planning and quarterly review processes to support budget preparation, forecasts and project costings



- Facilitate annual and quarterly planning of the resource management system to effectively manage staff time in delivering budgets and forecasts
- Exercise commercial acumen to contribute to key strategic business decisions at both the Leadership Team and Board level
- Develop and implement systems that improve organisational efficiency and effectiveness
- Provide regular financial reporting and analysis to the Board of Trustees
- Lead on financial risk management, identifying potential risks and developing mitigation strategies
- Support the financial aspects of funding applications and project proposals, ensuring accurate costings and budgets

Treasury and cashflow management

- Effectively manage Verture cashflows
- Ongoing monitoring of existing banking arrangements to ensure that those in place meet the needs and ethical values of the business

Project Management and financial reporting

- Overall accountability for the effective operational management of Verture's financial reporting processes including:
 - Routine financial processes, including all bookkeeping, payroll preparation and ensuring that all routine banking transactions and payments are made within agreed timescales
 - Ensure the completion of accurate and timely statutory returns (quarterly VAT, payroll related tax returns, OSCR, Companies House)
- Production of accurate and timely accounting records including:
 - Regular monthly management accounts and quarterly Board reporting;
 - Supporting financial narrative for the Board of Trustees;
 - Quarterly updates to income/expenditure forecasts; and
 - Annual audited statutory accounts



- Proactive management of Verture's insurance policies and employee pension payments
- Where necessary, provide guidance to colleagues on compliance with internal and external financial regulations
