

## **PRIVACY POLICY**

This Privacy Policy is created by EMANGO education Pvt. Ltd. (EMANGO) in order to demonstrate its commitment to the user's privacy and protection of information. It explains the information that EMANGO collects, processes, uses, shares and protects when a user accesses its website and voluntarily provides for accessing the portal ("Portal").
