









Anyone can donate directly to your organization, or recommend a grant from a donor-advised fund or community fund.


All gifts are immediately liquidated, and tax receipts are promptly distributed.

Most nonprofits receive granted dollars via ABA Wire Transfer, typically within 48 hours of a grant recommendation.

Organizations with existing crypto wallets may alternatively choose to receive grants as USDC Stablecoin.



Our Promise: Always Free for Nonprofits

As a 501(c)(3) organization itself, Endaoment considers its platform public infrastructure, and does not charge nonprofits for any services, outside of costs incurred to transfer donations to your organization. Donors pay an industry low 1.5% on all contributions.



Frequently Asked Questions

Is Endaoment really free
for organizations?

Yes. Endaoment never charges nonprofits to use its services. Donors pay a 1.5% lifetime fee on all gifts, covering our bills and operating expenses.

Does my organization need to custody donated assets?

Your organization is not required to hold cryptocurrency, stock, or any other donated asset. Most nonprofits opt to receive funds in US Dollars via bank wire. (No board meeting required!) If your organization is already equipped with a crypto wallet, you may instead choose to receive Endaoment grants as USDC Stablecoin.

Is Endaoment a legitimate nonprofit?

Yes. Endaoment is a California-based Public Charity and Nonprofit Public Benefit Corporation, federally tax-exempt under IRS Rev. Code Sec 501(c)(3). Our EIN is 84-4661797.

How is giving through Endaoment advantageous for donors?

Endaoment accepts gifts of complex assets in their original form. By eliminating the need to sell the asset and incur capital gains tax, donors can often deduct the full market value of their gift against their taxable income. (Endaoment does not offer tax advice. Donors should consult their CPA or attorney to address any tax-related questions.)

What information is provided about donors?

Just like a traditional community foundation or donor-advised fund provider, Endaoment relays basic identifying information about donors with each grant, provided they opt in to these disclosures.

Are there restrictions on Endaoment Grants?

There is no limit to how much money your organization may receive from Endaoment. Donors may include specific use instructions when recommending grants from DAFs.

Does Endaoment support fundraising for special programs or initiatives?

Yes. Any fiscal sponsorships or special programs may be added as a subproject on your organization's Endaoment profile. Donations made from these pages are granted to your organization as usual, with instructions designating gifts towards the specific initiative. 
