

This document tells you what must appear on the label of the candles or wax melts you make with **Plush Eve Fragrance Oil**. The label elements depend on the **percentage of fragrance oil** you add to the wax: choose the section that matches your recipe and copy the text from the label box.

At 7% fragrance oil

No pictogram required.

No signal word required.

Label text

The text below must appear on your product label, legibly and visibly, in the official language of the country where it is sold.

Harmful to aquatic life with long lasting effects.

Contains Linalool, Iso-E super, benzyl salicylate, alpha-Hexylcinnamaldehyde, linalyl acetate, Citrus limon oil, dl-Citronellol, 4-tert-butylcyclohexyl acetate, geraniol, Vertofix, macrolide, Citrus nobilis peel oil expressed. May produce an allergic reaction.

If medical advice is needed, have product container or label at hand.

Keep out of reach of children.

Avoid release to the environment.

Dispose of contents and container at an approved disposal site, in accordance with local regulations.

The text below must appear on your product label, legibly and visibly, in the official language of the country where it is sold.

WARNING

Contains: 10%.

May cause an allergic skin reaction.

Toxic to aquatic life with long lasting effects.

Contains: Linalool, Iso-E super, benzyl salicylate, alpha-Hexylcinnamaldehyde, linalyl acetate, Citrus limon oil, dl-Citronellol, 4-tert-butylcyclohexyl acetate, geraniol, Vertofix, macrolide, Citrus nobilis peel oil expressed, Hydroxycitronellal, piperonal, Coumarin, Cashmeran, Piconia, Gurjun oil, Canthoxal, cyclamen aldehyden, Isoeugenol.

Other mandatory elements on your label

- the name, address and telephone number of the **candle manufacturer** (that is, yours, not Erfello's)
- the nominal quantity of the product (net weight)

- the product name
- candle safety instructions (for example: never leave a burning candle unattended), where applicable

Please note: the texts above apply to candles and wax melts made with this fragrance oil alone, in a non-hazardous wax. If you blend several fragrance oils in one product or add other additives, the classification of the finished product changes and must be recalculated.
