

PARTICIPATION REGULATION
"LUCKY TRAINING DRAW 2020" (13 May 2020 – 15 August 2020)" RAFFLE CAMPAIGN

Art. 1. ORGANISER OF THE RAFFLE CAMPAIGN

The organiser of the **"LUCKY TRAINING DRAW 2020" RAFFLE Campaign (13 May 2020 – 15 August 2020)** is the company SMART PAYMENT S.R.L., Romanian legal person, with registered office at Emil Garleanu Street 8, 3rd District, CIF RO37056221, Registration Number with the Trade Company J40/1678/16.02.2017, dully represented by the Mrs.loana Ochenatu, in capacity of Administrator.

The campaign is carried out for, in the name and in the benefit of One Network Services EOOD(herein called the Company or OneLife company), foreign legal person, with registered office in Bulgaria, Sofia 6A, P.R. Slaveykov sqr, CIF BG201531600,dully represented by Mr. Angel Boyadzjiiski

The Raffle Campaign shall be carried according to the provisions of this Regulation which is binding on all the participants ("Regulation").

According to the free will of the Organiser the Raffle Campaign can be publicised for the purpose of public information, including through advertising materials and/or for information purposes.

Art. 2. PERIOD, PLACE OF PERFORMANCE AND CONDITIONS OF THE CONTEST

"LUCKY TRAINING DRAW 2020" RAFFLE Campaign (13 May 2020 – 15 August 2020) takes place during the period **13505.2020 hour 12:00 – 15 August 2020 hour 23:59** GMT+3, which will be considered the deadline for the participants to packages and register in the Raffle) and takes place on international level, it shall be organised and shall take place on the website ramdom.org, according to the Regulation and the Raffle Campaign mechanism.

The Campaign consists in purchasing Digital Training packages, which are of 3 categories: Digital Training III with the value of 99 Euro, payable in onecoin and Euros, 1.16 one+49 euros; Digital Training II with the value of 199 Euro, payable in onecoin and Euros, 2.34 one+99 euros; Digital Training I with the value of 399Euro, payable in onecoin and Euros, 4.70 one+199 euros, for which purchase, raffle tickets afferent to each package category are remitted, giving the possibility to participate in the Raffle where 7 categories of prizes are being awarded.

Based on the date of tickets purchase, buyers are granted different chances for winning prizes!

For the purchase of a Digital Training III package, during the period 14th of May 2020- 30th of June 2020, you will automatically receive, 2 chances to win the Raffle. For the purchase of a Digital Training III package, during the period 1st of July 2020 –15th of August 2020, the buyers automatically receive 1 winning chance to win the raffle.

For the purchase of a Digital Training II package, during the period 14th of May 2020- 30th of June 2020, you will automatically receive, 6 chances to win the raffle.

For the purchase of a Digital Training II package, during the period 1st of July 2020 –15th of August 2020, the buyers automatically receive 3 winning chances to win the raffle.

For the purchase of a Digital Training I package, during the period 14th of May 2020- 30th of June 2020, you will automatically receive, 20 winning chances to win the raffle.

For the purchase of a Digital Training I package, during the period 1st of July 2020 –15th of August 2020, the buyers automatically receive 10 winning chances to win the raffle.

A person can purchase several packages with the same value or different values.

If the beneficiary of the package does not participate for reasons attributable to the Company of the company SMART PAYMENT SRL or its collaborators, on the date and hours indicated for carrying out the purchased Training, the amount/amounts paid for the purchase of the package shall not be refunded.

The participants shall receive the access codes to the conference room online, by email, based on the package purchased.

When purchasing packages, regardless the value and registration for Raffle the participants shall register with the following personal data: Surname, First Name, E-mail, Phone, full address, expressly giving their consent for the personal data processing and Newsletter subscription.

The Prizes Draws shall take place on 22 August 2020 between 12:00 GMT+3 – 18.00 GMT+3, within the Global Event THE LEGEND OF THE ONE. The draws shall be broadcasted live of the winners shall be published on the website www.fantasticglobalteam.ro, by Newsletter and/or in all the official channels of the OneLife company.

Art. 3. PARTICIPATION RIGHT

Any individual with a minimum age of 18 years, regardless the sex, nationality or religion, the place of his/her domicile, who agrees with the terms and conditions of this regulation, who purchases one or several Digital Training I, II and III packages, fill in the purchase forms of one or several Digital Training packages, regardless the category of the package and participation in the Raffle Campaign with all the personal data on the website www.fantasticglobalteam.ro can participate in this campaign.

Art. 4. OFFICIAL CONTEST REGULATION

The Official Regulation of the Campaign is available to any applicant, free of charges, during the whole period of the contest and by accessing the page www.fantasticglobalteam.ro/regulament. The Participants undertake to abide and comply with all the terms, conditions and provisions of this Regulation. The Organiser reserves the right to modify or change this Official Regulation, and such changes shall be made public on the page www.fantasticglobalteam.ro

Art. 5. PRIZES

Art. 6. TERMS AND CONDITIONS OF PRIZE AWARDING

Art. 7. Validation conditions

Subsequently the designation of the Raffle winners, the Organiser shall proceed to the validation of winnings, on which occasion, it shall verify the fulfilment of the conditions regarding the registration of the Participants in the contest, as well as the manner of its performance. The Organiser shall contact all the winners of the campaign prizes through the available methods: phone and/or email, according to the data provided by the participants on the occasion of contest registration.

Winnings will be validated if the winning participants cumulatively meet the conditions provided in this regulation.

Art. 8. Invalidation conditions

The winnings shall be invalidated if the participant designated winner for any of the prizes at stake violates the participation requirements provided by this regulation, and also if he/she provided false or manifestly erroneous information.

Art. 9. TAXES AND FEES

Art. 10. INTERRUPTION OF THE CAMPAIGN

This raffle may cease before the date mentioned in the Regulation only in case of occurrence of an event of force majeure or fortuitous event, according to the legislation in force, including in case of the impossibility of the Organiser, for reasons beyond its control to continue this raffle.

Art. 11. LIMITATION OF LIABILITY

The Organiser is not responsible for:

- the impossibility of a participant in the Contest to enter into possession of the Prize won or to use it according to the above mentioned conditions, for reasons that exclude the Organiser fault;
- the email addresses that are not found in the data base or do not allow the confirmation of the participant identity, which contain false or manifestly erroneous information and which do not meet the validity conditions provided in this regulation;
- any other costs of the winner in connection to entry in possession of the prize, other than the ones in his/her charge according to this regulation and legal provisions;
- impossibility of a winner to take possession of the prize for reasons that exclude the fault of the Organiser.

The Organiser can not be held responsible for losses or destructions of prizes in case of force majeure or fortuitous event. Unjustified prizes claims, forgeries or complaints proved to be ungrounded and abusive, constitute grounds for the Organiser to claim damages-interest.

Any attempted fraud results in elimination of the respective participant from the Campaign and in the notification of the competent investigation bodies, the Organiser shall inform than the respective Participant about this decision.

The Organiser shall not be responsible for any of the prejudices that may be suffered by the winner with regard to the prizes won, regardless the nature of these prejudices, except for the situations expressly provided by the law and which could establish such a liability.

The Organiser is not liable in any way for the direct or indirect damages resulting from the registration in the Campaign, except for the obligations deriving from the legislation on the matter of consumers protection.

Art. 12. PROCESSING OF PERSONAL DATA

By participation into this campaign, it is presumed to know the content of the regulation and the consent of the participant for the processing of his/her personal data by the organiser, in accordance with the provisions of the Regulation (UE) 2016/679 (GDPR).

All the participants in the campaign are guaranteed the rights under GDPR on the protection of individuals with regard to the personal data processing and free movement of such data, especially the rights of the data subject concerning information, access to data, the right to intervene, opposition, to address to the competent court of law and of complaint to the supervisory authority. Within the meaning of GDPR, the main rights mentioned above belonging to the data subjects have the following content:

1. The right to access to data: Any data subject has the right to obtain from the Operator, upon request and free of charge for one request per year, the confirmation that the data concerning him/her are or are not processed by the Operator. Thus, at the written, signed and dated request of the respective person, sent to the address of the Organiser from Bucharest, once a year, free of charge, the company SMART PAYMENT SRL shall confirm if uses data concerning him/her or shall cease any processing thereof.

2. The right to intervene on data: Any data subject has the right to obtain from the operator, upon request and free of charge:

(i) where appropriate, the rectification, update, blocking or deletion of data which processing does comply with the law, especially incomplete or inaccurate data;

(ii) where appropriate, transformation of data whose processing does not comply with the law into anonymous data;

(iii) notifying the third persons to whom the data have been disclosed, of any operation done according to the item (i) or (ii), if this notification does not prove impossible or does not imply a disproportionate effort against the legitimate interest that could be harmed. Thus, the company SMART PAYMENT SRL Shall rectify, update, block, delete or transform into anonymous data all the data whose utilisation does not comply with the provisions of GDPR.

3. Right of opposition: The data subject has the right to oppose in any moment, free of charge and without any justification, to the data concerning him/her to be processed for direct marketing purpose, in the name of the operator or any third party or to be disclosed to any third parties in such purpose. The following personal details shall be collected during the period of the promotional Campaign:

For all the participants: surname and name from the identity card, permanent address, cell phone number; email address.

They are guaranteed all the rights provided by the law.

The purposes of establishing the data base are: fulfilling the object of the contract, preparation of statistic reports on consumers, direct marketing, information of the persons included in the data base of SMART PAYMENT SRL through various means of communication (post, e-mail, SMS or other means of communication allowed by law) regarding other actions carried out in the future by the Organiser. The Organiser undertake that the personal data will not be disseminated to third parties, excepts its proxies.

By registering for this Contest, the participants agree with the provisions of this Official Regulation.

Art. 13. FORCE MAJEURE

For the purpose of this Regulation, force majeure means any event that can not be foreseen, controlled or remedied by the Organiser, including the impossibility of the Organiser due to reasons beyond its control and whose occurrence makes the latter unable to fulfil the obligations assumed by this Regulation.

The Organiser reserves the right to conclude or to extend this raffle, in case of force majeure, provided that such situation and decision is communicated in advance.

Art. 14. LITIGATION

Any disputes between the Organiser and the participants in this campaign shall be settled amicably, and if this is not possible, the disputes shall be solved by the competent Romanian courts of law in the city of Bucharest.

Any complaints related to the campaign can be sent to the Organiser email address: oneliferomania@gmail.com within maximum 3 working days from the end of the Contest. After the expiration of this term, the Organiser shall not take into consideration any complaint. The complaints will obligatorily include the reasons and the email address or the post address where the response shall be notified, under penalty of rejection. The complaints will be solved within 10 working days from the date of their receipt and a response will be communicated to the participants to the email address or post address indicated by him/her.

Art. 15. OTHER CLAUSES

By participation in this Contest, the participants agree to comply with the rules and other conditions established by this official regulation. If the Organiser finds that a winner does not fulfilled and/or failed to comply with the conditions established by the official regulation of the Contest, reserves the right to suspend in any moment the rights and benefits of the winner without other compensations or payments. The Organiser reserves the right to offer more prizes than the ones provided in this regulation. The Organiser is entitled to take all the necessary measures in case of attempted system fraud, abuse or any other attempts that could affect the image or costs of this promotional campaign.
