

Google Cloud Event Terms & Conditions for CE Ambassador Summit 2023

Event Access

- Access to Google Cloud CE Ambassador Summit 2023 is at no cost for invited Googlers.
- Access includes three days of in-person conference sessions (September 11 - 14, 2023), access to any entertainment portions, and access to morning keynote addresses.
- Access is for the three- day program. Access is granted only to the original registrant and is non-transferable.
- Access to CE Ambassador Summit may not be sold, bartered, auctioned, or transferred in any way, and doing so may result in Google rendering the ticket null and void without any responsibility to Google. The individual that registers for the program, must be the person that attends the program.

Confidentiality

General Registration Terms
