



### **Terms and Conditions:**

1. By submitting your fee to attend the Clinton Foundation's Clinton Global Initiative ("CGI") September 2024 meeting (the "Event"), you are agreeing to these terms and conditions.
2. The Event is a program of the Bill, Hillary & Chelsea Clinton Foundation (the "Foundation"), a 501(c)(3) nonprofit organization. Value received at the meeting is \$800 per attendee; the remainder of your fee is tax deductible.
3. Event attendees are expected to adhere to the values of the CGI community. The Foundation reserves the right to exclude or expel from participation in the Event any individual or delegation who does not adhere to the Values of the CGI Community in the Foundation's sole determination.
4. While the Foundation aims to facilitate introductions and connections necessary to drive action on key issues at the Event, CGI and the Event are non-commercial in nature. Attendees are expected to respect the nature of the Event and agree:
  - (a) not to engage in any direct sales of products or services at the Event, and
  - (b) not to primarily engage in the direct promotion of products or services, without express written consent from the Foundation.
5. Attendees must adhere to all health and safety protocols required by the Foundation. To align with the latest CDC guidance and any applicable laws and regulations, the Foundation will disclose details on health and safety protocols closer to the start date of the Event.
6. The Foundation will be documenting the Event through, among other media, photography, and videography. By attending the Event, attendees are granting the Foundation the right to record, stream, and photograph attendees and use attendees' likeness at the Events (collectively, the "Recording"), and granting the Foundation unrestricted rights to display, distribute, edit, reproduce, create derivative works from, and/or otherwise use the Recording, in whole or in part, in any and all media (including social media), without any further approval from attendees, for any Foundation purposes including, without limitation, any promotional, fundraising, educational, and reporting purposes, both online and in print. Attendees further agree that their names and relevant biographical data (such as organization, job title, and country of residence) may be disclosed in descriptive text or commentary in connection with the Foundation's use of the

Recording. Attendees understand and agree that they will receive no royalties, fee, or other compensation for use of the Recording and acknowledge that all prints, videos, and any digital reproductions of the Recording shall be the property of the Foundation.

7. Attendees may take recordings and photographs of the Event for personal, non-commercial use (“Attendee Recordings”). but shall not use Attendee Recordings to imply any kind of affiliation or endorsement beyond that of an Event attendee, or as applicable, CGI commitment-maker or partner. Attendee Recordings and photographs may not be used for commercial purposes without the prior written consent of the Foundation. 8. Event attendees, speakers, and sponsors are solely responsible for any views or opinions they express at the Event; the Foundation shall not be held responsible or liable for any such views or opinions.

9. The Foundation is committed to the lawful and transparent collection and use of any personal identifiable information you provide to the Foundation in connection with the Event. 10. Cancellation and Rescheduling Policy:

- a. If the Foundation cancels the Event, the Foundation will, upon request by attendee, issue a full refund of the meeting fee.
- b. If the Foundation reschedules the Event, the Foundation will apply attendees’ fees to the rescheduled event. If an attendee, after making reasonable efforts to find substitute delegates, cannot attend the rescheduled event, the Foundation will, upon request by attendee, issue a full refund of the meeting fee.
- c. If an individual or delegation is excluded or expelled from participation in any event due to failure to adhere to the values of the CGI community or these terms and conditions as determined solely by the Foundation, the meeting fee paid shall be non-refundable.
- d. If an individual or delegation is excluded or expelled from the Event for any other reason, the Foundation will issue a full refund of the meeting fee.
- e. If an individual is unable to attend the Event due to a positive COVID-19 test or an event beyond the individual’s reasonable control (e.g., death, disability or incapacity of an immediate family member, natural disasters such as hurricanes, earthquakes or floods, or human-made disasters such as war or terrorist attacks), the Foundation will, upon request by attendee, issue a full refund of the meeting fee. If

an individual is unable to attend the Event for any other reason, the meeting fee shall be non-refundable.

11. Attendees agree, for themselves, their heirs, executors, and agents, to release, hold harmless, and indemnify the Foundation, its affiliates, directors, officers, employees, and agents from and against any and all claims, damages, liabilities, costs, injuries, losses, and expenses (including reasonable attorneys' fees and costs) (collectively, "Liabilities") arising out of or in connection with the Event or these terms and conditions except such Liabilities as may result from the gross negligence or willful misconduct of the Foundation.

12. The Foundation reserves the right to modify these terms and conditions, at any time and without prior notice.
