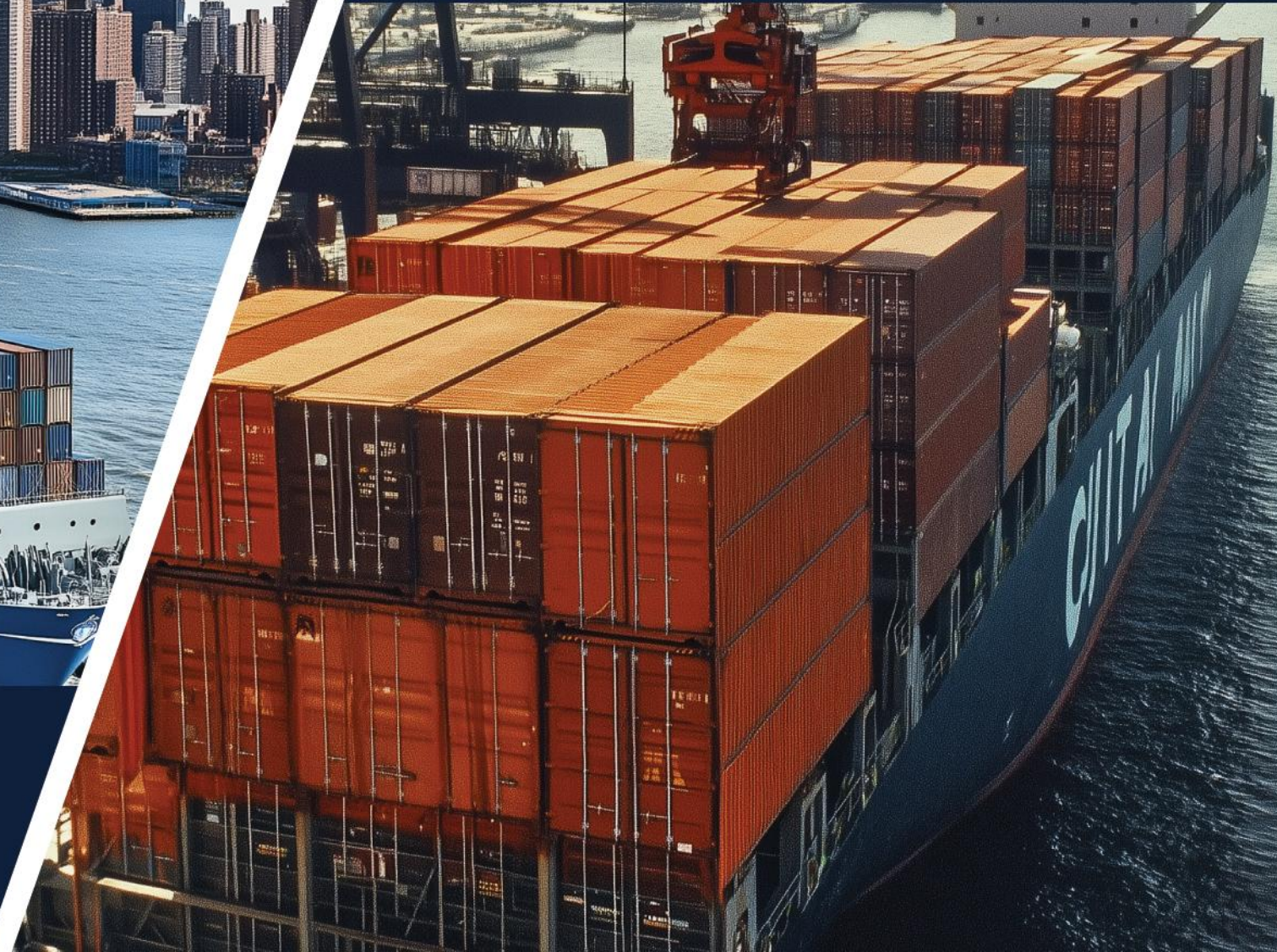


China's Imports from U.S.

A Focus on the 300 Key Imported Products



Scope of research

We identified **top-300 largest value import items** traded between China and USA in 2024, specifically focusing on **China's imports from the USA**. This identification was based on analysis of the full database on the trade between the two countries.

We divided these 300 products into segments:

- I. **Largest-value traded goods** (annual value of shipments of 800 M\$ – 13 B\$);
- II. **Champion-value traded goods** (annual value of shipments of 207 M\$ – 800 M\$);
- III. **Rising Champion value traded goods** (annual value of shipments of 94 M\$ – 207 M\$);
- IV. **Latent Champion value traded goods** (annual value of shipments of 55 – 94 M\$).

We analyzed long-term and short-term evolution of trade of each group (in US\$ terms only, volume trade not analyzed): CAGR over 2017-2024, Growth Rates in 2024.

Methodology: At the end of each section, we ranked the traded items within each group based on three key indicators: **Imports Value in 2024 (Absolute Import Size in \$-terms)**, **CAGR over seven years (2017-2023) a indicator of a long-term growth trend**, and **yoy Growth Rate in 2024 as indicator of short-term performance**. All indicators were assigned an equal weight **on a 10-point scale**, and the total score was calculated as the sum of these three values. The highest-scoring categories are identified as the most promising goods for supply to Chinese market from USA, while those with the lowest scores are considered the most risky.

Data sources: UN Comtrade databases processed by GTAIC Intelligence Platform.

Data on trade in volume metrics (tons, kilos, and other) and prices are not analyzed in this research. However, they can be analyzed under a separate request.

This research was prepared as of 10th of March 2025.

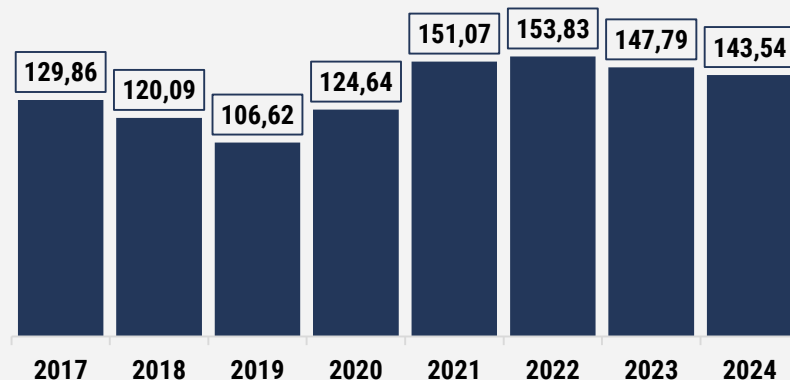

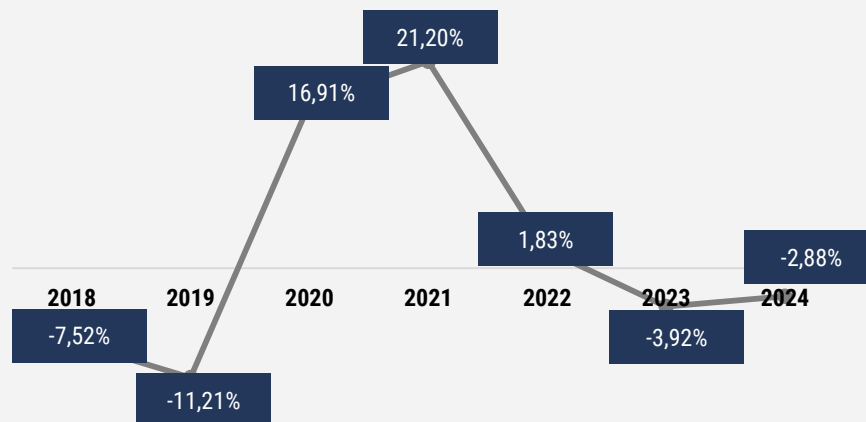

- In the long-term (2017–2024), China's imports from U.S. have shown an upward trend, increasing from \$129.86 billion in 2017 to \$143.54 billion in 2023.
- From 2017 to 2024, the compounded annual growth rate (CAGR) of China's imports from U.S. was +1.26%, with the most notable growth occurring during 2021–2022, when China's imports from U.S. surpassed \$151 billion.
- In 2023, China's imports from U.S. totaled \$147.79 billion, down from \$153.83 billion in 2022, marking a **-3.92%** decrease. In 2024, imports continued to decline, reaching \$143.54 billion (-2.88%).
- The analysis covers the top 300 imported products by value in 2024, categorized into four groups: the 1st Group – Top 25 (with the yearly imports value of 800 M\$ – 13 B\$ in 2024), the 2nd group – Top 75 out of Top 100 (early trade value of 207 M\$ – 800 M\$), the 3rd group – Top 100-200 (94 – 207 M\$), – Top 200-300 (55 – 94 M\$).
- For each group, we identify the products that have shown sustained and significant import growth from the U.S., focusing on both long-term (2017-2024) and short-term (2023-2024) growth trends.

The **top-25 highest-value** product categories (6-digit HS classification) account for approximately **54.34%** of China's imports from US reaching **78 B\$** in 2024.

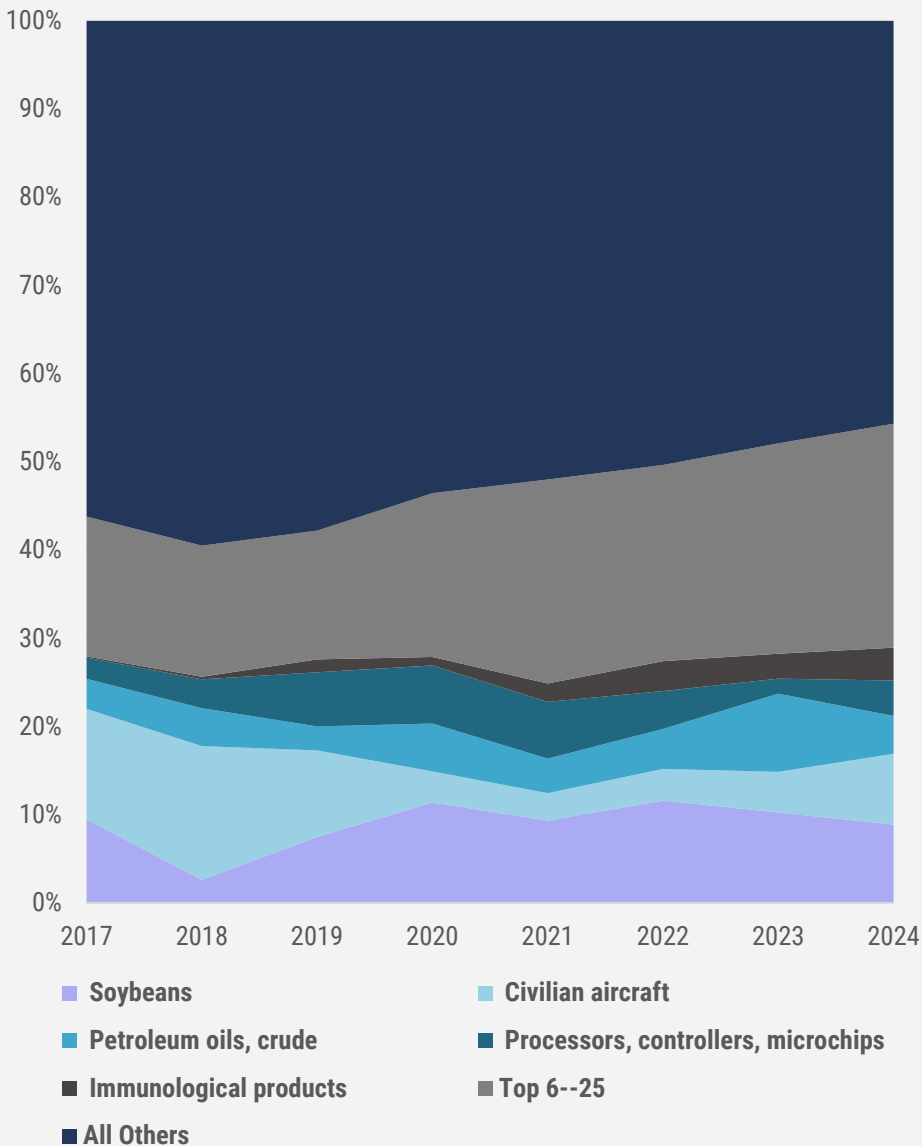
The examples of categories within this group are presented below, along with their respective import values and shares of total imports:

- **Energy Products: These products accounted for \$13.45 billion, representing over 9.37% of total imports:**
 - Petroleum oils and oils from bituminous minerals, crude
 - Propane, liquefied
 - Natural gas, liquefied
 - Bituminous coal
- **Soybeans: These products accounted for \$12.76 billion, accounting for 8.89% of total China's imports from US.**
- **Microchips, Their Components and Manufacturing Equipment: Amounting to nearly \$8.16 billion in 2024, accounting for 11.71% of total China's imports from US:**
 - Processors and controllers, electronic integrated circuits
 - Electronic integrated circuits, others
 - Machines and apparatus for the manufacture of semiconductor devices
- **Civilian Aircraft: Exceeding \$11.52 billion, accounting for over 8.03% of total imports**
- **Pharmaceutical Products: Totaling nearly \$7.13 billion in 2024, representing 5% of total China's imports from US:**
 - Immunological products
 - Medicaments, in measured doses, etc.
- **Other Product Categories worth \$21.42 billion accounting for 14.92% of total China's imports from US and including: Motor Vehicles, Copper Waste, Medical and Optical Instruments, Meat and Meat By-products, Cotton Textiles, Wood Pulp, Grain Crops.**

Top-5 Product Categories by Value in the Structure of China's Imports from US (B\$)



- During 2018–2024 the share of the top-25 categories steadily increased from 41% in 2018 to 54% in 2024, highlighting a **growing concentration** in key import positions.
- Over the long-term (2019–2024), **Soybeans** remains the dominant category, with import values increasing from \$7.99 billion in 2019 to \$12.76 billion in 2024.
- In 2024, **Civilian Aircraft** emerged as the second-largest import category at \$11.52 billion, nearly doubling the import value of **Petroleum Oils** (\$6.16 billion), which ranked third.
- The further analysis covers the import value dynamics of the 5 fastest growing and 5 most decreasing import positions, providing insights into shifting trade patterns and the evolving composition of China's import structure.

Most Growing and Declining Import Positions within Largest-value Segment

Out of the top-25 product positions, **Chemical Wood Pulp** is the category with the most significant decline in imports values across all the periods considered (in 2024 and 2017 – 2024). Notably, **Immunological products in measured doses for retail sale** is one of the most promising import positions, with an imports value of over **5.35 B\$** in 2024 and experiencing rapid import growth in reviewed periods.

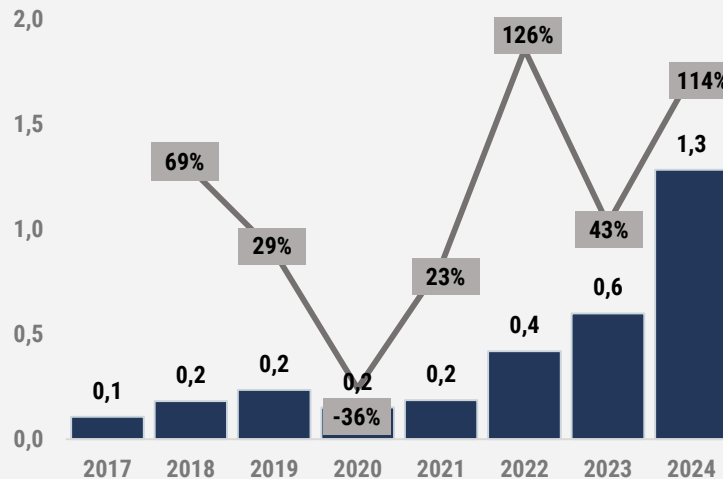

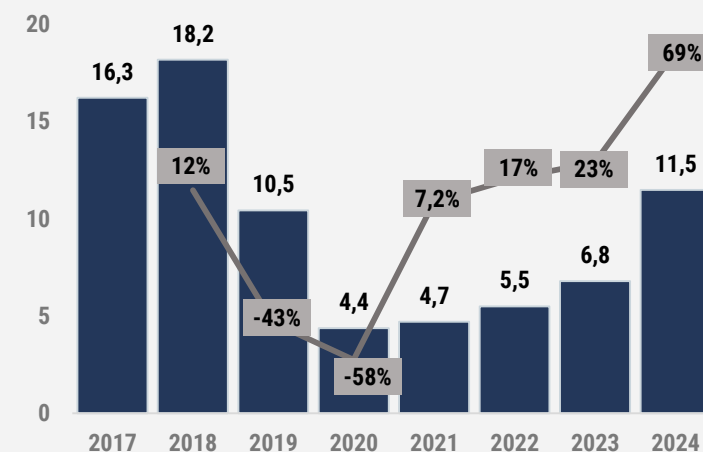

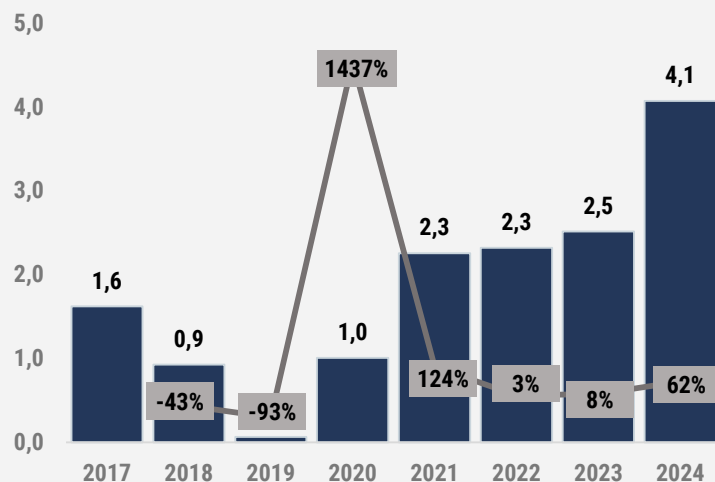
Imports Value of Optical Instruments for Semiconductor Wafers, B \$



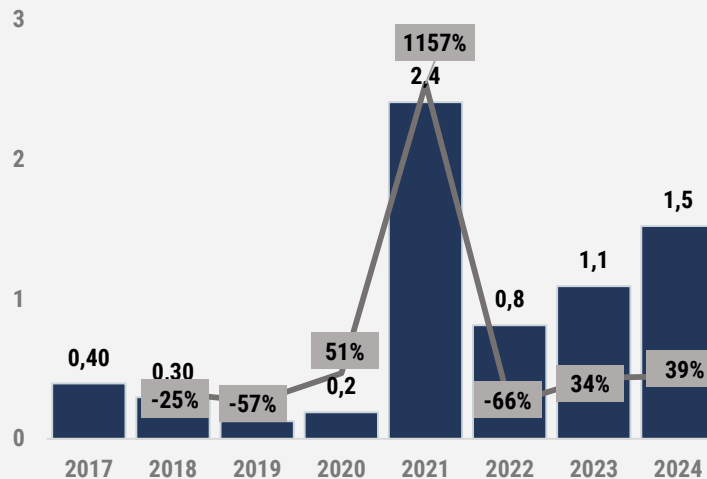
Imports Value of Civilian aircraft, B \$

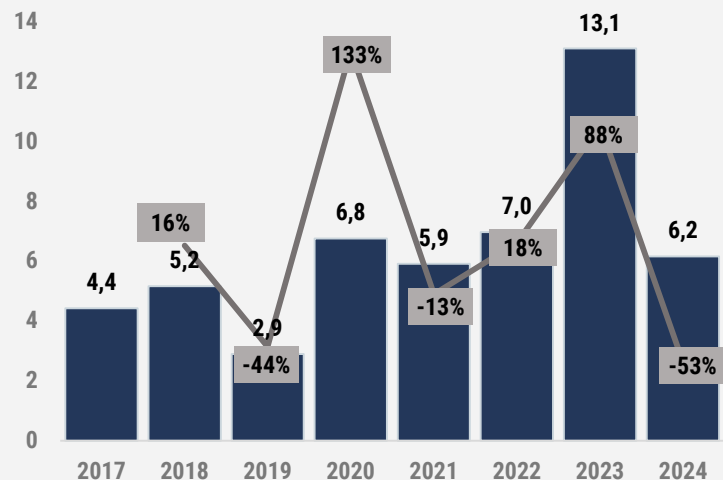

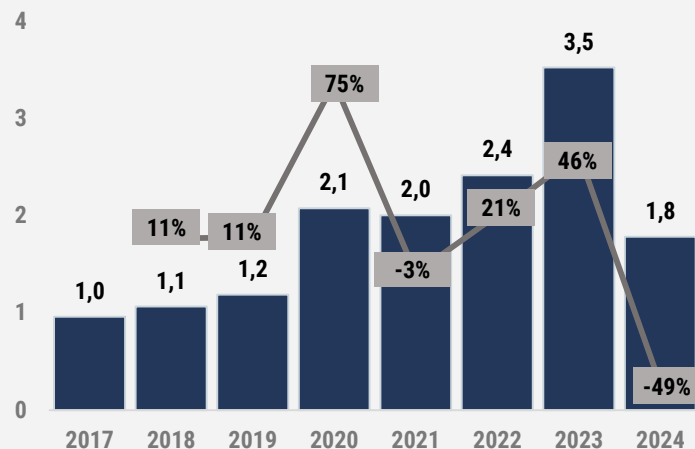

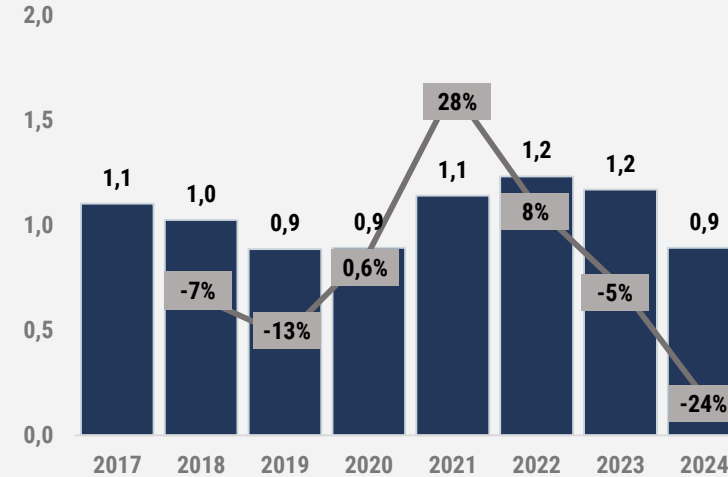

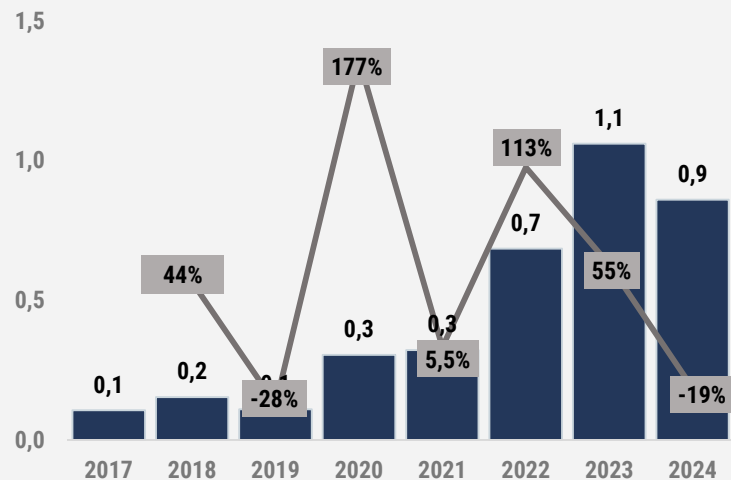

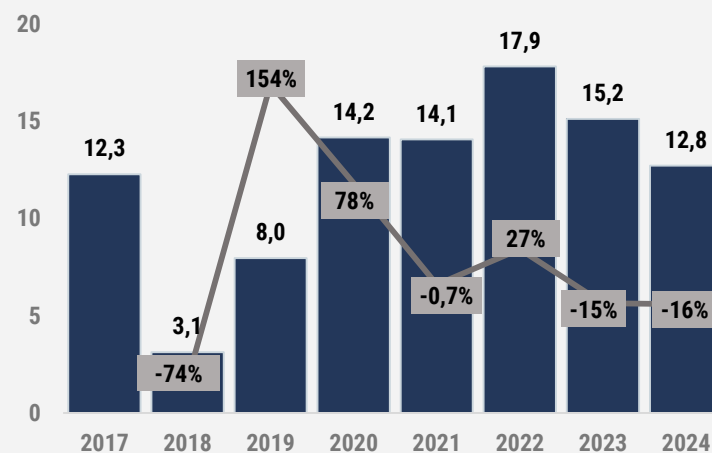

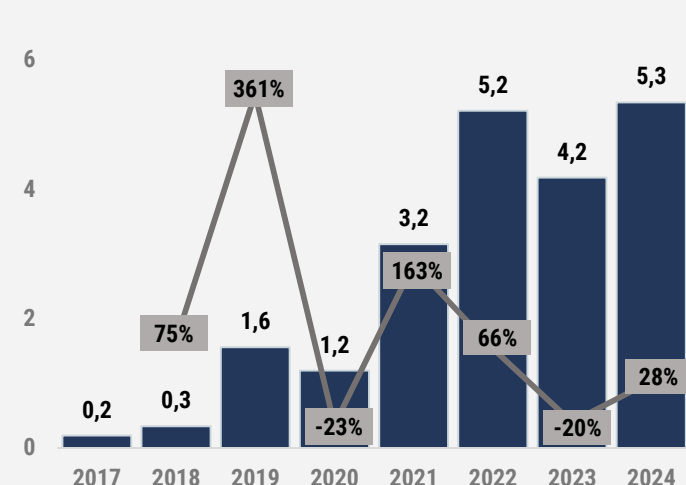

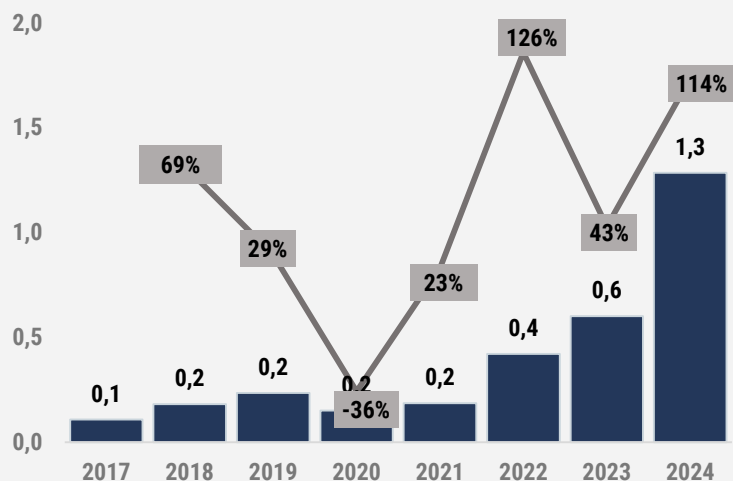

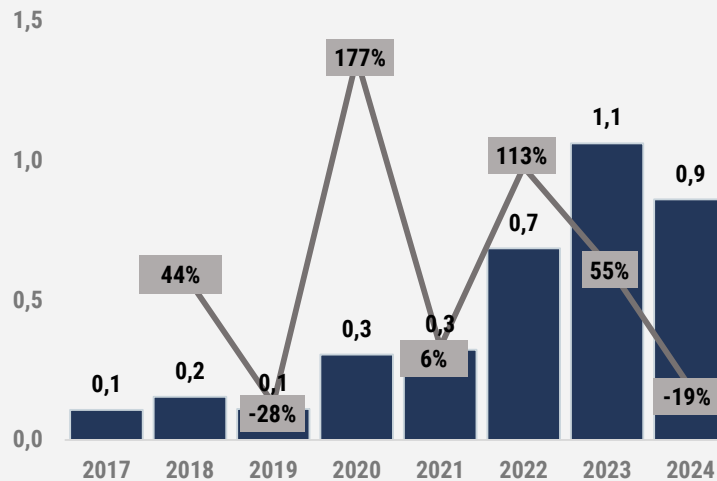

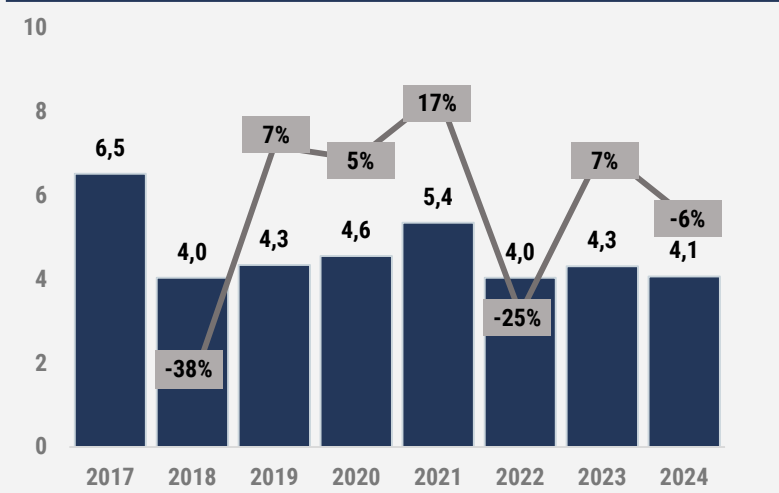

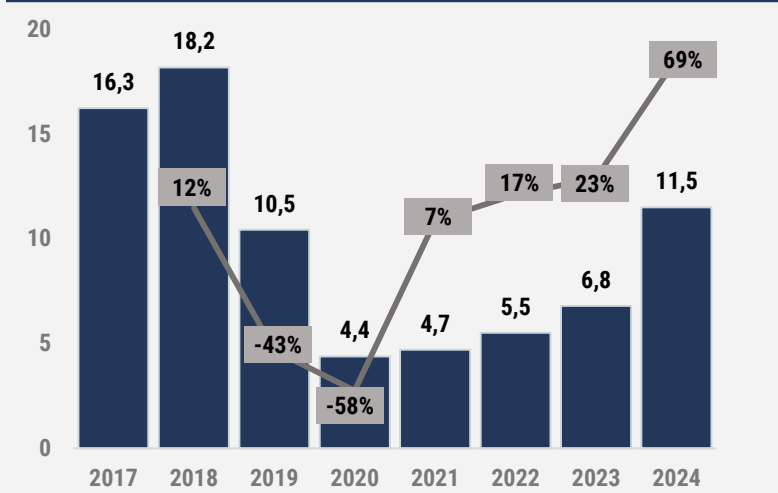

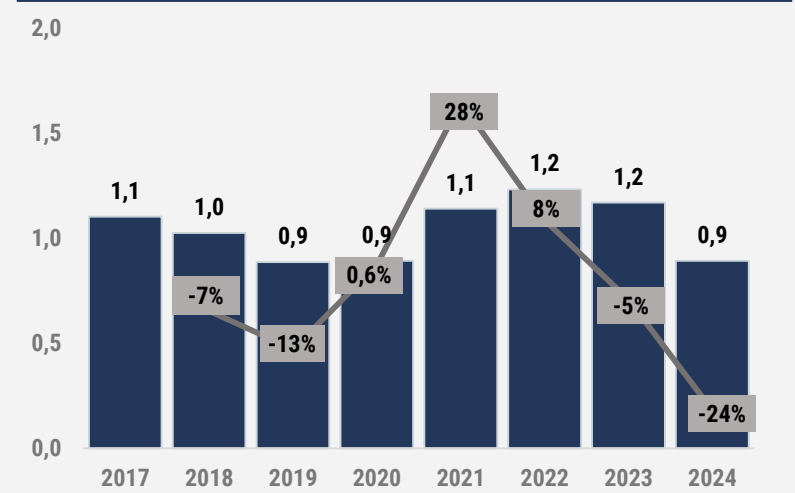

Imports Value of Immunological Products, B \$

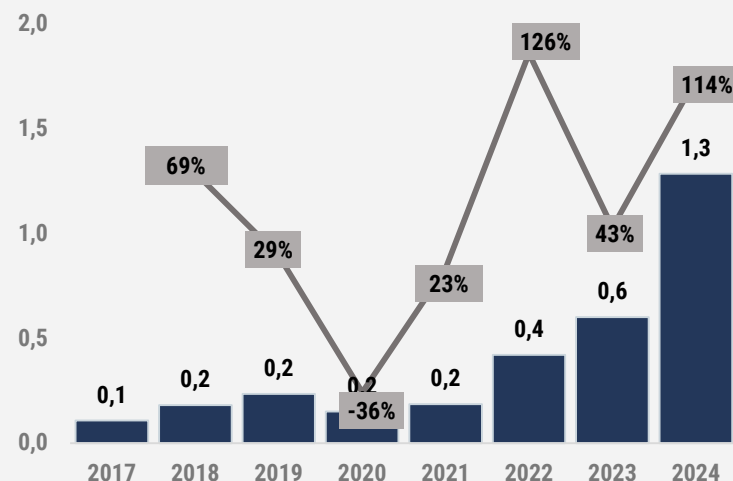


Imports Value of Civilian Aircraft, B \$

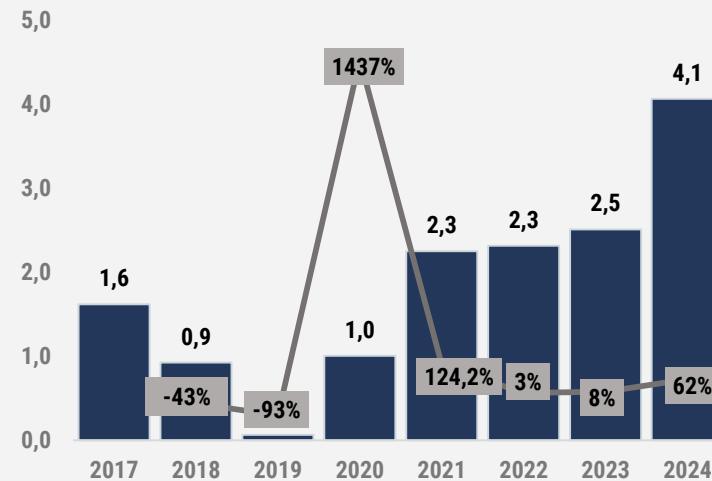

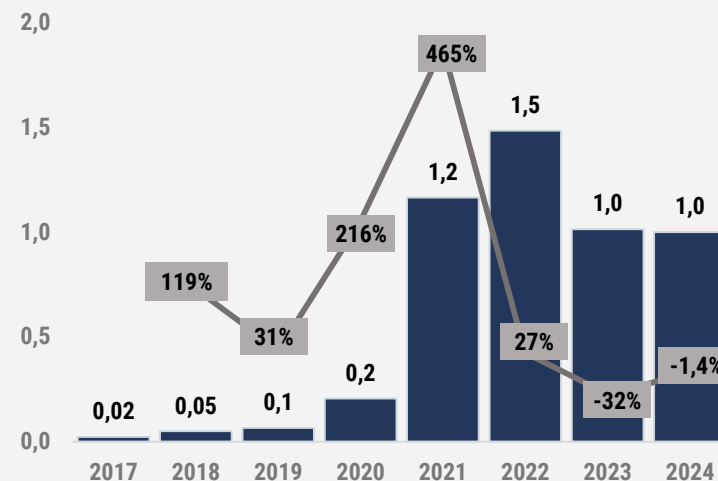

Imports Value of Polyethylene (gravity of > 0.94), B \$

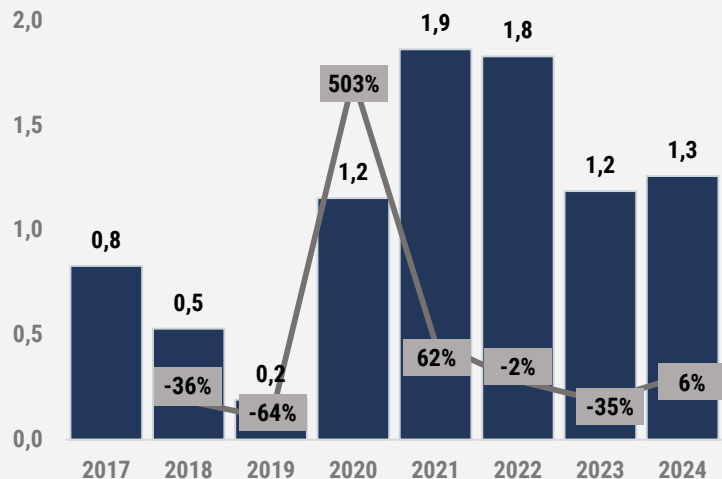


Imports Value of Medicaments (in measured doses), B \$

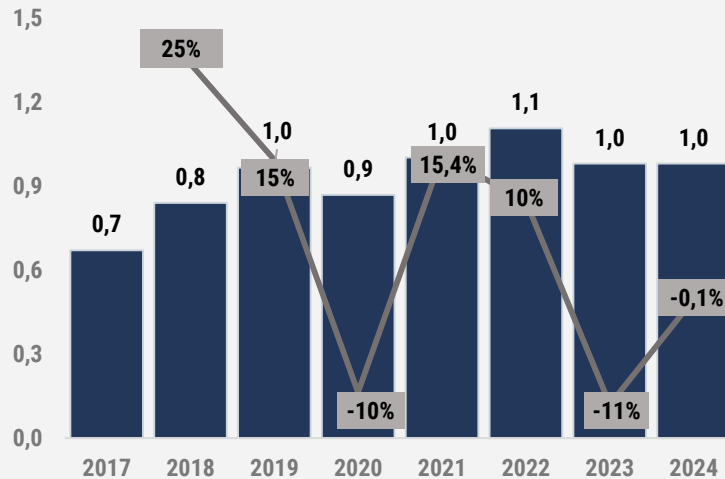

The **3rd group** with imports value of more than 55 and less than 94 M\$ (under 6-digit HS classification) account for over **5%** of all China's imports from the U.S., reaching nearly **\$7.20 billion** in 2024.

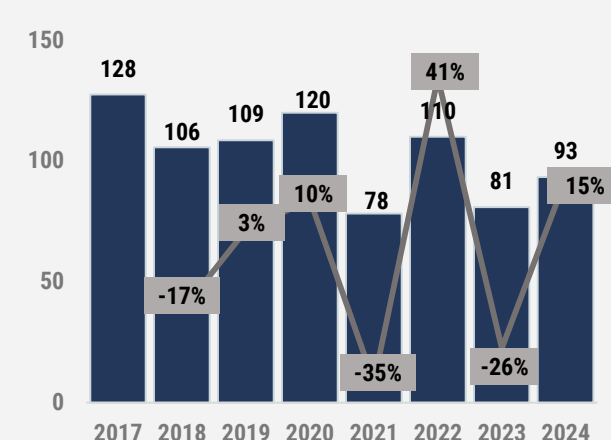
Imports Value of Wine of Fresh Grapes, M\$

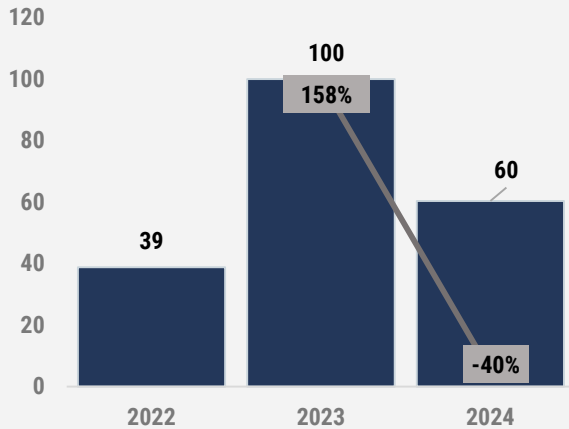

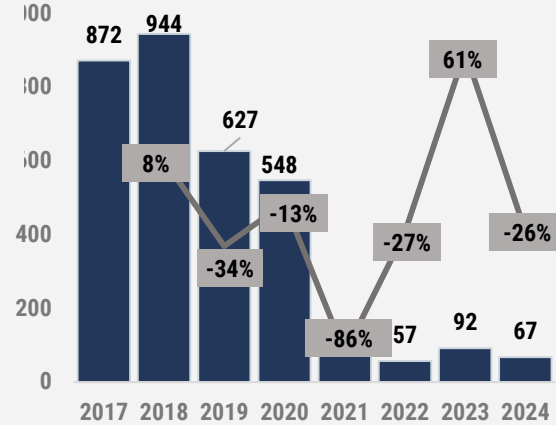

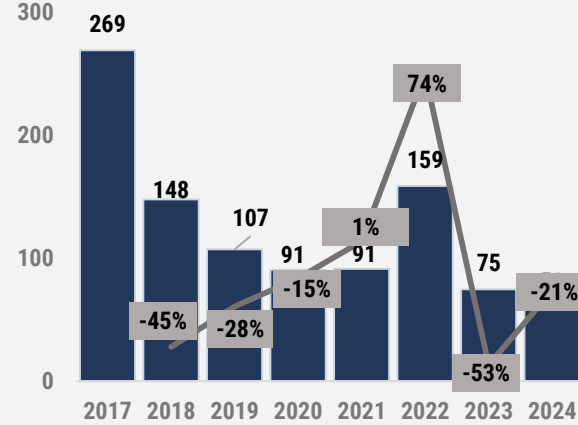
Imports Value of Television Cameras (Others), M\$



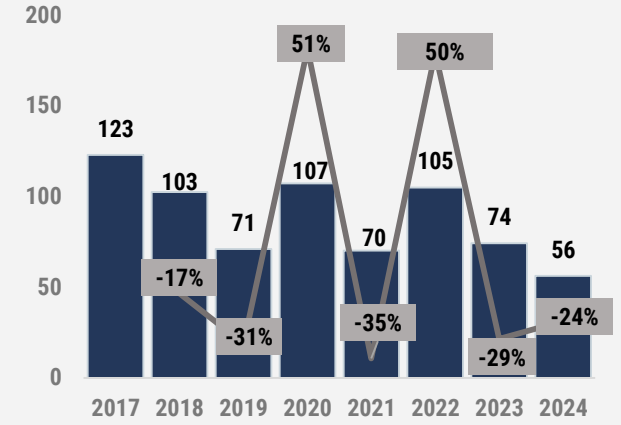
Imports Value of Scrap of Unbleached Kraft Paper , M\$



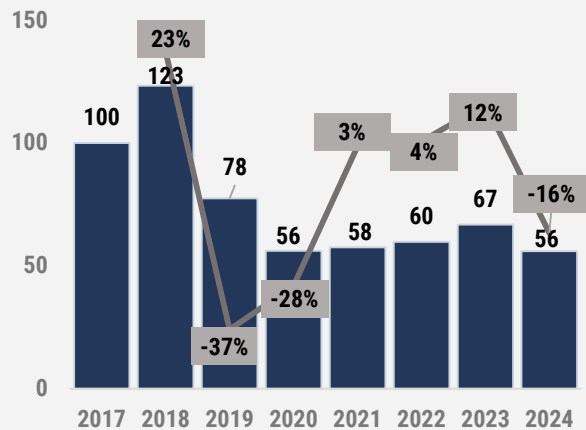
Imports Value of Petroleum Oils (other than Crude), M\$



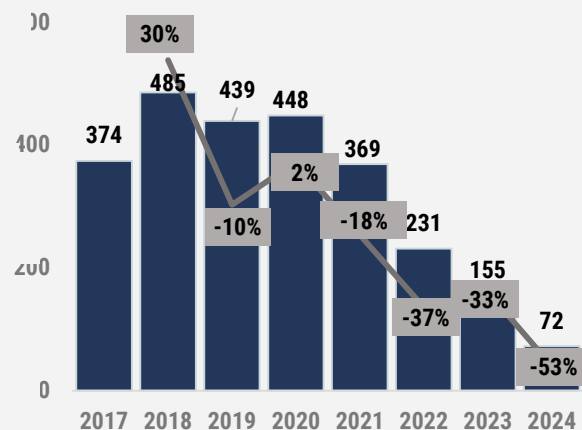
Imports Value of Printed Circuits, M\$



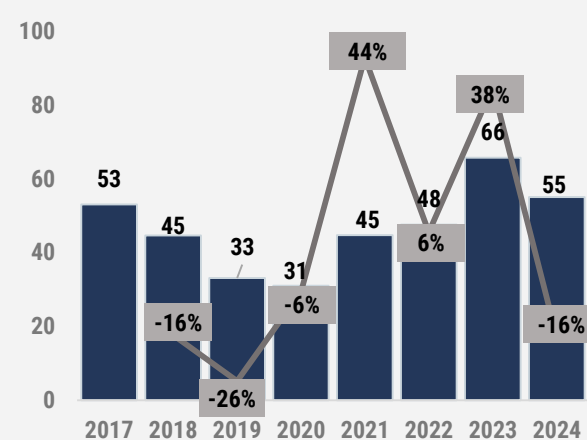
Imports Value of Parts for Derricks, Cranes, etc. M\$



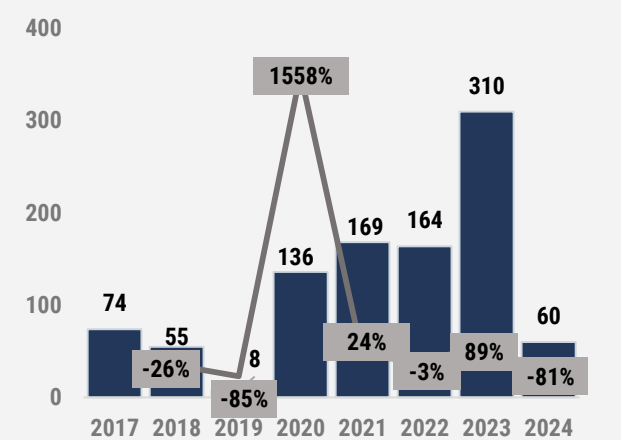
Imports Value of Ultrasonic Scanning Apparatus, M\$
