



Scope of research

We identified top-100 largest value import items traded between Canada and Romania in 2024, specifically focusing on Canada's imports from Romania.

The analysis was based on the full database on the trade between the two countries (Canada's imports data, mirror data).

We divided these 100 products into segments:

- Largest-value traded goods (annual value of shipments of 3.7 M\$ 38 M\$);
- II. Champion-value traded goods (annual value of shipments of 1.9 M\$ -3.7 M\$);
- III. Rising Champion value traded goods (annual value of shipments of 1 139 K\$ 1.9 M\$);
- IV. Latent Champion value traded goods (annual value of shipments of 910 K\$ 1 139 K\$).

We analyzed long-term and short-term evolution of trade of each group (in US\$ terms only, volume trade not analyzed): CAGR over 2017-2023, Growth Rates in 2024.

Methodology: At the end of each section, we ranked the traded items within each group based on three key indicators: Imports Value in 2024 (Absolute Import Size in \$-terms), CAGR over seven years (2017-2023) as indicator of a long-term growth trend, and y-o-y Growth Rate in 10M 2024 as indicator of short-term performance. All indicators were assigned an equal weight on a 10-point scale, and the total score was calculated as the sum of these three values. The highest-scoring categories are identified as the most promising goods for supply to the Canada's market from Romania, while those with the lowest scores are considered the most risky.

Notes: use of n/a designation: In 2022, the Harmonized System underwent significant revisions, including the introduction of new commodity items. The "n/a" designation is used for imports values of goods that were previously classified under different HS codes before 2022.

Data sources: UN Comtrade databases processed by GTAIC Intelligence Platform.

Data on trade in volume metrics (tons, kilos, and other) and prices are not analyzed in this research. However, they can be analyzed under a separate request.

Upon results of the analyses of the top-100 largest value import items traded between Canada and Romania in 2024, we identified the most promising positions supplied from Romania to Canada across various product groups:

- In the Largest-Value Segment (annual value of shipments of 3.7 M\$ 38 M\$); the most promising positions are: 1) Parts of turbojets; 2) New pneumatic tires, of rubber, of a kind used on motor cars; 3) Electric coffee or tea makers; 4) Electric coffee or tea makers; 5) Electrical static converters; power supplies for adp machines or units of 8471; 6) Women's overcoats, raincoats, capes, cloaks anoraks of wool or fine animal hair, other than those of heading no. 6204.
- II. Within the Champion-Value Segment (annual value of shipments of 1.9 M\$ -3.7 M\$) the most promising positions include: 1) Women's overcoats, carcoats, capes, cloaks, anoraks, windbreakers and similar articles of wool, knitted or crocheted; 2) Commodities not specified according to kind; 3) Electric conductors, for a voltage not exceeding 1000 v, fitted with connectors, others; 4) Seats with wooden frames, not upholstered, others; 5) Ballasts for discharge lamps or tubes; 6) Suspension shock absorbers for motor vehicles.
- III. In the Rising Champion Value Segment (annual value of shipments of 1 139 K\$ 1.9 M\$) the most promising positions remain: 1) Digital processing units other than those of 8471.41 and 8471.49, n.e.s.o.i.; 2) Machines and mechanical appliances having individual functions, others; 3) Vacuum cleaners with self-contained electric motor, others; 4) Electrical switches for a voltage not exceeding 1,000 v, others; 5) Ball bearings; 6) Headphones, earphones.
- IV. In the Latent Champion Value Segment (annual value of shipments of 910 K\$ 1 139 K\$) the most promising positions are: 1) Vacuum cleaners with self-contained electric motor, of a power It=1500 w and having a dust bag; 2) Microphones and stands therefor; 3) Measuring or checking instruments, appliances and machines, others; 4) Automatic circuit breakers for a voltage not exceeding 1,000 v; 5) Spark-ignition reciprocating piston engines for propulsion of vehicles, 250–1,000 cc; 6) Filtering or purifying machinery and apparatus for gases, others.






Canada's Imports from Romania in 2017 – 2024

- ➤ Over the long term (2017–2024), the compounded annual growth rate (CAGR) of Canada's imports from Romania has been +1.10%, with the most notable surge occurring in 2022, when Canada's imports from Romania rose by almost 63% year-on-year.
- ➤ In 2023, Canada's imports from Romania reached \$565.11 million, marking a notable decrease of 7.26% from \$609.38 million in 2022.
- ➤ In 2024, the value of imports totaled \$464.08 million, showing a significant -17.88% year-on-year decline.
- ➤ The analysis covers the top 100 imported products by value in 2024, categorized into four groups: the 1st Group – Top 25 (with the yearly imports value of 3.7 M\$ – 38 M\$ in 2024), the 2nd group (early trade value of 1.9 M\$ – 3.7 M\$), the 3rd group (1 139 K\$ – 1 900 K\$), the 4th group – Top 76-100 (910 K\$ – 1 139 K\$).
- For each group, we identify the products that have shown sustained and significant import growth from Romania, focusing on both long-term (2017 2024) and shorth-term (2023 2024) growth trends.

The **top-25 highest-value** product categories (6-digit HS classification) account for approximately **53.08**% of Canada's imports from Romania reaching **\$246.32 million** in 2024.

The Top 25 product groups are dominated by the following categories:

- > Pneumatic Tires: Amounting to \$49.72 million in 2024, accounting for 10.71% of Canada's imports from Romania:
 - New pneumatic tires, of rubber, of a kind used on motor cars (including station wagons and racing cars)
 - New pneumatic tires, of rubber, of a kind used on buses or trucks
- > Coats: These products accounted for \$45.82 million, representing 9.87% of total imports:
 - Women's overcoats, raincoats, capes, cloaks anoraks of wool or fine animal hair, other than those of heading no. 6204
 - Men's overcoats, raincoats, capes, cloaks, anoraks, of man-made fibres, other than those of heading no. 6203
 - Women's overcoats, raincoats, capes, cloaks anoraks, of man-made fibres, other than those of heading no. 6204
- > Articles of Iron or Steel: These products reached \$30.24 million, accounting for 6.52% of total Canada's imports from Romania:
 - Semifinished products of alloy steel (other than stainless) others
 - Stranded wire, ropes and cables, not electrically insulated, of iron or steel
 - > Line pipe for oil and gas pipelines, of seamless iron (other than cast iron) or steel, nes
 - Tubes, pipes and hollow profiles, seamless others, of circular cross section of alloy steel (other than stainless), not cold-drawn or cold-rolled
- Other Product Categories worth \$120.5 million accounting for 25.97% of total Canada's imports from Romania and including: Electrical Machinery, Footwear, Sunflower-seed or Safflower Oil, Medicaments, Medical Instruments, Tobacco and Its Substitutes.




Dynamics of Changes in the Structure of Canada's Imports from Romania

- During 2017 2024 the share of the top-25 categories steadily increased from 15% in 2017 to 53% in 2024, highlighting a growing concentration in key import positions.
- From 2021 to 2024, the category New pneumatic tires, of rubber, of a kind used on motor cars (including station wagons and racing cars) was leading in the imports structure, except in 2023, when the top import position was occupied by Semifinished products of alloy steel (other than stainless) others.
- Since 2023, the Women's overcoats, raincoats, capes, cloaks anoraks of wool or fine animal hair, other than those of heading no. 6204 category has emerged as the third-largest import category, with imports value reaching \$23.2 million in 2024.
 - The further analysis covers the import value dynamics of the 5 fastest growing and 5 most decreasing import positions, providing insights into shifting trade patterns and the evolving composition of Canada's import structure from Romania.



Most Growing and Declining Import Positions within Largest-value Segment

Out of the positions of the 1st group, three positions – 1) Semifinished products of alloy steel (other than stainless) others, 2) Sunflower-seed or safflower oil, and their fractions, refined but not chemically modified; and 3) Machines for the reception, conversion and transmission or regeneration of voice, images or other data, including switching and routing apparatus – stand out as showing the most significant long-term growth in import value (2017-2024).

Notably, Fir wood (sliced or peeled, >6mm) and Electrical static converters; power supplies for adp machines or units of 8471 have demonstrated the highest increase by 155-257% in 2024.








Imports Value of Tobacco and its Substitutes, others, K\$






Top-5 Positions with the Highest Decrease of Imports in Short-term









Imports Value of Power supplies for adp machines or units of 8471, M\$

This **group** with imports value of more than 910 and less than 1 139 K\$ (under 6-digit HS classification) account for **5.44**% of all Canada's imports from Romania, reaching nearly **\$25.25 million** in 2024.

Most Growing Import Positions Within Latent Champion Value Segment

Out of the positions of the latent champion value segment, 1) **Spark-ignition reciprocating piston engines for propulsion of vehicles except rail or tramway stock, over 250 but not over 1,000 cc**, and **2) Filtering or purifying machinery and apparatus for gases, others** have risen significantly in long-term in import value (2017-2023). Furthermore, these categories demonstrated remarkable increases in 2024, increasing by more than 55% compared to the same period in the previous year.


Imports Value of Spark-ignition Reciprocating Piston Engines for propulsion of vehicles, 250 – 1,000 cc, K\$




