










Figure 1. Global Market Size (B US\$, left axes), Annual Growth Rates (%, right axis)




Figure 2. Global Market Size (Ktons, left axis), Annual Growth Rates (%, right axis)



COUNTRY ECONOMIC OUTLOOK - COMPETITION

This section provides an overview of the competitive environment and trade protection measures within the selected country. It includes detailed information on import tariffs, pricing levels for specific goods, and the competitive advantages held by local producers.

A competitive landscape of Titanium oxides formed by local producers in Germany in 2022 is likely to be risk intense with an elevated level of local competition. The potentiality of local businesses to produce similar competitive products is somewhat Promising. However, this doesn't account for the competition coming from other suppliers of this product to the market of Germany.

In accordance with international classifications, the Titanium oxides belongs to the product category, which also contains another 106 products, which Germany has comparative advantage in producing. This note, however, needs further research before setting up export business to Germany, since it also doesn't account for competition coming from other suppliers of the same products to the market of Germany.

The level of proxy prices of 75% of imports of Titanium oxides to Germany is within the range of 2,846.72 - 8,125.42 US\$/ton in 2023. The median value of proxy prices of imports of this commodity (current US\$/ton 4,039.70), however, is higher than the median value of proxy prices of 75% of the global imports of the same commodity in this period (current US\$/ton 3,250.24). This may signal that the product market in Germany in terms of its profitability may have turned into premium for suppliers if compared to the international level.

Germany charged on imports of Titanium oxides in 2022 on average 5.50%. The bound rate of ad valorem duty on this product, Germany agreed not to exceed, is 5.50%. Once a rate of duty is bound, it may not be raised without compensating the affected parties. At the same time, the rate of the tariff Germany set for Titanium oxides was higher than the world average for this product in 2022 (3%). This may signal about Germany's market of this product being more protected from foreign competition.

This ad valorem duty rate Germany set for Titanium oxides has been agreed to be a normal non-discriminatory tariff charged on imports of this product for all WTO member states. However, a country may apply the preferential rates resulting from a reciprocal trading agreement (e.g. free trade agreement or regional trading agreement) or a non-reciprocal preferential trading scheme like the Generalized System of Preference or preferential tariffs for least developed countries. As of 2023, Germany applied the preferential rates for 108 countries on imports of Titanium oxides. The range of the preferential rate applied were from the 0% to 2%. The maximum level of ad valorem duty Germany applied to imports of Titanium oxides 2022 was 5.50%. Meanwhile, the share of Titanium oxides Germany imported on a duty free basis in 2023 was 0%



- b. Germany's market size in 01.2024-09.2024 reached US\$56.94M, compared to US\$62.09M in the same period last year. The growth rate was -8.29%.
- c. Imports of the product contributed around 0.01% to the total imports of Germany in 2023. That is, its effect on Germany's economy is generally of a low strength. At the same time, the share of the product imports in the total Imports of Germany remained stable.
- d. Since CAGR of imports of the product in US\$-terms for the past 5Y exceeded -3.07%, the product market may be defined as declining. Ultimately, the expansion rate of imports of Titanium oxides was underperforming compared to the level of growth of total imports of Germany (4.34% of the change in CAGR of total imports of Germany).
- e. It is highly likely, that decline in demand accompanied by growth in prices was a leading driver of the long-term growth of Germany's market in US\$-terms.
- f. The best-performing calendar year with the highest growth rate of imports in the US\$-terms was 2021. It is highly likely that growth in demand accompanied by declining prices had a major effect.
- g. The worst-performing calendar year with the smallest growth rate of imports in the US\$-terms was 2023. It is highly likely that biggest drop in import volumes with slow average price growth had a major effect.



- c. Expansion rates of the imports of Titanium oxides in Germany in 01.2024-09.2024 surpassed the long-term level of growth of the country's imports of Titanium oxides in volume terms.



- 1. Average annual level of proxy prices of Titanium oxides has been fast-growing at a CAGR of 7.92% in the previous 5 years.
- 2. In 2023, the average level of proxy prices on imports of Titanium oxides in Germany reached 5.06 K US\$ per 1 ton in comparison to 4.27 K US\$ per 1 ton in 2022. The annual growth rate was 18.41%.
- 3. Further, the average level of proxy prices on imports of Titanium oxides in Germany in 01.2024-09.2024 reached 4.35 K US\$ per 1 ton, in comparison to 5.01 K US\$ per 1 ton in the same period last year. The growth rate was approx. -13.17%.
- 4. In this way, the growth of average level of proxy prices on imports of Titanium oxides in Germany in 01.2024-09.2024 was lower compared to the long-term dynamics of proxy prices.



Figure 7. Monthly Imports of Germany, K current US\$



- b. The growth of imports of Titanium oxides to Germany in LTM underperformed the long-term imports growth of this product.
- c. Imports of Titanium oxides to Germany for the most recent 6-month period (04.2024 09.2024) underperformed the level of Imports for the same period a year before (-12.49% change).
- d. A general trend for market dynamics in 10.2023 09.2024 is stagnating. The expected average monthly growth rate of imports of Germany in current USD is -0.64% (or -7.4% on annual basis).
- e. Monthly dynamics of imports in last 12 months included no record(s) that exceeded the highest/peak value of imports achieved in the preceding 48 months, and 2 record(s) that bypass the lowest value of imports in the same period in the past.






Figure 10. Y-o-Y Monthly Level Change of Imports of Germany, tons

- c. Imports of Titanium oxides to Germany for the most recent 6-month period (04.2024 09.2024) outperform the level of Imports for the same period a year before (7.69% change).
- d. A general trend for market dynamics in 10.2023 09.2024 is stagnating. The expected average monthly growth rate of imports of Titanium oxides to Germany in tons is 0.35% (or 4.22% on annual basis).
- e. Monthly dynamics of imports in last 12 months included no record(s) that exceeded the highest/peak value of imports achieved in the preceding 48 months, and 1 record(s) that bypass the lowest value of imports in the same period in the past.








Figure 13.Largest Trade Partners of Germany in 2023, K US\$



Figure 16.Largest Trade Partners of Germany in 2023, tons







- 1. Belgium (2.5 M US\$ contribution to growth of imports in LTM);
- 2. Norway (2.06 M US\$ contribution to growth of imports in LTM);
- 3. United Kingdom (1.28 M US\$ contribution to growth of imports in LTM);
- 4. Netherlands (0.65 M US\$ contribution to growth of imports in LTM);
- 5. Czechia (0.58 M US\$ contribution to growth of imports in LTM);



- 2. Belgium (2.79 M US\$, or 3.97% share in total imports);



Conclusion: Based on this estimation, the entry potential of this product market can be defined as signifying high risks associated with market entry.



MARKET VOLUME THAT MAY BE CAPTURED BY A NEW SUPPLIER IN MID-TERM

This concluding section provides an assessment of the attractiveness level of the chosen country for suppliers. It also includes estimations of the market volume that suppliers can potentially fill, represented in both US\$ and Ktons.

Conclusion:

Based on recent imports dynamics and high-level analysis of the competition landscape, imports of Titanium oxides by Germany may be expanded to the extent of 198.21 K US\$ monthly, that may be captured by suppliers in a short-term.

This estimation holds possible should any significant competitive advantages have been gained.

A high-level estimation of a share of imports of Titanium oxides by Germany that may be captured by a new supplier or by existing market player in the upcoming short-term period of 6-12 months, includes two major components:

- Component 1: Potential imports volume supported by Market Growth. This is a market volume that can be captured by supplier as an effect of the trend related to market growth.
- Component 2: Expansion of imports due to increase of Competitive Advantages of suppliers. This is a market volume that can be captured by suppliers with strong competitive advantages, whether price wise or another, more specific and sustainable competitive advantages.

Below is an estimation of supply volumes presented separately for both components. In addition, an integrated component was added to estimate total potential supply of Titanium oxides to Germany.

Ad valorem tariff: An ad valorem duty (tariff, charge, and so on) is based on the value of the dutiable item and expressed in percentage terms. For example, a duty of 20 percent on the value of automobiles.

Applied tariff / Applied rates: Duties that are actually charged on imports. These can be below the bound rates.

Aggregation: A process that transforms microdata into aggregate-level information by using an aggregation function such as count, sum average or standard deviation.

Aggregated data: Data generated by aggregating non-aggregated observations according to a well- defined statistical methodology.

Approx.: Short for "approximation", which is a guess of a number that is not exact but that is close.

B: billions (e.g. US\$ 10B)

CAGR: For the purpose of this report, the compound annual growth rate (CAGR) is the annualized average rate of growth of a specific indicator (e.g. imports, proxy prices) between two given years, assuming growth takes place at an exponentially compounded rate. The CAGR between given years X and Z, where Z - X = N, is the number of years between the two given years, is calculated as follows:

$$CAGR_{\text{from year X to year Z}} = \left(\frac{Value_{yearZ}}{Value_{yearX}}\right)^{(1/N)} - 1$$

Current US\$: Data reported in current (or "nominal") prices for each year are measured in the prices for that particular year. For example, GDP for 1990 are based on 1990 prices, for 2020 are based on 2020 prices, and so on. Current price series are influenced by the effects of inflation.

Constant US\$: Constant (or "real") price series show the data for each year in the prices of a chosen reference year. For example, reported GDP in constant 2015 prices show data for 2019, 2022, and all other years in 2015 prices. Constant price series are used to measure the true volume growth, i.e. adjusting for the effects of price inflation.

CPI, Inflation: Inflation as measured by the consumer price index reflects the annual percentage change in the cost to the average consumer of acquiring a basket of goods and services that may be fixed or changed at specified intervals, such as yearly.

Country Credit Risk Classification: The Organization for Economic Cooperation & Development (OECD) Country Risk Classification measures the country credit risk and the likelihood that a country will service its external debt. The index uses a scale of eight risk categories to determine a country's credit risk (from 0 to 7: 0 being risk free and 7 represents the highest level of country risk to service its external debt). The country risk classifications are not sovereign risk classifications and therefore should not be compared with the sovereign risk classifications of private credit rating agencies (CRAs).

Country Market: For the purpose of this report, this is the total number of all goods (in US\$ or volume values) which added to the stock of material resources of a country by entering (imports) its economic territory in a certain period of time (often measured over the course of a year).

Competitors: Businesses/companies who compete against each other in the same good market. This may also refer to a country on a global level.

Domestic or foreign goods: Specification of whether the good is of domestic or foreign origin.

Domestic goods: Can be defined as goods originating in the economic territory of a country. In general, goods are considered as originating in the country if they have been wholly obtained in it or were substantially transformed.

Economic territory: The area under the effective economic control of a single government.

Estimation: Estimation is concerned with inference about the numerical value of unknown population values from incomplete data such as a sample.

Foreign goods: Are goods which originate from the rest of the world (including foreign goods in transit through the compiling country) or are obtained under the outward processing procedure, when such processing confers foreign origin (compensating products which changed origin).

Growth rates: refer to the percentage change of a specific variable within a specific time period.

GDP (current US\$): Gross Domestic Product at purchaser's prices is the sum of gross value added by all resident producers in the economy plus any product taxes and minus any subsidies not included in the value of the products. It is calculated without making deductions for depreciation of fabricated assets or for depletion and degradation of natural resources. Data are in current U.S. dollars. Dollar figures for GDP are converted from domestic currencies using single year official exchange rates. For a few countries where the official exchange rate does not reflect the rate effectively applied to actual foreign exchange transactions, an alternative conversion factor is used.



GDP (constant 2015 US\$): Gross Domestic Product at purchaser's prices is the sum of gross value added by all resident producers in the economy plus any product taxes and minus any subsidies not included in the value of the products. It is calculated without making deductions for depreciation of fabricated assets or for depletion and degradation of natural resources. Data are in constant 2015 prices, expressed in U.S. dollars. Dollar figures for GDP are converted from domestic currencies using 2015 official exchange rates. For a few countries where the official exchange rate does not reflect the rate effectively applied to actual foreign exchange transactions, an alternative conversion factor is used.

GDP growth (annual %): Annual percentage growth rate of GDP at market prices based on constant local currency. An economy's growth is measured by the change in the volume of its output or in the real incomes of its residents. The 2008 United Nations System of National Accounts (2008 SNA) offers three plausible indicators for calculating growth: the volume of gross domestic product (GDP), real gross domestic income, and real gross national income. The volume of GDP is the sum of value added, measured at constant prices, by households, government, and industries operating in the economy. GDP accounts for all domestic production, regardless of whether the income accrues to domestic or foreign institutions.

Goods (products): For the purpose of his report the term is defined as physical, produced objects for which a demand exists, over which ownership rights can be established and whose ownership can be transferred from one institutional unit to another by engaging in transactions on markets, plus certain types of so-called knowledge-capturing products stored on physical media that can cross borders physically.

Goods in transit: Goods are considered as simply being transported through a country if they (a) enter and leave the compiling country solely for the purpose of being transported to another country, (b) are not subject to halts not inherent to the transportation and (c) can be identified when both entering and leaving the country.

General imports and exports: Are flows of goods entering/leaving the statistical territory of a country applying the general trade system and recorded in compliance with the general and specific guidelines.

General imports consist of:

(a) Imports of foreign goods (including compensating products after outward processing which changed their origin from domestic to foreign) entering the free circulation area, premises for inward processing, industrial free zones, premises for customs warehousing or commercial free zones;

(b) Re-imports of domestic goods into the free circulation area, premises for inward processing or industrial free zones, premises for customs warehousing or commercial free zones.

General exports consist of:

(a) Exports of domestic goods (including compensating products after inward processing which changed their origin from foreign to domestic) from any part of the statistical territory, including free zones and customs warehouses;

(b) Re-exports of foreign goods from any part of the statistical territory, including free zones and customs warehouses.

Global Market: For the purpose of this report, the term represents the sum of imports (either in US\$ or volume terms) of a particular good of all countries who reported these data to the UN Comtrade database. Important to mention, the term doesn't include local production of that good, which may account for a large part. Thus, the term covers only global Imports flow.

The Harmonized Commodity Description and Coding Systems (HS, Harmonized System): an internationally recognized commodity classification developed and maintained by The World Customs Organization (WCO). The system is used by more than 200 countries and economies as a basis for their Customs tariffs and for the collection of international trade statistics. Over 98 % of the merchandise in international trade is classified in terms of the HS. The HS comprises over 5,600 separate groups of goods identified by a 6-digit code, arranged in 99 chapters, grouped in 21 sections.

HS Code: At the international level, the Harmonized System for classifying goods is a six-digit code system (HS code, Commodity Code, Product Code), which can be broken down into three parts. The first two digits (HS-2) identify the chapter the goods are classified in, e.g., 01 Animals; live. The next two digits (HS-4) identify groupings within that chapter (the heading), e.g., 0104 - Sheep and goats; live. The following two digits (HS-6) are even more specific (the subheading), e.g., 010410 - Sheep; live. Up to the HS-6 digit level, all countries classify products in the same way (a few exceptions exist where some countries apply old versions of the HS).

Imports penetration: Import penetration ratios are defined as the ratio between the value of imports as a percentage of total domestic demand. The import penetration rate shows to what degree domestic demand D is satisfied by imports M. It is calculated as M/D, where the domestic demand is the GDP minus exports plus imports i.e. [D = GDP-X+M]. From a macroeconomic perspective, a country that produces manufactured goods with a high degree of international competitiveness will see decreasing imports. Under these circumstances, the import penetration rate will fall. Conversely, a country that produces manufactured goods with a low degree of international competitiveness will see increasing imports. In this case, the import penetration will rise. It must be noted, however, that the relationship described here does not always hold. Two factors – Import barriers and transaction costs – may interfere with it. If a country has established import barriers, another country's comparatively better manufactured goods will have little impact on its imports, and its import penetration rate will not rise. Likewise, if transportation and other transaction costs are extremely high for traded goods, differences in international competitiveness may not be reflected in the import penetration rate.



International merchandise trade statistics: Refers to both foreign (or external) merchandise trade statistics as compiled by countries and international merchandise trade statistics as represented by the consolidated and standardized country data sets that are compiled and maintained by the international or regional agencies.

Importer/exporter: In general, refers to the party in the customs territory who signed the contract of purchase/sale and/or who is responsible for executing the contract (i.e., the agent responsible for effecting import into or export from a country). Each importer or exporter is usually assigned a unique identification number.

Imports volume: The number or amount of Imports in general, typically measured in kilograms.

Imputation: Procedure for entering a value for a specific data item where the response is missing or unusable.

Imports value: The price actually paid for all imported units (by quantity unit) of the given commodity (unit price multiplied by quantity), or the cost of the commodity if not sold or purchased.

Institutional unit: The elementary economic decision-making center characterized by uniformity of behavior and decision-making autonomy in the exercise of its principal function.

K: thousand (e.g. US\$ 10K)

Ktons: thousand tons (e.g. 1 Ktons)

LTM: For the purpose of this report, LTM means Last Twelve Months for which the trade data are available. This period may not coincide with calendar period though, which is often the case with the trade data.

Long-term growth rate: For the purpose of this report, it is a metric that is used to express the change in a variable, represented as a percentage, and is used interchangeably with CAGR.

Long-Term: For the purpose of this report, it is equivalent to a period used for calculation of CAGR.

M: million (e.g. US\$ 10M)

Market: For the purpose of this report the terms Market and Imports may be used interchangeably, since both refer to a particular good which is bought and sold in particular country. The distinctive feature is that the Market term includes only imports of a particular good to a particular country. It does not include domestic production of such good or anything else.

Microdata: Data on the characteristics of individual transactions collected by customs or other sources (such as administrative records or surveys) or estimated.

Macrodata: Data derived from microdata by grouping or aggregating them, such as total exports of goods classified in a particular HS subheading.

Mirror statistics: Mirror statistics are used to conduct bilateral comparisons of two basic measures of a trade flow and are a traditional tool for detecting the causes of asymmetries in statistics.

Mean value: The arithmetic mean, also known as "arithmetic average", is a measure of central tendency of a finite set of numbers: specifically, the sum of the values divided by the number of values.

Median value: Is the value separating the higher half from the lower half of a data sample, a population, or a probability distribution.

Marginal Propensity to Import: Is the amount imports increase or decrease with each unit rise or decline in disposable income. The idea is that rising income for businesses and households spurs greater demand for goods from abroad and vice versa.

Trade Freedom Classification: Trade freedom is a composite measure of the absence of tariff and non-tariff barriers that affect imports and exports of goods and services. The trade freedom score is based on two inputs:

The trade-weighted average tariff rate and

Non-tariff barriers (NTBs).

Market size (Market volumes): For the purpose of this report, it refers to the total number of specific good (in US\$ or volume values) which added to the stock of relevant material resources in a certain period of time (often measured over the course of a year). This term may refer to country, region, or world (global) levels.

Net weight (kilograms): the net shipping weight, excluding the weight of packages or containers.



OECD: The Organisation for Economic Co-operation and Development (OECD) is an intergovernmental organisation with 38 member countries, founded in 1961 to stimulate economic progress and world trade. It is a forum whose member countries describe themselves as committed to democracy and the market economy, providing a platform to compare policy experiences, seek answers to common problems, identify good practices, and coordinate domestic and international policies of its members. The majority of OECD Members are high-income economies ranked as "very high" in the Human Development Index, and are regarded as developed countries. Their collective population is 1.38 billion. As of 2017, OECD Member countries collectively comprised 62.2% of global nominal GDP (USD 49.6 trillion) and 42.8% of global GDP (Int\$54.2 trillion) at purchasing power parity.

The OECD Country Risk Classification measures the country credit risk and the likelihood that a country will service its external debt. The index uses a scale of eight risk categories to determine a country's credit risk, with 0 representing the lowest level of country risk. For more information, visit <u>https://www.oecd.org/</u>

Official statistics: Statistics produced in accordance with the Fundamental Principles of Official Statistics by a national statistical office or by another producer of official statistics that has been mandated by the national government or certified by the national statistical office to compile statistics for its specific domain.

Proxy price: For the purpose of this report, the term is a broad representation of actual price of a specific good in a specific market. Proxy price acts as a substitute for actual price for the reason of being calculated rather than obtained from the market directly. Proxy price implies very closer meaning as unit values used in international trade statistics.

Prices: For the purpose of this report the term always refers to prices on imported goods, except for explicit definitions, e.g. consumer price index.

Production: Economic production may be defined as an activity carried out under the control and responsibility of an institutional unit that uses inputs of labor, capital, and goods and services to produce outputs of goods or services.

Physical volumes: For the purpose of this report, this term indicates foreign trade (imports or exports flows) denominated in units of measure of weight, typically in kilograms.

Quantity units (Volume terms): refer to physical characteristics of goods. The use of appropriate quantity units may also result in more internationally comparable data on international movements of goods, because differences in quantity measurements between the importing country and the exporting country can be less significant than in value measurements. Therefore, quantities are often used in checking the reliability of the value data via the calculation of so-called unit values (value divided by quantity). It is recommended that countries collect or estimate, validate and report quantity information in the World Customs Organization (WCO) standard units of quantity (e.g. kilograms) and in net weight (i.e. not including packaging) on all trade transactions.

RCA Index: Revealed Comparative Advantage Index Comparative advantage underlies economists' explanations for the observed pattern of inter-industry trade. In theoretical models, comparative advantage is expressed in terms of relative prices evaluated in the absence of trade. Since these are not observed, in practice we measure comparative advantage indirectly. Revealed comparative advantage indices (RCA) use the trade pattern to identify the sectors in which an economy has a comparative advantage, by comparing the country of interests' trade profile with the world average. The RCA index is defined as the ratio of two shares. The numerator is the share of a country's total exports of the commodity of interest in its total exports. The denominator is share of world exports of the same commodity in total world exports.

where **s** is the country of interest, **d** and **w** are the set of all countries in the world, **i** is the sector of interest, **x** is the commodity export flow and **X** is the total export flow.

The numerator is the share of good i in the exports of country s, while the denominator is the share of good i in the exports of the world.

Re-imports: Are imports of domestic goods which were previously recorded as exports.

Re-exports: Are exports of foreign goods which were previously recorded as imports.



Real Effective Exchange Rate (REER): It is an indicator of a nation's competitiveness in relation to its trading partners. It is a measure of the relative strength of a nation's currency in comparison with those of the nations it trades with. It is used to judge whether the nation's currency is undervalued or overvalued or, ideally, fairly valued. Economists use REER to evaluate a country's trade flow and analyze the impact that factors such as competition and technological changes are having on a country and its economy. An increase in a nation's REER means businesses and consumers have to pay more for the products they export, while their own people are paying less for the products that it imports. It is losing its trade competitiveness, but the environment gets more favorable to Imports.

Short-term growth rate: For the purpose of this report, it is a metric that is used to express the change in a variable, represented as a percentage, and used interchangeably with LTM.

Statistical data: Data collected, processed or disseminated by a statistical organization for statistical purposes.

Seasonal adjustment: Statistical method for removing the seasonal component of a time series.

Seasonal component: Fluctuations in a time series that exhibit a regular pattern at a particular time during the course of a year which are similar from one year to another.

Short-Term: For the purpose of this report, it is equivalent to the LTM period.

T: tons (e.g. 1T)

Trade statistics: For the purposes of this report, the term will be used to refer to international, foreign or external merchandise trade statistics, unless otherwise indicated, and the term "merchandise" has the same meaning as the terms, "products", "goods" and "commodities".

Total value: The price actually paid for all units (by quantity unit) of the given commodity (unit price multiplied by quantity), or the cost of the commodity if not sold or purchased.

Re-exports: Are exports of foreign goods which were previously recorded as imports.

Time series: A set of values of a particular variable at consecutive periods of time.

Tariff binding: Maximum duty level on a product listed in a member's schedule of commitments; it represents the commitment not to exceed the duty applied on the concerned product beyond the level bound in the schedule. Once a rate of duty is bound, it may not be raised without compensating the affected parties. For developed countries, the bound rates are generally the rates actually charged. Most developing countries have bound the rates somewhat higher than the actual rates charged, so the bound rates serve as ceilings.

The terms of trade (ToT): is the relative price of exports in terms of imports and is defined as the ratio of export prices to import prices. It can be interpreted as the amount of import goods an economy can purchase per unit of export goods. An improvement of a nation's terms of trade benefits that country in the sense that it can buy more imports for any given level of exports. The terms of trade may be influenced by the exchange rate because a rise in the value of a country's currency lowers the domestic prices of its imports but may not directly affect the prices of the commodities it exports.

Trade Dependence, **%GDP:** Is the sum of exports and imports of goods and services measured as a share of gross domestic product. This indicator shows to what extent the country's economy relies on foreign trade as compared to its GDP.

US\$: US dollars

WTO: the World Trade Organization (WTO) is an intergovernmental organization that regulates and facilitates international trade. The World Trade Organization (WTO) is the only global international organization dealing with the rules of trade between nations. At its heart are the WTO agreements, negotiated and signed by the bulk of the world's trading nations and ratified in their parliaments. The goal is to ensure that trade flows as smoothly, predictably and freely as possible. With effective cooperation in the United Nations System, governments use the organization to establish, revise, and enforce the rules that govern international trade. It officially commenced operations on 1 January 1995, pursuant to the 1994 Marrakesh Agreement, thus replacing the General Agreement on Tariffs and Trade (GATT) that had been established in 1948. The WTO is the world's largest international economic organization, with 164 member states representing over 98% of global trade and global GDP.

Y: year (e.g. 5Y - five years)

Y-o-Y: Year-over-year (YOY) is a financial term used to compare data for a specific period of time with the corresponding period from the previous year. It is a way to analyze and assess the growth or decline of a particular variable over a twelve-month period.



METHODOLOGY

Following is a list of use cases of application of specific words combinations across the report. The selection is based on calculated values of corresponding indicators.

1. Country Market Trend:

 In case the calculated growth rates for the LTM period exceeded the value of 5Y CAGR by 0.5 percentage points or more, then "surpassed" is used, if it was 0.5 percentage points or more lower than 5Y CAGR then it is "underperformed". In case, if the calculated growth rate for the LTM period was within the interval of 5Y CAGR +- 5 percentage points (including boundary values), then either "followed" or "was comparable to" is used.

2. Global Market Trends US\$-terms:

- If the "Global Market US\$-terms CAGR, %" value was less than 0%, the "declining" is used,
- If the "Global Market US\$-terms CAGR, %" value was more than or equal to 0% and less than 4%, then "stable" is used,
- If the "Global Market US\$-terms CAGR, %" value was more than or equal to 4% and less than 6%, then "growing" is used,
- If the "Global Market US\$-terms CAGR, %" value was more than 6%, then "fast growing" is used.

3. Global Market Trends t-terms:

- If the "Global Market t-terms CAGR, %" value was less than 0%, the "declining" is used,
- If the "Global Market t-terms CAGR, %" value was more than or equal to 0% and less than 4%, then "stable" is used,
- If the "Global Market t-terms CAGR, %" value was more than or equal to 4% and less than 6%, then **"growing"** is used,
- If the "Global Market t-terms CAGR, %" value was more than 6%, then "fast growing" is used.

4. Global Demand for Imports:

- If the calculation of the change in share of a specific product in the total imports of the country was more than 0.5 percentage points, then the **"growing"** was used,
- If the calculation of the change in share of a specific product in the total imports of the country was less than 0.5%, then the "declining" was used,
- If the calculation of the change in share of a specific product in the total imports of the country was within the range of +- 0.5% (including boundary values), then the **"remain stable"** was used,

5. Long-term market drivers:

- "Growth in Prices accompanied by the growth in Demand" is used, if the "Global Market t-terms CAGR, %" was more than 2% and the "Inflation 5Y average" was more than 0% and the "Inflation contribution to US\$-term CAGR%" was more than 50%,
- "Growth in Demand" is used, if the "Global Market t-terms CAGR, %" was more than 2% and the "Inflation 5Y average" was more than 0% and the "Inflation contribution to US\$-term CAGR%" was less than or equal to 50%,
- "Growth in Prices" is used, if the "Global Market t-terms CAGR, %" was more than 0% or less than or equal to 2%, and the "Inflation 5Y average" was more than 4%,
- "Stable Demand and stable Prices" is used, if the "Global Market t-terms CAGR, %" was more than or equal to 0%, and the "Inflation 5Y average" was more than of equal to 0% and less than or equal to 4%,
- **"Growth in Demand accompanied by declining Prices"** is used, if the "Global Market t-terms CAGR, %" was more than 0%, and the "Inflation 5Y average" was less than 0%,
- **"Decline in Demand accompanied by growing Prices"** is used, if the "Global Market t-terms CAGR, %" was less than 0%, and the "Inflation 5Y average" was more than 0%,
- **"Decline in Demand accompanied by declining Prices"** is used, if the "Global Market t-terms CAGR, %" was less than 0%, and the "Inflation 5Y average" was less than 0%,

6. Rank of the country in the World by the size of GDP:

- "Largest economy", if GDP (current US\$) is more than 1,800.0 B,
- "Large economy", if GDP (current US\$) is less than 1,800.0 B and more than 1,000.0 B,
- "Midsize economy", if GDP (current US\$) is more than 500,0.0 B and less than 1,000.0 B,
- "Small economy", if GDP (current US\$) is more than 50.0 B and less than 500.0 B,
- "Smallest economy", if GDP (current US\$) is less than 50.0 B,
- "Impossible to define due to lack of data", if the country didn't provide data.



7. Economy Short Term Growth Pattern:

- "Fastest growing economy", if GDP growth (annual %) is more than 17%,
- "Fast growing economy", if GDP growth (annual %) is less than 17% and more than 10%,
- "Higher rates of economic growth", if GDP growth (annual %) is more than 5% and less than 10%,
- "Moderate rates of economic growth", if GDP growth (annual %) is more than 3% and less than 5%,
- "Slowly growing economy", if GDP growth (annual %) is more than 0% and less than 3%,

- "Low level of reliance", in case if Imports of goods and services (% of GDP) is more than 10% and less than 30%,
- "Practically self-reliant", in case if Imports of goods and services (% of GDP) is more than 0% and less than 10%,
- "Impossible to define due to lack of data", in case there are not enough data.

Sts., Nauru, Palau, St. Kitts and Nevis, St. Lucia, St. Vincent and the Grenadines, Samoa, Sao Tome and Principe, Seychelles, Sint Maarten, Solomon Islands, Tonga, Tuvalu, Vanuatu, because these countries haven't been classified.
 - "There are no data for the country", in case if the country is not being classified.

16. **Trade Freedom Classification.** The Index of Economic Freedom is a tool for analyzing 184 economies throughout the world. It measures economic freedom based on 12 quantitative and qualitative factors, grouped into four broad categories, or pillars, of economic freedom: (1) Rule of Law (property rights, government integrity, judicial effectiveness), (2) Government Size (government spending, tax burden, fiscal health), (3) Regulatory Efficiency (business freedom, labor freedom, monetary freedom), (4) Open Markets (trade freedom, investment freedom, financial freedom). For the purpose of this report we use the Trade freedom subindex to reflect country's position in the world with respect to international trade.

- "Repressed", in case if the Trade freedom subindex is less than or equal to 50 and more than 0,
- $^\circ$ "Mostly unfree", in case if the Trade freedom subindex is less than or equal to 60 and more than 50,
- "Moderately free", in case if the Trade freedom subindex is less than or equal to 70 and more than 60,
- $^\circ\,$ "Mostly free", in case if the Trade freedom subindex is less than or equal to 80 and more than 70,
- \circ "Free", in case if the Trade freedom subindex is less than or equal to 100 and more than 80,
- "There are no data for the country", in case if the country is not being classified.



17. The competition landscape / level of risk to export to the specified country:

- **"risk free with a low level of competition from domestic producers of similar products"**, in case if the RCA index of the specified product falls into the 90th quantile,
- **"somewhat risk tolerable with a moderate level of local competition"**, in case if the RCA index of the specified product falls into the range between the 90th and 92nd quantile,
- **"risk intense with an elevated level of local competition"**, in case if the RCA index of the specified product falls into the range between the 92nd and 95th quantile,
- **"risk intense with a high level of local competition"**, in case if the RCA index of the specified product falls into the range between the 95th and 98th quantile,
- **"highly risky with extreme level of local competition or monopoly"**, in case if the RCA index of the specified product falls into the range between the 98th and 100th quantile,
- "Impossible to define due to lack of data", in case there are not enough data.

18. Capabilities of the local businesses to produce similar competitive products:

- **"low"**, in case the competition landscape is risk free with a low level of competition from domestic producers of similar products,
- "moderate", in case the competition landscape is somewhat risk tolerable with a moderate level of local competition,
- **"promising"**, in case the competition landscape is risk intense with an elevated level of local competition or risk intense with a high level of local competition,
- "high", in case the competition landscape is highly risky with extreme level of local competition or monopoly,
- "Impossible to define due to lack of data", in case there are not enough data.

19. The strength of the effect of imports of particular product to a specified country:

- "low", in case if the share of the specific product is less than 0.1% in the total imports of the country,
- "moderate", in case if the share of the specific product is more than or equal to 0.1% and less than 0.5% in the total imports of the country,
- "high", in case if the share of the specific product is equal or more than 0.5% in the total imports of the country.

20. A general trend for the change in the proxy price:

- **"growing"**, in case if 5Y CAGR of the average proxy prices, or growth of the average proxy prices in LTM is more than 0,
- **"declining"**, in case if 5Y CAGR of the average proxy prices, ot growth of the average proxy prices in LTM is less than 0,

21. The aggregated country's ranking to determine the entry potential of this product market:

- · Scores 1-5: Signifying high risks associated with market entry,
- Scores 6-8: Indicating an uncertain probability of successful entry into the market,
- Scores 9-11: Suggesting relatively good chances for successful market entry,
- Scores 12-14: Pointing towards high chances of a successful market entry.

22. Global market size annual growth rate, the best-performing calendar year:

- "Growth in Prices accompanied by the growth in Demand" is used, if the "Country Market t-term growth rate, %" was more than 2% and the "Inflation growth rate, %" was more than 0% and the "Inflation contribution to \$-term growth rate, %" was more than 50%,
- **"Growth in Demand"** is used, if the "Country Market t-term growth rate, %" was more than 2% and the "Inflation growth rate, %" was more than 0% and the "Inflation contribution to \$-term growth rate, %" was less than or equal to 50%,
- **"Growth in Prices"** is used, if the "Country Market t-term growth rate, %" was more than 0% and less than or equal to 2%, and the "Inflation growth rate, %" was more than 4%,
- **"Stable Demand and stable Prices"** is used, if the "Country Market t-term growth rate, %" was more than or equal to 0% and less than or equal to 2%, and the "Inflation growth rate, %" was more than of equal to 0% and less than or equal to 4%,
- **"Growth in Demand accompanied by declining Prices"** is used, if the "Country Market t-term growth rate, %" was more than 0%, and the "Inflation growth rate, %" was less than 0%,
- **"Decline in Demand accompanied by growing Prices"** is used, if the "Country Market t-term growth rate, %" was less than 0%, and the "Inflation growth rate, %" was more than 0%.



23. Global market size annual growth rate, the worst-performing calendar year:

- "Declining average prices" is used if "Country Market t term growth rate, % is more than 0%, and "Inflation growth rate, %" is less than 0%
- "Low average price growth" is used if "Country Market t term growth rate, % is more than 0%, and "Inflation growth rate, %" is more than 0%,
- "Biggest drop in import volumes with low average price growth" is used if "Country Market t term growth rate, % is less than 0%, and "Inflation growth rate, %" is more than 0%,
- "Decline in Demand accompanied by decline in Prices" is used if "Country Market t term growth rate, % is less than 0%, and "Inflation growth rate, %" is less than 0%.

24. TOP-5 Countries Ranking:

Top-10 biggest suppliers in last calendar year are being ranked according to 4 components:

- 1. share in imports in LTM,
- 2. proxy price in LTM,
- 3. change of imports in US\$-terms in LTM, and
- 4. change of imports in volume terms in LTM

Each of the four components ranges from 1 to 10, with 10 being the highest. The aggregated score is being formed as a sum of scores of ranking of each component. However, in case if countries get similar scores, the ranking of the first component prevails in selection.

25. Export potential:

As a part of risks estimation component and business potential of export to the country, a system of ranking has been introduced. It helps to rank a country based on a set of macroeconomic and market / sectoral parameters covered in this report. Seven ranking components have been selected:

- 1. Long-term trends of Global Demand for Imports (refer to pages 17-20 of the report)
- 2. Strength of the Demand for Imports in the selected country (refer to pages 22-23 of the report)
- 3. Macroeconomic risks for Imports in the selected country (refer to pages 22-23 of the report)
- 4. Market entry barriers and domestic competition pressures for imports of the good (refer to pages 22-24 of the report)
- 5. Long-term trends of Country Market (refer to pages 26-29 of the report)
- 6. Short-term trends of Country Market, US\$-terms (refer to pages 30-31 of the report)
- 7. Short-term trends of Country Market, volumes and proxy prices (refer to pages 32-35 of the report)

Each component includes 4-6 specific parameters. All parameters are evaluated on a scale from 0 to 6, with 0 being the lowest/ less favorable value or characteristic. An aggregated rank is a total country's score that includes scores of each specific ranking component. Each component is evaluated on a scale from 0 to 2, with 0 being the lowest score. The highest possible aggregated country's score is 14 points (up to 2 points for each of 7 ranking components). Aggregated country's rank is a sum of points gained for each ranking component. It ranges from 0 to 14 points. An aggregated rank describes risks and imports potential of the selected country with the selected product.

26. Market volume that may be captured in the mid-term:

The result of the market research is an approximation of the potential supply volume for the specific product in the designated market, provided the continuation of the identified trends in the future. The potential supply volume comprises two components:

1. **Component 1** is related to the ongoing trend in market development. The calculation is based on the anticipated average monthly market growth, derived from the trend observed over the past 24 months (you can find this trend currently calculated for tons on the report page 32). The assumption is that the identified trend will remain unchanged, and the calculated average monthly increase is applied to actual data on the volume of average monthly import supplies over the last 12 months, along with the corresponding average price. Simultaneously, the computation is based on the idea that a new supplier could secure a market share equivalent to the average share held by the top 10 largest suppliers in this market over the past 12 months: The potential supply in dollars per month for a new player, according to Component 1, is calculated by multiplying the following factors: Average monthly volume of imports into the country in tons × Average monthly increase in imports over the last 24 months (month-on-month growth) × Average market share for the top 10 supplying countries × Average import price over the last 12 months Component 1 could be zero in the event of a negative short-term trend in imports of the specified product into the country over the past 24 months.

2. **Component 2** signifies the extra potential supply linked to the potential strong competitive advantage of the new supplier. Its calculation is based on the factual parameters of supplying countries that have experienced the highest growth in their supplies to the chosen country over the past 12 months. The assumption is that this increase is attributed to their respective competitive advantages. The potential supply volume in dollars per month for a new player, based on Component 2, is calculated by dividing the average increase in imports in tons over the last 12 months compared to the previous 12 months for the top 5 countries that have most increased imports into the country by 12 months. The result is then multiplied by the average import price over the last 12 months.

The total increase is determined by summing the values obtained from the two components.
