POLAND'S IMPORTS FROM MOLDOVA



Focus on the 100 Key Imported Products







Scope of research

We identified top-100 largest value import items traded between Poland and Moldova in 2024, specifically focusing on Poland's imports from Moldova.

The analysis was based on the full database on the trade between the two countries (Poland's imports data, mirror data).

We divided these 100 products into segments:

- Champion-value traded goods (annual value of shipments of 690 K\$ 53 M\$);
- II. Rising Champion value traded goods (annual value of shipments of 50 K\$ -690 K\$).

We analyzed long-term and short-term evolution of trade of each group (in US\$ terms only, volume trade not analyzed): CAGR over 2017-2023, Growth Rates in 2024.

Methodology: At the end of each section, we ranked the traded items within each group based on three key indicators: Imports Value in 2024 (Absolute Import Size in \$-terms), CAGR over seven years (2017-2023) as indicator of a long-term growth trend, and y-o-y Growth Rate in 10M 2024 as indicator of short-term performance. All indicators were assigned an equal weight on a 10-point scale, and the total score was calculated as the sum of these three values. The highest-scoring categories are identified as the most promising goods for supply to the Poland's market from Moldova, while those with the lowest scores are considered the most risky.

Notes: use of n/a designation: In 2022, the Harmonized System underwent significant revisions, including the introduction of new commodity items. The "n/a" designation is used for imports values of goods that were previously classified under different HS codes before 2022.

Data sources: UN Comtrade databases processed by GTAIC Intelligence Platform.

Data on trade in volume metrics (tons, kilos, and other) and prices are not analyzed in this research. However, they can be analyzed under a separate request.

Upon results of the analyses of the top-100 largest value import items traded between Poland and Moldova in 2024, we identified the most promising positions supplied from Moldova to Poland across various product groups:

- I. Within the Champion-Value Segment (annual value of shipments of 690 K\$ 53 M\$) the most promising positions include: 1) Grapes, fresh; 2) Insulated ignition wiring sets and other wiring sets for vehicles, aircraft and ships; 3) Apple juice, others, not fortified with vitamins or minerals, unfermented, not containing added spirit; 4) Footwear, with outer soles of rubber, plastics or composition leather and uppers of leather others, covering the ankle; 5) Electric conductors, for a voltage not exceeding 1000 v, fitted with connectors, others; 6) Plums, prune plums and sloes, fresh; 7) Apricots, fresh; 8) Bars and rods of iron or nonalloy steel, not further worked than hot-rolled, hot-drawn or hot-extruded; 9) Wine of fresh grapes (other than sparkling wine) and grape must with fermentation prevented, etc. by adding alcohol, containers >10 liters; 10) Bars and rods, hot-rolled, in irregularly wound coils, of iron or nonalloy steel, of circular cross-section measuring less than 14mm in diameter, others.
- II. In the Rising Champion Value Segment (annual value of shipments of 50 K\$ 690 K\$) the most promising positions remain: 1) Glass fibers and articles thereof others; 2) Carpets and other textile floor coverings, woven, not tufted or flocked, others, of pile construction, made-up, of wool or fine animal hair; 3) Apples, dried; 4) Flaxseed (linseed), whether or not broken; 5) Reservoirs, tanks, casks, vats and similar containers others, of a capacity of more than 300 liters (79.25 gal.), of iron or steel; 6) Fermented beverages, others (incl cider, perry & mead); mixtures of fermented beverages & non-alcohol beverage others; 7) T-shirts, singlets, tank tops and similar garments of cotton, knitted or crocheted; 8) Women's or girls' swimwear of synthetic fibers, knitted or crocheted; 9) Sweaters, pullovers, sweatshirts, waistcoats (vests), and similar articles knitted or crocheted, of wool; 10) Nonalcoholic beverages, others (including milk-based drinks).



Summary

Notably, Moldova holds significant market share in Poland's markets of 1) Apple juice (others, not unfermented), 2) Plums, prune plums and sloes, fresh, 3) Sunflower seeds (whether or not broken) and 4) Apricots (fresh) in 2024. Moldova accounted for over 37% of Poland's apple juice imports, nearly 26% of Poland's plum and prune plum imports, 13% of Poland's sunflower seed imports and almost 10% of Poland's apricot imports:

Snapshot of Poland's Imports from Moldova




Poland's Imports from Moldova in 2017 – 2024



- ➤ Over the long term (2017–2024), the compounded annual growth rate (CAGR) of Poland's imports from Moldova has been +5.02% with the most notable surge occurring in 2021, when Poland's imports from Moldova rose by over 70% year-on-year.
- ➤ In 2023, Poland's imports from Moldova reached \$226.45 million, marking a notable decrease of 23.65% from \$296.57 million in 2022.
- In 2024, the value of imports totaled \$181.94 million, showing a significant -19.66% year-on-year decline.
- ➤ The analysis covers the top 100 imported products by value in 2024, categorized into four groups: the 1st Group – Top 25 (with the yearly imports value of 690 K\$ – 53 M\$ in 2024), the 2nd group (early trade value of 50 K\$ – 690 K\$),
- For each group, we identify the products that have shown sustained and significant import growth from Moldova, focusing on both long-term (2017 2024) and shorth-term (2023 2024) growth trends.

The **top-25 highest-value** product categories (6-digit HS classification) account for approximately **90.8**% of Poland's imports from Moldova reaching **\$181.94 million** in 2024. The Top 25 product groups are dominated by the following categories:

- > Fruit, Berry, and Fruit-Based Beverage Products: Amounting to \$91.95 million in 2024, accounting for 50.54% of Poland's imports from Moldova:
 - Apple juice, others, not fortified with vitamins or minerals, unfermented, not containing added spirit, whether or not sweetened
 - Grapes, fresh
 - Plums, prune plums and sloes, fresh
 - Wine of fresh grapes (other than sparkling wine) and grape must with fermentation prevented, etc. by adding alcohol, containers of not over 2 liters
 - Wine of fresh grapes (other than sparkling wine) and grape must with fermentation prevented, etc. by adding alcohol, containers holding over 10 liters
 - Apricots, fresh
 - > Raspberries, blackberries, mulberries and loganberries, fresh
 - Prunes, dried
 - Cherries, fresh, other than sour
- Metallurgical Products: These products accounted for \$32.30 million, representing 17.76% of total imports:
 - > Bars and rods, hot-rolled, in irregularly wound coils, of iron or nonalloy steel, of circular cross-section measuring less than 14mm in diameter, others
 - > Tubes, pipes and hollow profiles, of iron or steel, welded, of a square or rectangular cross-section, others
 - Bars and rods of iron or nonalloy steel, hot-worked others, concrete reinforcing
 - > Bars and rods of iron or nonalloy steel, not further worked than hot-rolled, hot-drawn or hot-extruded, but including twisted after rolling, n.e.s.o.i
 - Waste and scrap of precious metal, others
- Footwear and Fabrics: These products reached \$5.37 million, accounting for 2.95% of total Poland's imports from Moldova:
 - Footwear, with outer soles of rubber, plastics or composition leather and uppers of leather others, not covering the ankle
 - Footwear, with outer soles of rubber, plastics or composition leather and uppers of leather others, covering the ankle
 - Woven fabrics of cotton, 85% or more cotton by weight, bleached, plain weave, weighing over 100 g/m2 but not over 200 g/m2
- Other Product Categories worth \$35.57 million accounting for 19.55% of total Poland's imports from Moldova and including: Parts of Motor Vehicles, Electric Conductors, Sunflower Seeds, Carpets, Chocolate.




Dynamics of Changes in the Structure of Poland's Imports from Moldova

- During 2017 2024 the share of the top-25 categories steadily increased from 69% in 2017 to 91% in 2024, highlighting a growing concentration in key import positions.
- From 2017 to 2024, two product categories 1) apple juice (others, not fortified with vitamins or minerals, unfermented, not containing added spirit, whether or not sweetened) and 2) Bars and rods, (hot-rolled, in irregularly wound coils, of iron or nonalloy steel, of circular cross-section measuring less than 14mm in diameter, others) consistently held the leading positions in the import structure.
- In 2024, the category of Fresh Grapes has emerged as the third-largest import category, with imports value reaching \$15.63 million in 2024.
- The further analysis covers the import value dynamics of the 5 fastest growing and 5 most decreasing import positions, providing insights into shifting trade patterns and the evolving composition of Poland's import structure from Moldova.



Most Growing and Declining Import Positions within Champion-Value Segment

Out of the positions of the 1st group, two positions – 1) Raspberries, blackberries, mulberries and loganberries (fresh) and 2) Grapes (fresh) – have shown significant increases in imports values across all the periods considered (in 2024 and 2017 – 2024).

Notably, 1) Ethyl alcohol, undenatured (of an alcoholic strength by volume of 80% vol. or higher) and 2) Bars and rods of iron or nonalloy steel (hot-worked others, concrete reinforcing) are characterized by notable declines in the same periods (in 2024 and 2017 – 2024).


