Turkey's Imports from Kyrgyzstan

A Focus on the 50 Key Imported Products



Date of Report generation: 14 April 2025

Scope of Research

We identified the top-50 largest value import items traded between Turkey and Kyrgyzstan in 2024, specifically focusing on Turkey's imports from Kyrgyzstan.

The analysis was based on the full database on the trade between the two countries (Turkey's imports data, mirror data).

We divided these 50 products into segments:

- I. Traded goods until 2024 (inclusive);
- II. Newly Traded Goods starting in 2024.

For the traded goods until 2024, we analyzed both long-term and short-term evolution of trade (in US\$ terms only, volume trade not analyzed): CAGR over 2017-2024, Growth Rates in 2024.

Furthermore, the analysis highlights manufacturing sector goods that experienced substantial growth in imports values from Kyrgyzstan to Turkey in 2024.

Notes: use of n/a designation: In 2022, the Harmonized System underwent significant revisions, including the introduction of new commodity items. The "n/a" designation is used for imports values of goods that were previously classified under different HS codes before 2022.

The section of Newly Traded Goods starting 2024 includes an analysis of short-term trade dynamics, including Growth Rates in 2024, as well as Kyrgyzstan's share in Turkey's commodity markets.

Data sources: UN Comtrade databases processed by GTAIC Intelligence Platform.

Data on trade in volume metrics (tons, kilos, and other) and prices are not analyzed in this research. However, they can be analyzed under a separate request.

This research was prepared as of 14th of April 2025.

O Executive Summary

Executive Summary

Over the long term (2017–2023), the compounded annual growth rate (CAGR) of Turkey's imports from Kyrgyzstan has been +8.46%, with the most notable surge occurring in 2023, when Turkey's imports from Kyrgyzstan rose by 129% year-on-year and reached \$273.95 million.

Prior to that, imports grew steadily from \$64.03 million in 2018 to \$119.55 million in 2022. However, in 2024, the value of imports declined sharply to \$167.57 million, showing a notable -38.83% year-on-year decrease.

The analysis reveals that agricultural products remain one of the most promising positions for the expansion of Kyrgyzstan's trade with Turkey. In 2024, the total value of Turkey's imports of plant products from Kyrgyzstan amounted to \$18.92 million, reflecting a 11.13% year-on-year decline. Despite this moderate decrease, the plant product group has demonstrated remarkable stability over the 2017–2024 period. Unlike energy-related goods—which tend to be imported sporadically—agricultural products maintain a steady market presence and are less susceptible to external shocks.

Energy products dominate Kyrgyzstan's export structure to Turkey in value terms, totaling \$108.63 million, or 64.83% of total imports. However, this category has shown high levels of fluctuation. For instance, imports of petroleum oils, oils from bituminous minerals (other than crude) reached \$14.32 million in 2022, fell to \$2.59 million in 2023, and then exceeded \$78 million in 2024. Similarly, imports of bituminous coal (whether or not pulverized, but not agglomerated) totaled \$161.20 million in 2023, but dropped sharply to \$19.73 million in 2024.

Executive Summary

Agricultural products have solidified their position as second-largest export product group from Kyrgyzstan to Turkey, following energy commodities, reaching \$22.56 million in 2024.

This sector stands out as a promising area for expansion, particularly given its strong foundation among small enterprises and the notable market share Kyrgyzstan holds in Turkey's agricultural imports. Beyond plant products, exports of animal products from Kyrgyzstan have shown robust expansion, marking a 31.71% year-on-year increase in 2024.

Recommendations:

- 1. Strengthen agri-export value chains to improve reliability and consistency of supply.
- 2. Search for buyers in the Turkey's market, especially for high-demand agricultural goods.
- 3.Expand market reach beyond Turkey, targeting countries with strong demand for Kyrgyzstan's core agriexports, for instance, expanding kidney bean exports to Italy and India—the world's 2nd and 3rd largest global importers of these products.

Executive Summary

In the analysis of **the top-50 largest value import items** traded between Turkey and Kyrgyzstan in 2024, several manufacturing sector goods were identified within each product group that experienced substantial growth in imports value from Kyrgyzstan to Turkey:

- **I.** Traded Goods until 2024: the list of such imports positions includes: 1) Polyethylene having a specific gravity of 0.94 or more, in primary forms; 2) Artificial waxes and prepared waxes, others; 3) Tube or pipe fittings of copper alloys; 4) Cartridges and parts thereof, others.
- **II. Traded Goods starting in 2024** the positions are following: 1) Looped pile fabrics, knitted or crocheted, of cotton; 2) Looped pile fabrics, knitted or crocheted, of manmade fibers; 3) Parts of centrifuges, including Centrifugal Dryers; 4) Inorganic bases; other metal oxides, hydroxides and peroxides, others.



- Over the long term (2017–2023), the compounded annual growth rate (CAGR) of Turkey's imports from Kyrgyzstan has been +8.46%, with the most notable surge occurring in 2023, when Turkey's imports from Kyrgyzstan rose by 129% year-on-year and reached \$273.95 million.
- ➤ Before 2023, imports grew steadily from \$64.03 million in 2018 to \$119.55 million in 2022.
- In 2024, the value of imports totaled \$167.57 million, showing a notable -38.83% year-on-year decline.
- The analysis covers the top 50 imported products by value in 2024 (annual value of shipments of 50 K\$ 78 M\$), categorized into two groups: the 1st Group Traded goods until 2024 (inclusive), the 2nd group Newly Traded Goods starting in 2024.
- For the traded goods until 2024, we identify the products that have shown sustained and significant import growth from Kyrgyzstan, focusing on both long-term (2017–2024) and shorth-term (2023–2024) growth trends. The section of Newly Traded Goods starting 2024 includes an analysis of short-term trade dynamics, including Growth Rates in 2024, as well as Kyrgyzstan's share in Turkey's commodity markets.



Dynamics of Changes in the Structure of Turkey's Imports from Kyrgyzstan



From 2017 to 2024, imports of Cotton and Kidney Beans experienced significant declines: the supplies of Cotton fell from \$13.95 million in 2017 to \$7.27 million in 2024, the supplies of Kidney Beans dropped from \$17.08 million in 2017 to \$7.27 million in 2024.

Beginning in 2022, Turkey started importing Petroleum Oils (other than crude) and Anthracite Coal from Kyrgyzstan, with imports value of these commodities reaching \$78.03 million and \$10.87 million, respectively, In addition, since 2023, Turkey began importing another type of energy products from Kyrgyzstan – Bituminous coal. Between 2023 and 2024, two categories – 1) **Petroleum Oils (other than crude)** and 2) **Bituminous Coal** emerged as the leading import positions: the **Petroleum Oils (other than crude)** category ranked as the first largest import position in 2024, while the **Bituminous Coal category**, held the N1 import position in 2023.

Traded goods until 2024 (inclusive)

... exceed 92% of total Turkey's imports from Kyrgyzstan

The **group** of traded goods until 2024 represents approximately **92.66**% of Turkey's imports from Kyrgyzstan reaching **\$155.28 million** in 2024.

This group is dominated by the following categories:

- Energy Products: Amounting to \$108.63 million in 2024, accounting for 64.83% of Turkey's imports from Kyrgyzstan:
 - Petroleum oils, oils from bituminous minerals (other than crude) & products containing by weight Gt=70% or more of these oils, not biodiesel or waste

 - Walnuts, fresh or dried, shelled
 - Walnuts, fresh or dried, In shell
 - Pistachios, shelled, fresh or dried
 - > Pistachios, in shell, fresh or dried
 - Sunflower seeds, whether or not broken
 - Apples, dried
 - Apricots, dried
 - Vegetables, others, and mixtures of vegetables, provisionally preserved, but unsuitable in that state for immediate consumption
- Precious Metals: These products reached over \$2.41 million, accounting for 1.44% of total Turkey's imports from Kyrgyzstan.
 - ➤ Gold, nonmonetary, unwrought others (other than powder)
 - Silver, unwrought others (other than powder)
- Other Product Categories worth \$25.32 million accounting for 15.11% of total Turkey's imports from Kyrgyzstan and including: Aluminum and Aluminum Scrap, Copper Articles, Fabrics, Cartridges And Parts Thereof, Animal Products, Food Preparations, Parts of Aeroplanes or Unmanned Aircraft.






Polyethylene (gravity > 0.94) Market in Turkey: Share of Kyrgyzstan supplies








Average Monthly Prices on Imports in 2024, \$ / ton







Artificial Wax Market in Turkey: Share of Kyrgyzstan supplies



Copper Alloy Pipe Fitting Market in Turkey: Share of Kyrgyzstan supplies




Top-10 Suppliers Showing Decline: Growth in 2024 (K\$)






Centrifuge Parts Market in Turkey: Share of supplies from Kyrgyzstan








Average Monthly Prices on Imports in 2024, \$ / ton










Top-6 Suppliers Showing Decline: Growth in 2024 (K\$)
