

UAE Imports from Germany

A Focus on the 500 Key Imported Products



Scope of research

We identified **top-500 largest value import items** traded between the United Arab Emirates and Germany in 2024, specifically focusing on **the UAE imports from Germany**.

The analysis was based on the full database on the trade between the two countries (Germany's exports data, mirror data).

We divided these 500 products into segments:

- I. **Largest-value traded goods** (annual value of shipments of 56 M\$ – 815 M\$);
- II. **Champion-value traded goods** (annual value of shipments of 18 M\$ – 56 M\$);
- III. **Rising Champion value traded goods** (annual value of shipments of 10 M\$ – 18 M\$);
- IV. **Latent Champion value traded goods** (annual value of shipments of 6 M\$ – 10 M\$);
- V. **Low-value traded goods – niche products** (annual value of shipments of 3 M\$ – 6 M\$).

We analyzed long-term and short-term evolution of trade of each group (in US\$ terms only, volume trade not analyzed): CAGR over 2017-2024, Growth Rates in 2024.

Methodology: At the end of each section, we ranked the traded items within each group based on three key indicators: **Imports Value in 2024 (Absolute Import Size in \$-terms)**, **CAGR over seven years (2017-2023) as indicator of a long-term growth trend**, and **y-o-y Growth Rate in 2024 as indicator of short-term performance**. All indicators were assigned an equal weight **on a 10-point scale**, and the total score was calculated as the sum of these three values. The highest-scoring categories are identified as the most promising goods for supply to the UAE market from Germany, while those with the lowest scores are considered the most risky.

Data sources: UN Comtrade databases processed by GTAIC Intelligence Platform.

Data on trade in volume metrics (tons, kilos, and other) and prices are not analyzed in this research. However, they can be analyzed under a separate request.

This research was prepared as of 25th of March 2025.

Summary

Upon results of the analyses of **the top-500 largest value import items** traded between the United Arab Emirates and Germany in 2024, we identified **the most promising positions supplied from Germany to the United Arab Emirates across various product groups:**

- I. In the Largest-Value Segment** (annual value of shipments of 56 M\$ – 815 M\$), the most promising positions are: 1) Line pipe for oil, gas pipelines, of iron or steel; 2) Motor vehicles with sparking and electric motor; 3) Passenger motor vehicles with reciprocating piston engine, (1,500– 3,000 cc); 4) Waste and scrap of gold; 5) Passenger motor vehicles with reciprocating piston engine, over 3,000 cc.
- II. Within the Champion-Value Segment** (annual value of shipments of 18 M\$ –56 M\$) the most promising positions include: 1) Pneumatic elevators and conveyors; 2) AC motors others, multi-phase, of an output exceeding 75 kw; 3) Medicaments, containing hormones, in measured doses; 4) Food preparations; 4) Heat exchange units; 5) Gears and gearing, ball or roller screws; gear boxes and other speed changers; 6) Vacuum cleaners with self-contained electric motor, of a power $I_t=1500$ w; 7) Mixtures of odoriferous substances and mixtures based on one or more of these substances used as raw materials; 8) Electrothermic hairdressing apparatus other than hair dryers.
- III. In the Rising Champion Value Segment** (annual value of shipments of 10 M\$ – 18 M\$), the most promising positions remain: 1) Laboratory equipment for the treatment of material involving temperature change; 2) Jewelry and parts thereof, of silver; 3) Smoking tobacco, whether or not containing tobacco substitutes; 4) Vehicles (other than trailers and semi-trailers), not mechanically propelled; 5) Footwear, with outer soles of rubber, plastics or composition leather; 6) Tubes, pipes and hoses, rigid, of polymers of vinyl chloride; 7) Parts for boring or sinking machinery; 8) Machinery for working rubber or plastics.
- IV. In the Latent Champion Value Segment** (annual value of shipments of 6 M\$ – 10 M\$), the most promising positions are: 1) Electric hair dryers; 2) AC motors others, multi-phase, of an output not exceeding 750 w; 3) Machines for mixing or kneading earth, stone, ore or other mineral substances; 4) Trunks, suitcases, vanity cases and similar containers; 5) Lithium-ion batteries; 6) Microphones; 7) Turbojets of a thrust exceeding 25 kn; 8) Refractory bricks, blocks, tiles.
- V. Among the Low-Value Segment goods** (niche products, annual value of shipments of 3 M\$ – 6 M\$), the most promising positions include: 1) Cyclic hydrocarbons; 2) Dog and cat food; 3) Trailers and semi-trailers for the transport of goods; 4) Breathing appliances and gas masks; 5) Parts of electrical lighting or signaling equipment, windshield wipers, defrosters and demisters; 6) Mountings, fittings and similar articles, of base metal; 7) Pipe or tube fittings, stainless steel flanges; 8) Dishwashing machines.

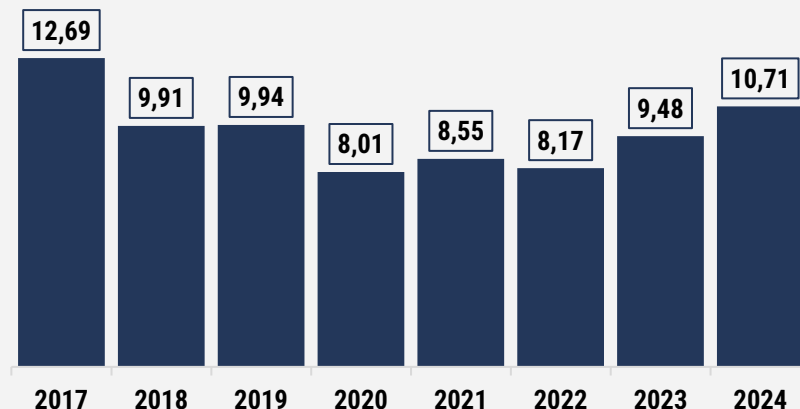

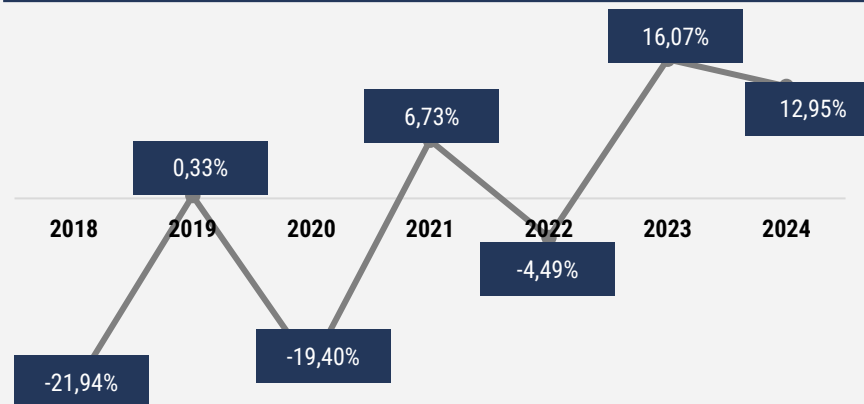

- In the long-term (2017–2024), UAE imports from Germany have shown a negative trend, decreasing from \$12.69 billion in 2017 to \$10.71 billion in 2024.
- From 2017 to 2024, the compounded annual growth rate (CAGR) of the United Arab Emirates' imports from Germany has been -2.10%, with the most notable declines occurring in 2018 and 2020, when the UAE imports from Germany fell by more than 19% year-on-year.
- Since 2023, the UAE imports from Germany started to recover, gradually growing from \$8.17 billion in 2022 to \$10.71 billion in 2024.
- The analysis covers the top 500 imported products by value in 2024, categorized into four groups: the 1st Group – Top 25 (with the yearly imports value of 56 M\$ – 815 M\$ in 2024), the 2nd group – Top 26–116 (early trade value of 18 M\$ – 56 M\$), the 3rd group – Top 117-209 (10 M\$ – 18 M\$), the 4th – Top 210-300 (6 M\$ – 10 M\$), and the 5th – Top 301-500 (3 M\$ – 6 M\$).
- For each group, we identify the products that have shown sustained and significant import growth from Germany, focusing on both long-term (2017-2024) and shorth-term (2023-2024) growth trends trends.

The **top-25 highest-value** product categories (6-digit HS classification) account for approximately **36.26%** of the UAE imports from Germany reaching **3.88 B\$** in 2024.

The examples of categories within this group are presented below, along with their respective import values and shares of total imports:

- **Vehicles, Airplanes and their Parts: These products accounted for \$2.16 billion, representing over 20% of total imports:**
 - Passenger motor vehicles with spark-ignition internal combustion reciprocating piston engine, 1,500– 3,000 cc
 - Passenger motor vehicles with spark-ignition internal combustion reciprocating piston engine, over 3,000 cc
 - Passenger motor vehicles with spark-ignition internal combustion reciprocating piston engine, 1,000 – 1,500 cc
 - Passenger motor vehicles, with both internal combust and electric motor
 - Road tractors for semi-trailers
 - Motor vehicles with only electric motor
 - Motor vehicles for goods transport
 - Motor vehicles with spark-ig and electric motor
 - Parts of airplanes, n.e.c. in heading no. 8807
 - Parts for use with piston engines, others
- **Pharmaceutical Products and Medical Instruments: Amounting to \$440 million in 2024, accounting for 4.11% of the UAE imports from Germany:**
 - Medicaments, in measured doses
 - Immunological products
 - Instruments for medical science
- **Smartphones: These products reached \$254 million, accounting for 2.4% of total UAE imports from Germany.**
- **Other Product Categories worth \$1.03 billion accounting for 9.58% of total UAE imports from Germany and including: Gas Turbines and Their Parts, Line Pipe for Oil and Gas Pipelines, Electronic Appliances and Their Parts, Articles of Plastics, Goods under HS code 998888, Gold Scrap, and Cosmetics.**

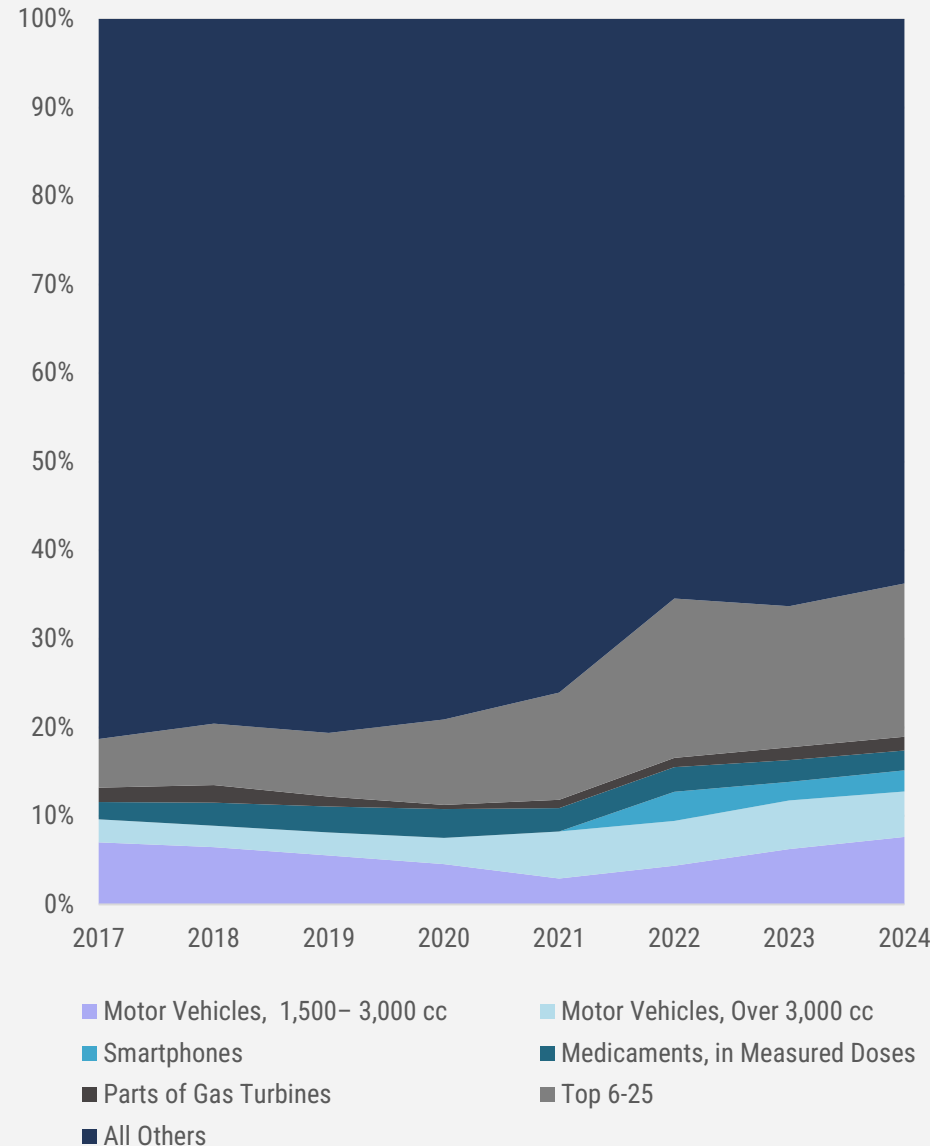

Top-5 Product Categories by Value in the Structure of UAE Imports from Germany (M\$)



- During 2017–2024 the share of the top-5 categories steadily increased from 13% in 2017 to 19% in 2024, highlighting a **growing concentration** in key import positions.
- Over the long-term (2017–2024), **Passenger motor vehicles with reciprocating piston engine (1,500– 3,000 cc)** remains the dominant category, with its share increasing from 6.99% in 2017 to 7.61% in 2024.
- Since 2021, **Passenger motor vehicles with reciprocating piston engine (over 3,000 cc)** emerged as the second-largest import category, with imports value reaching \$552 million – double the import value of **Smartphones** (\$254 million), which ranked third.
- The further analysis covers the import value dynamics of the 5 fastest growing and 5 most decreasing import positions, providing insights into shifting trade patterns and the evolving composition of UAE import structure from Germany.

Most Growing and Declining Import Positions within Largest-value Segment

Among the top-25 product positions, **Line pipe for oil, gas pipelines (of iron or steel)**, as well as **Motor Vehicles with Sparkling and Electric Motor**, have shown a significant increase in imports values across all the periods considered (in 2024 and 2017 – 2024).

This two categories are the most promising import positions, with an imports value of **78– 155 M\$** in 2024 and experiencing rapid import growth in reviewed periods.

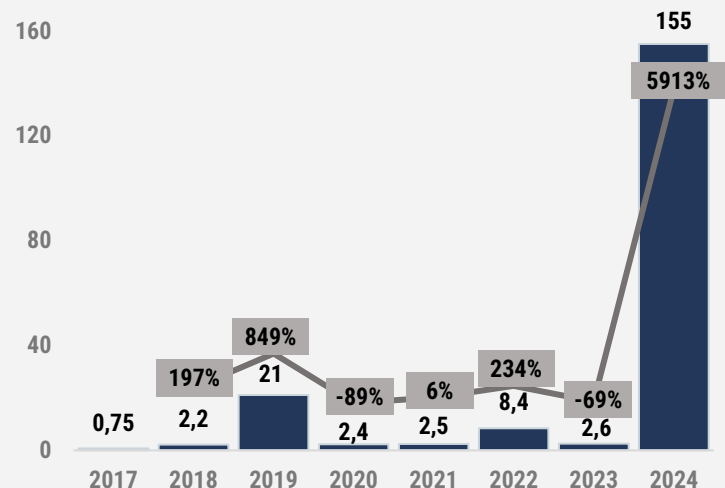

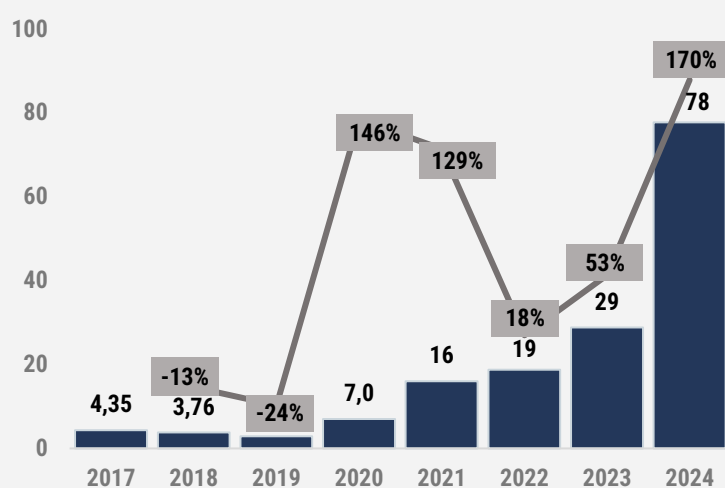

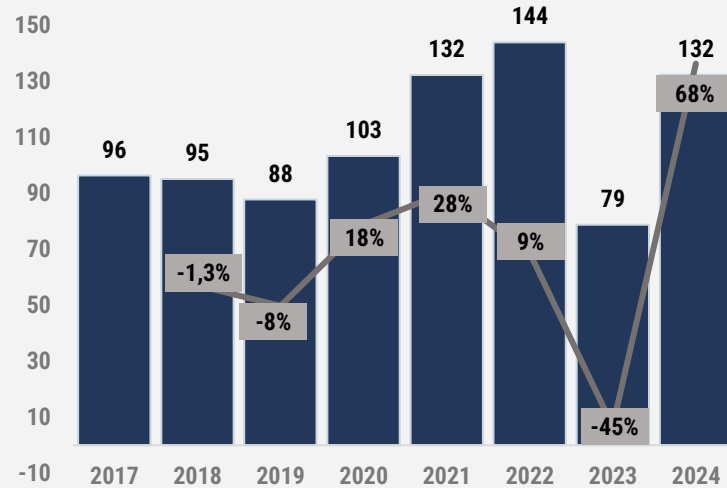

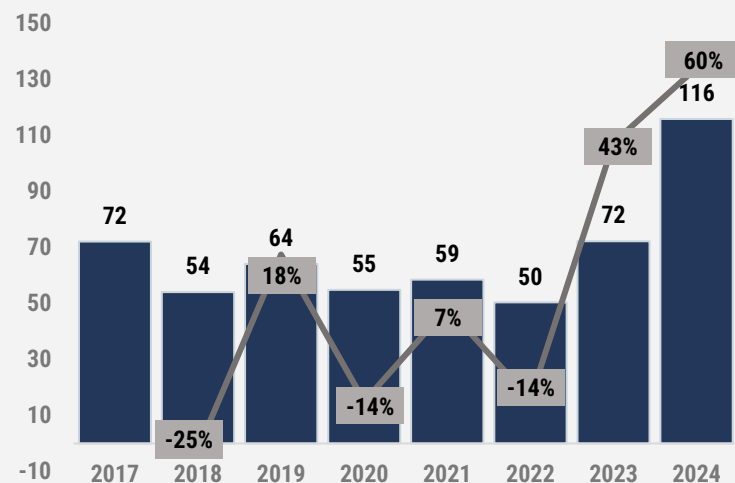
Imports Value of Motor Vehicles with sparking and electric motor, M\$



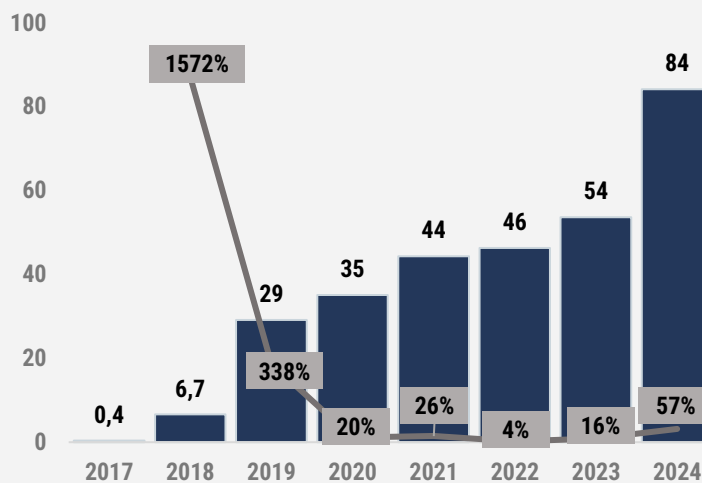
Imports Value of Immunological Products, M\$



Imports Value of Boards, Panels, Consoles, M\$

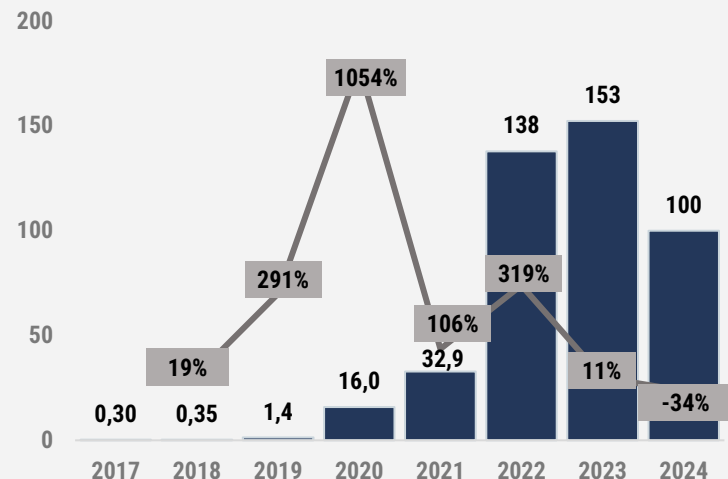


Imports Value of Waste and Scrap Of Gold, M\$

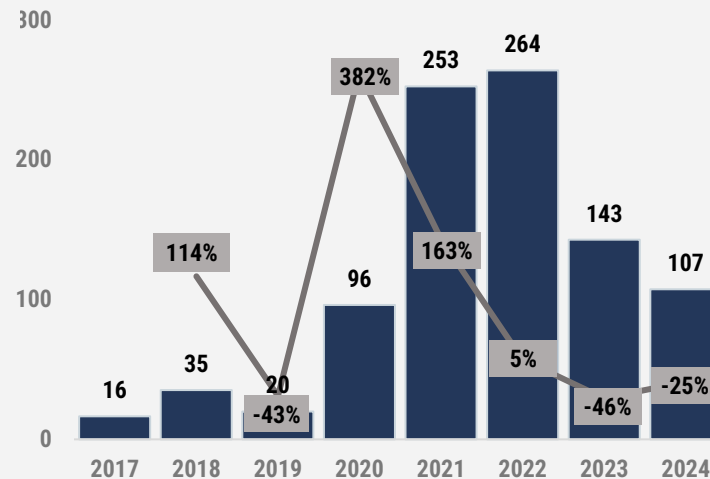


Top-5 Positions with the Highest **Decrease** of Imports in Short-term

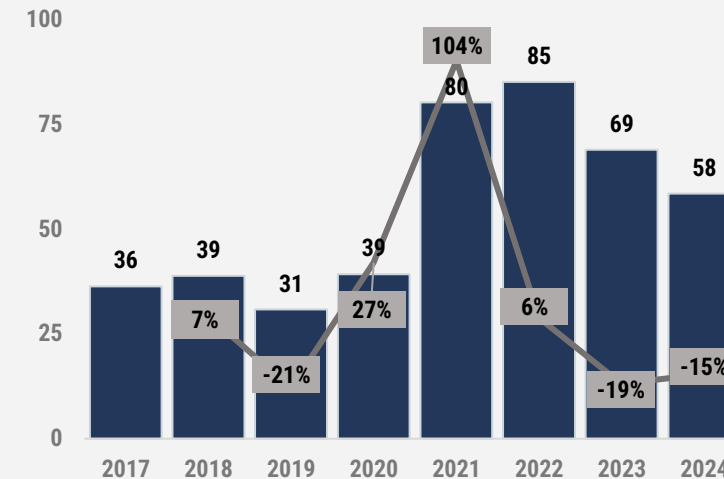

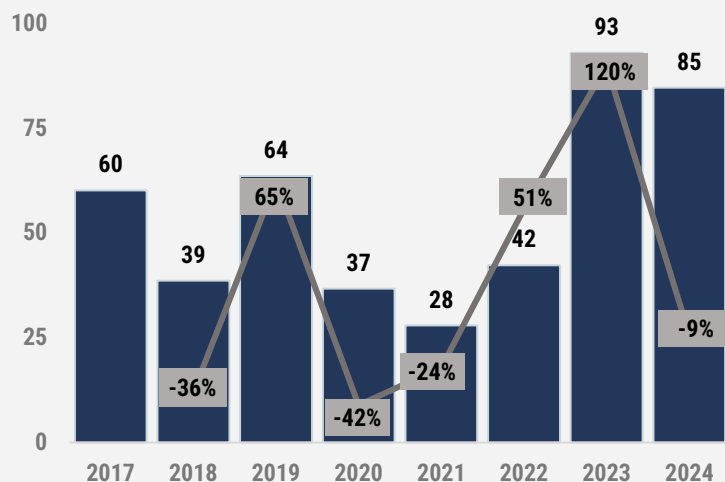
Imports Value of Motor vehicles, with combust and electric motor, M\$



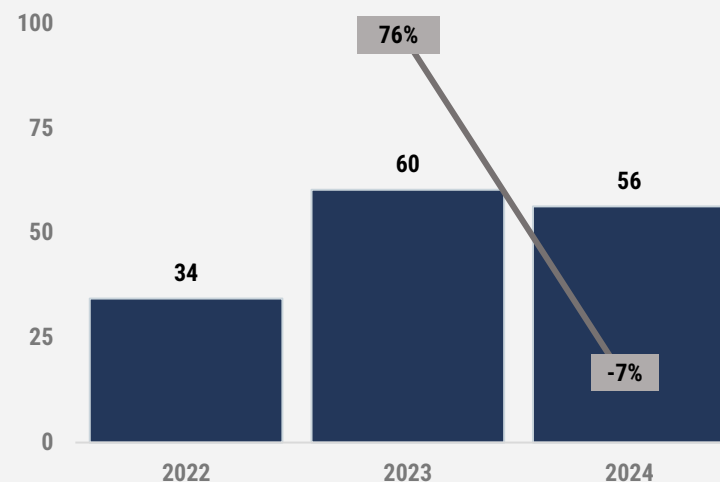
Imports Value Of Beauty or Make-up Preparations, M\$



Imports Value of Motor Vehicles for goods transport, M\$

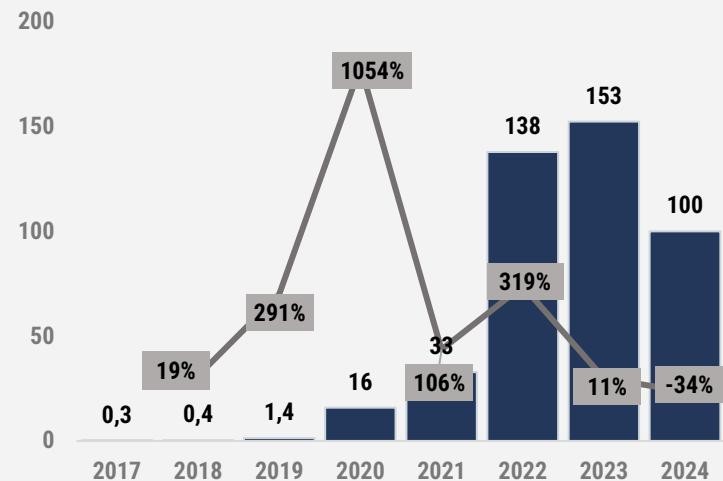


Imports Value of Reagents on a Backing (others), M\$

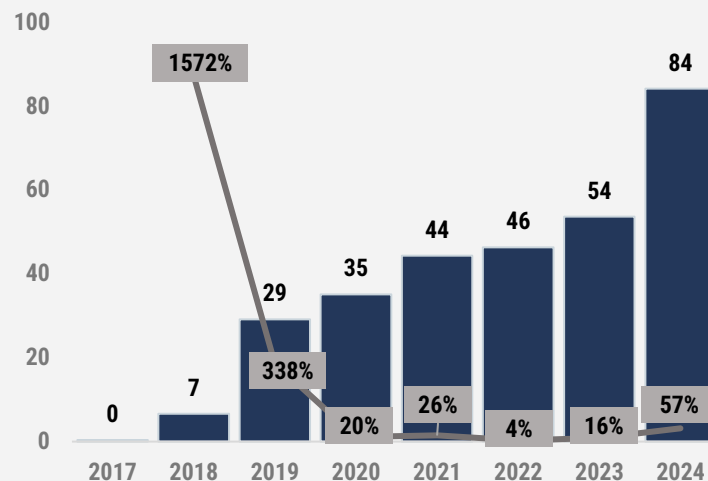


Top-5 Positions with the Highest Increase of Imports in Long-term, 2024

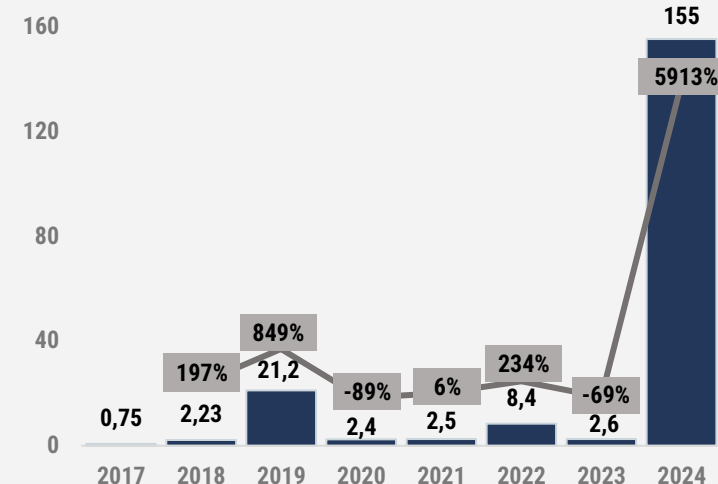

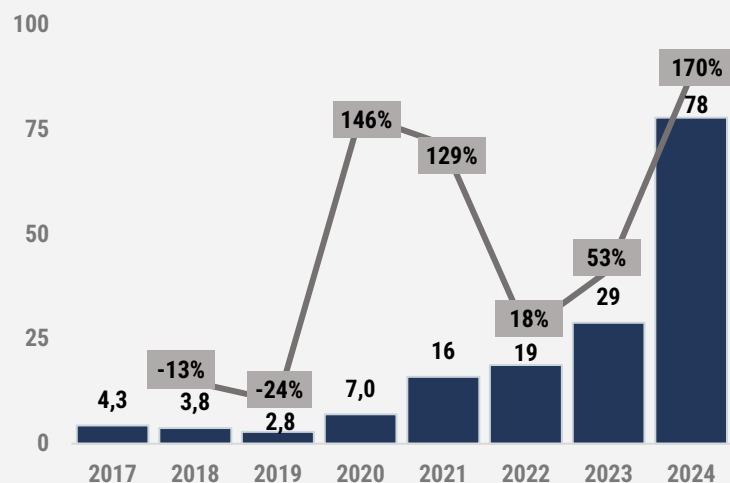
Imports Value of Waste and Scrap of Gold, M\$



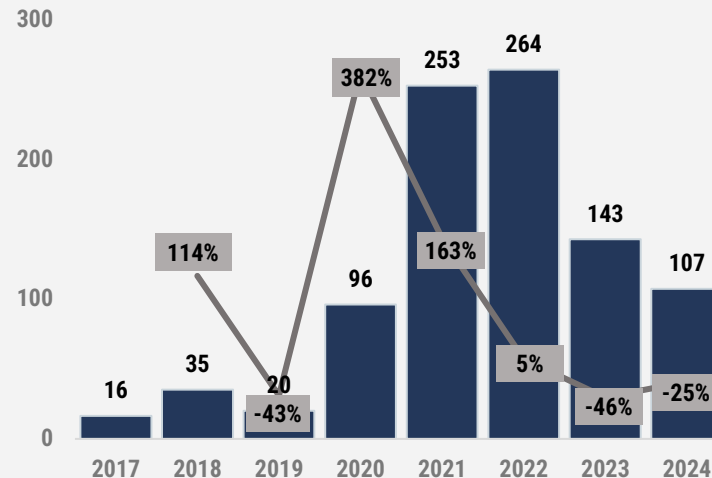
Imports Value of Line pipe for oil, gas pipelines (of iron or steel), M\$



Imports Value of Motor Vehicles with spark-ig and electric motor, M\$

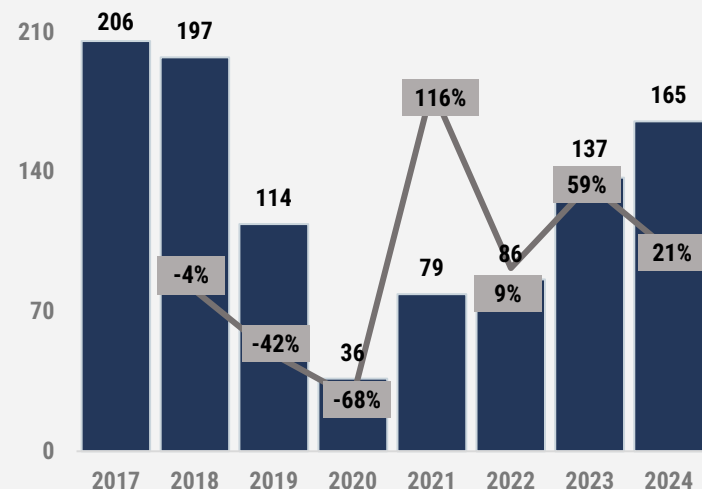


Imports Value of Motor Vehicles, with combust and electric motor, M\$

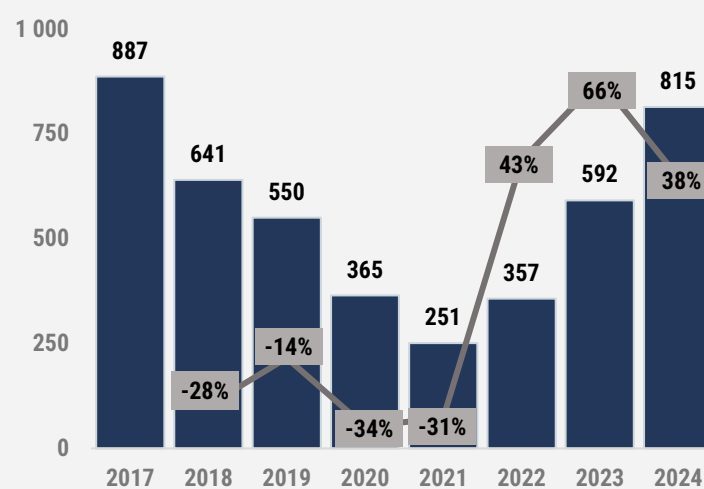

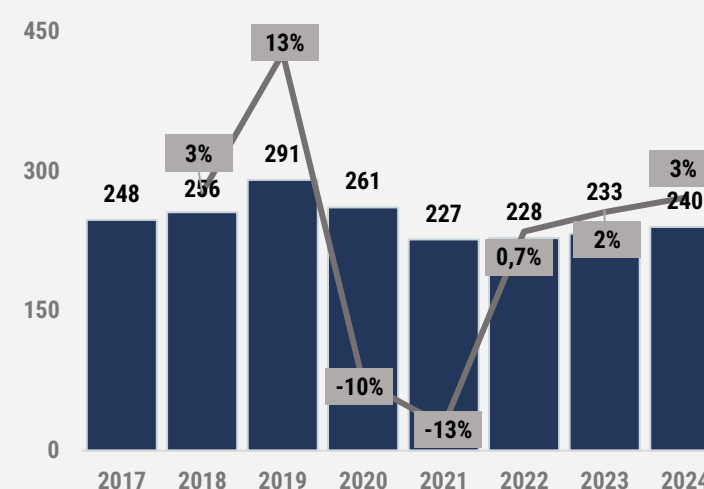
Imports Value of Parts of Gas Turbines, M\$

Imports Value of Medicaments, in measured doses, M\$

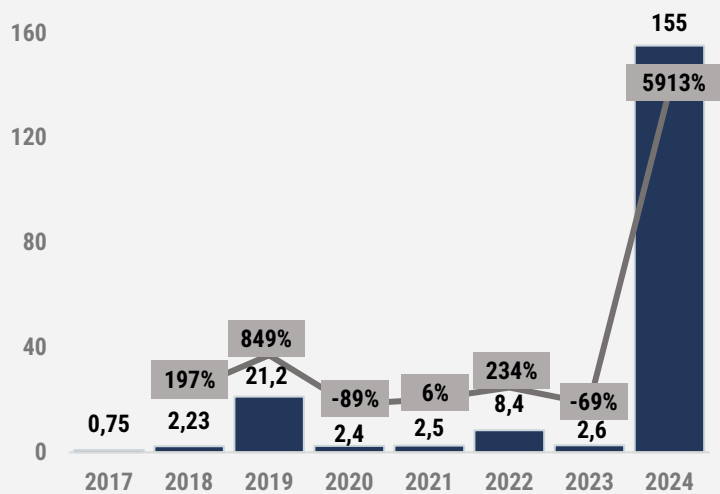

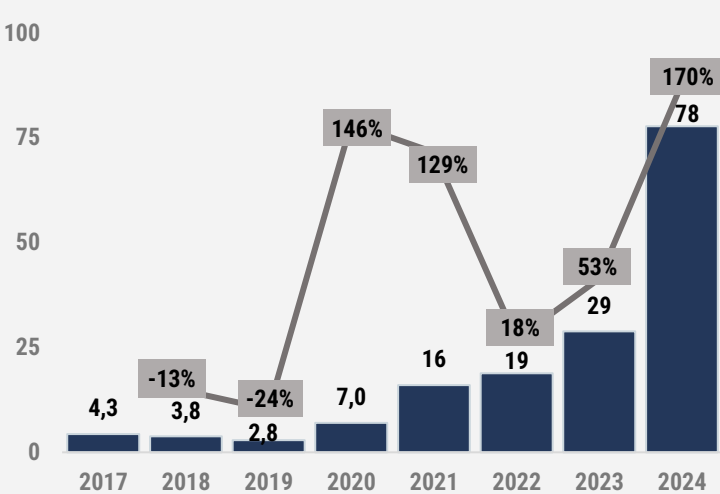

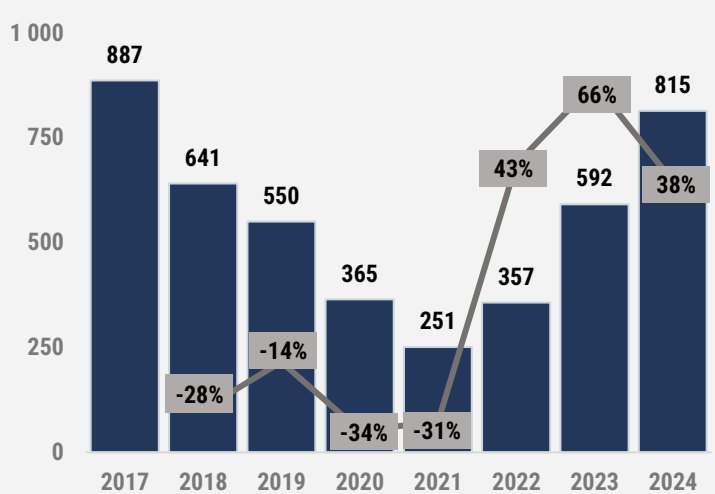
Imports Value of Line pipe for oil, gas pipelines (of iron or steel), M\$



Imports Value of Motor Vehicles with spark-ig and electric motor, M\$

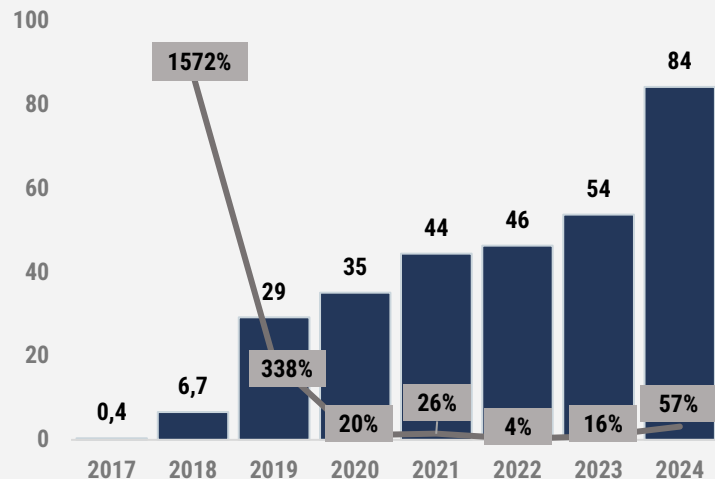


Imports Value of Motor Vehicles with piston engine, 1,500 – 3,000 cc M\$

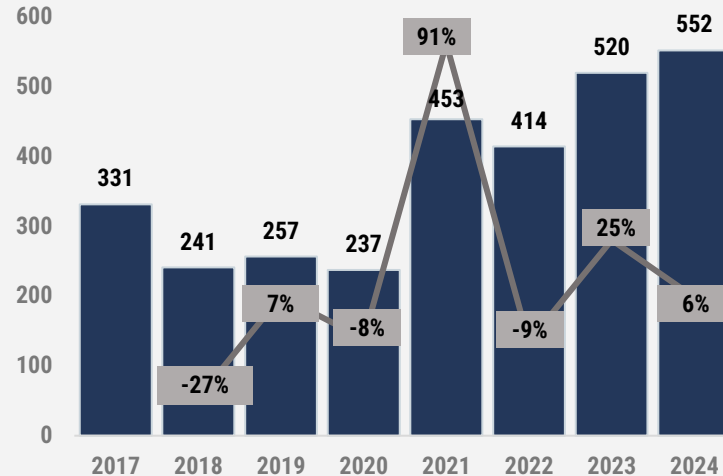

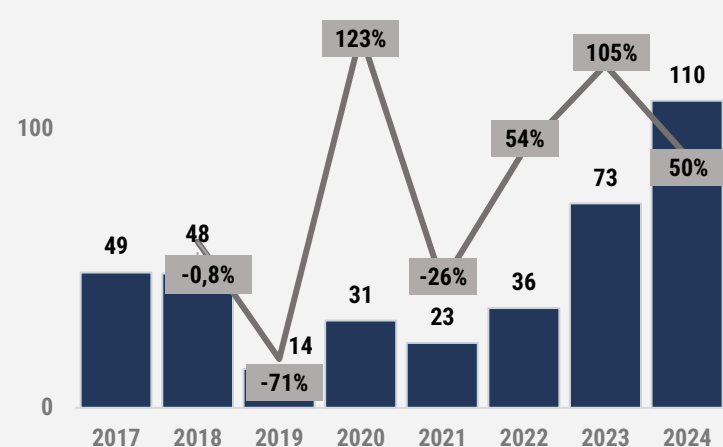

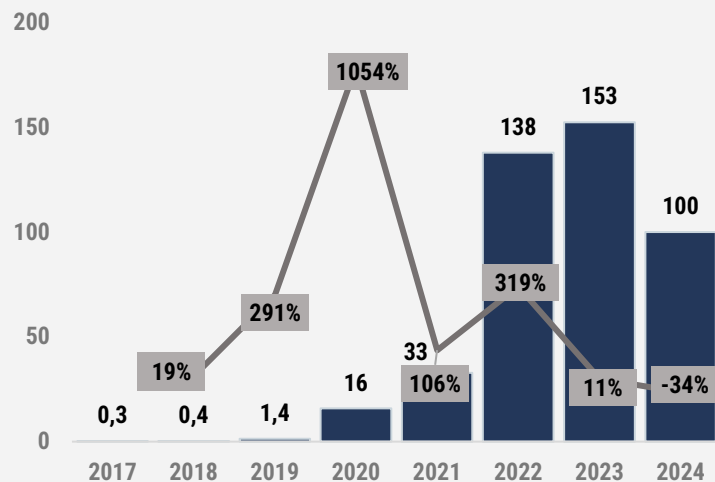
Imports Value of Motor Vehicles with piston engine, >3,000 cc, M\$



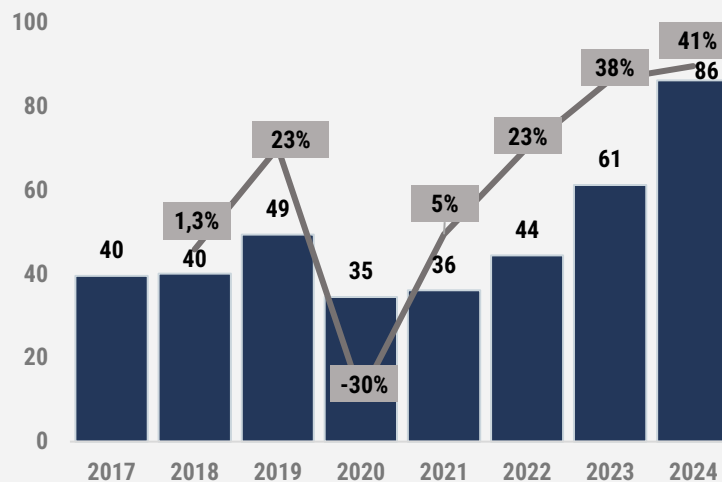
Imports Value of Vehicles with spark-ignition engine, 1000-1500 cc, M\$

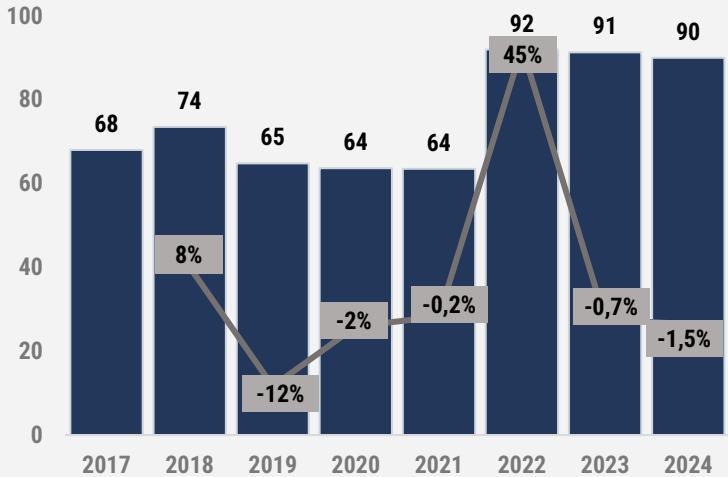

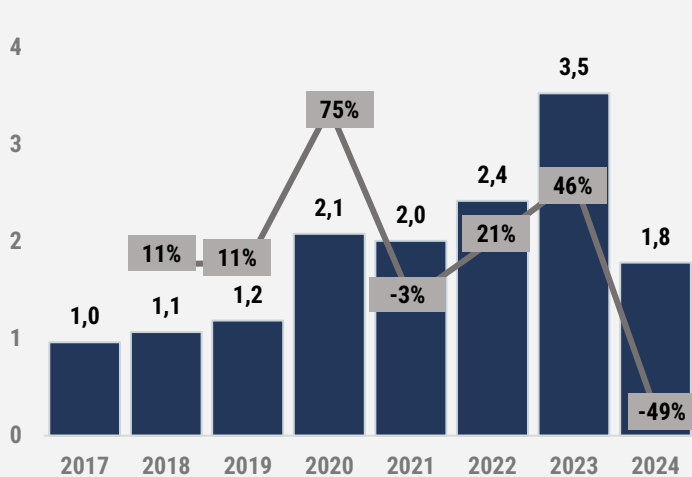

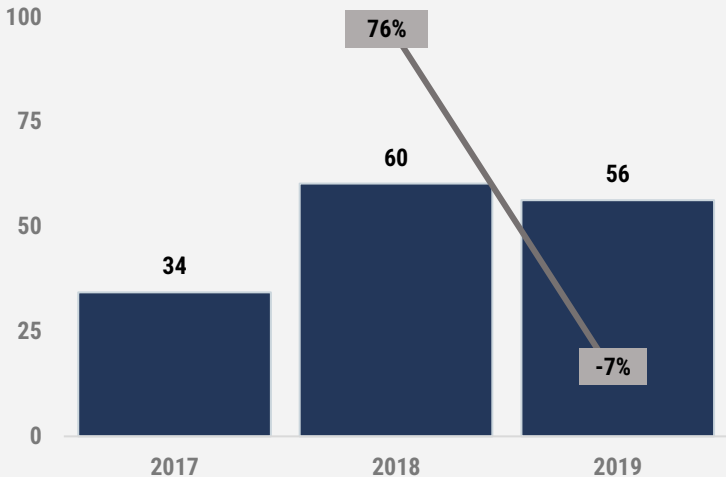

Imports Value of Parts of Printers, M\$

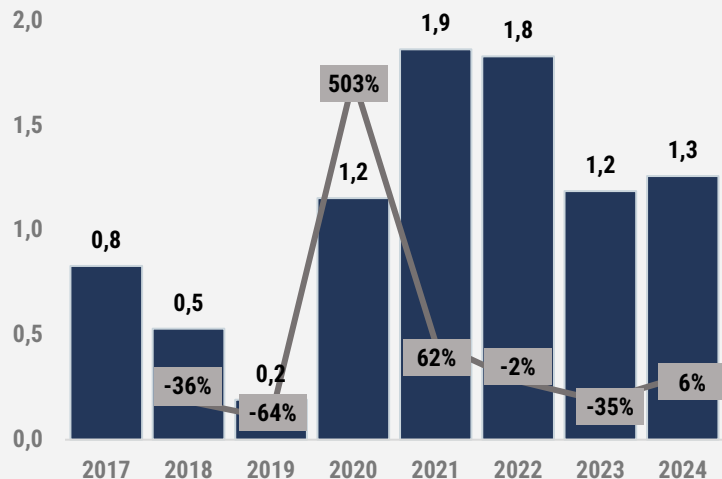


Imports Value of Reagents on a Backing (others), M\$

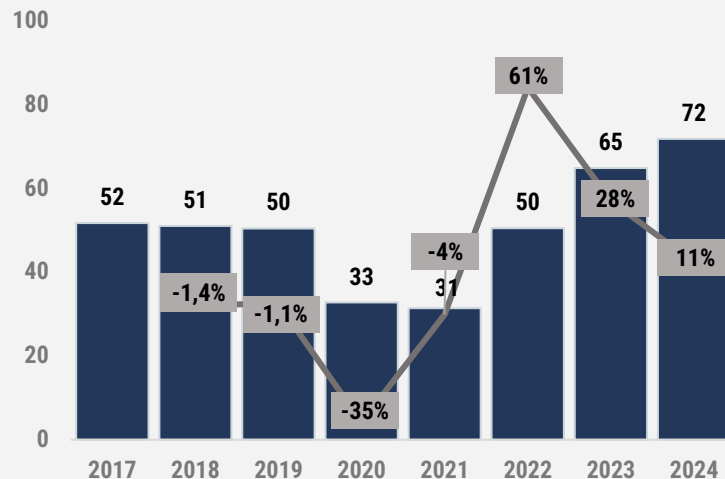

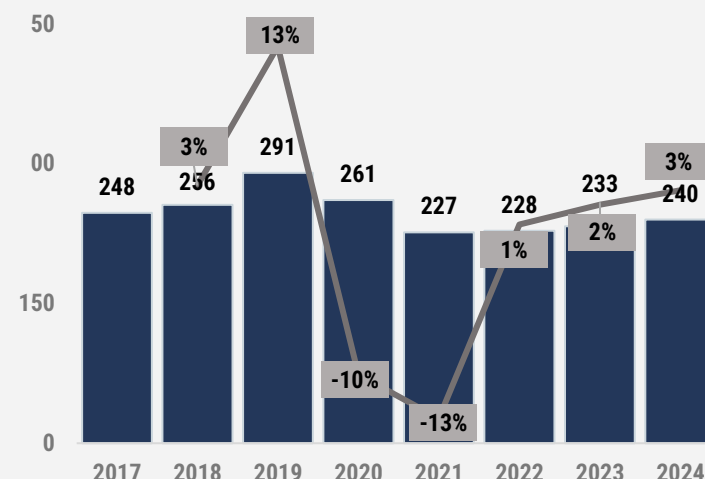
Imports Value of Parts of Airplanes, M\$



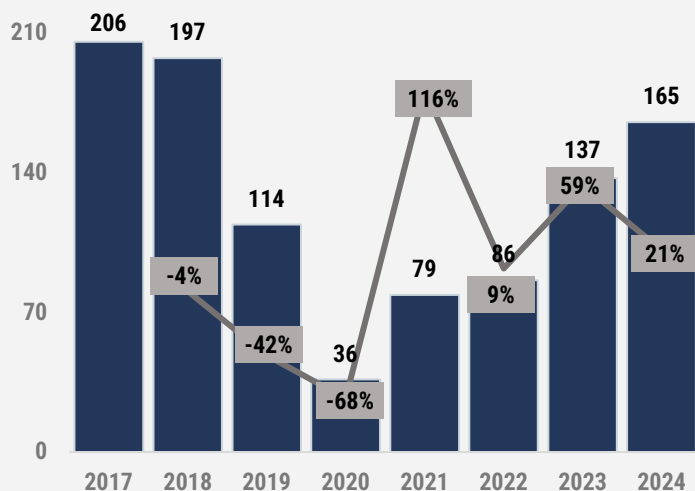

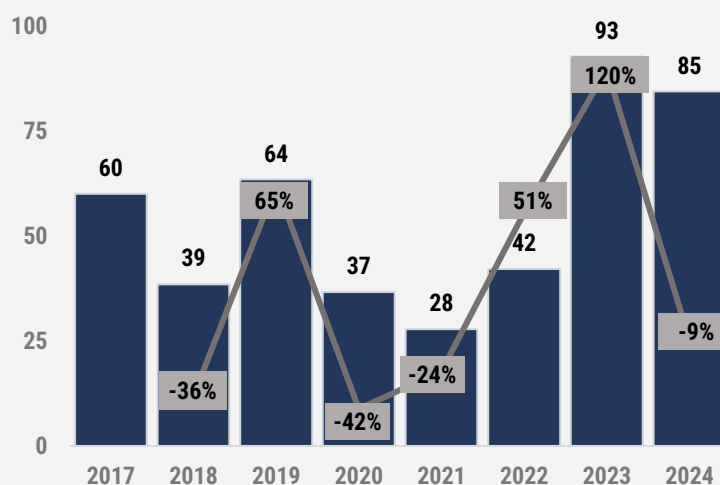
Imports Value of Medicaments, in measured doses, M\$

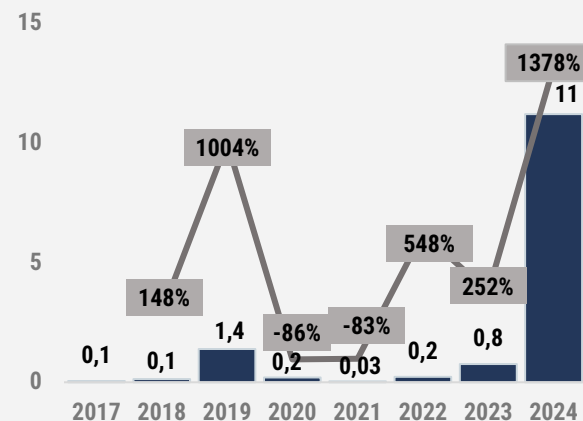

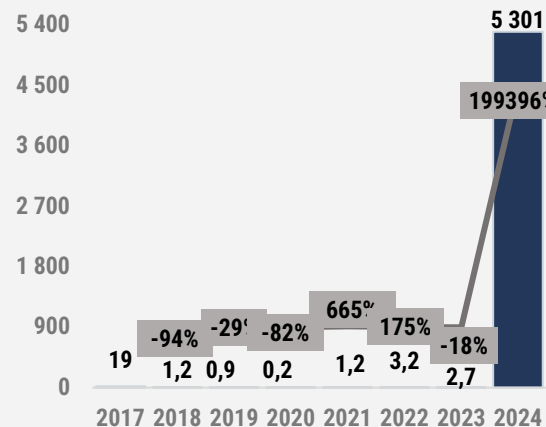

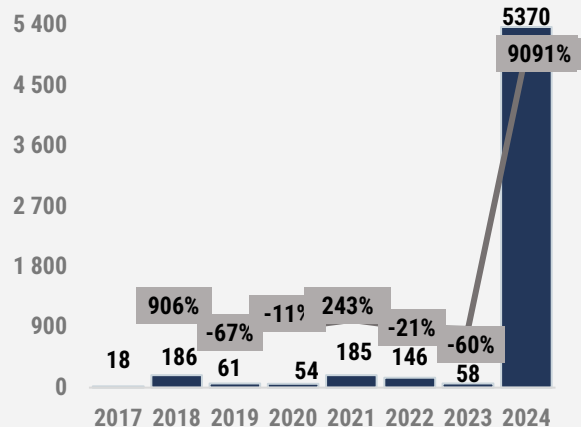

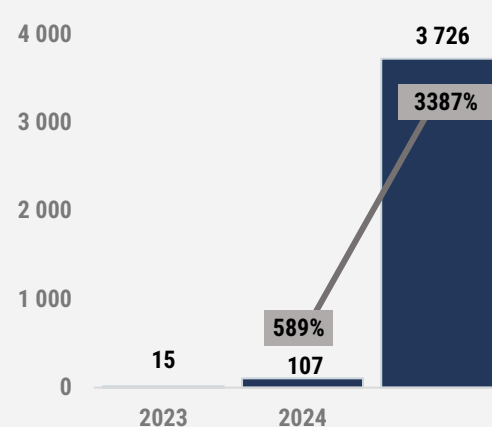

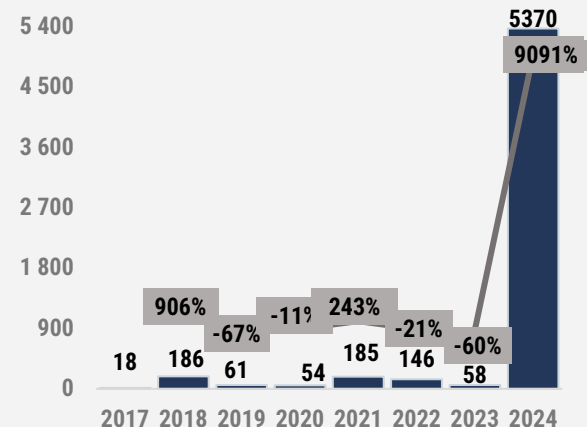

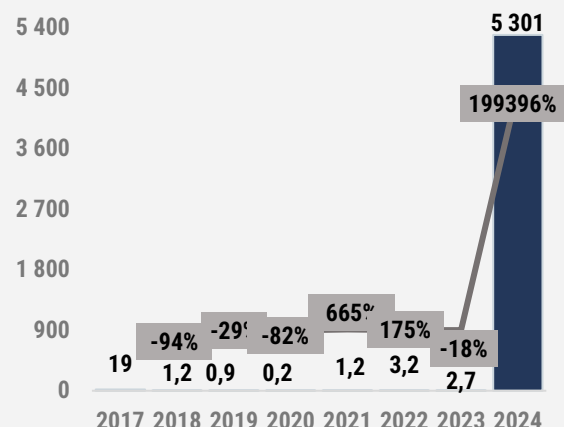

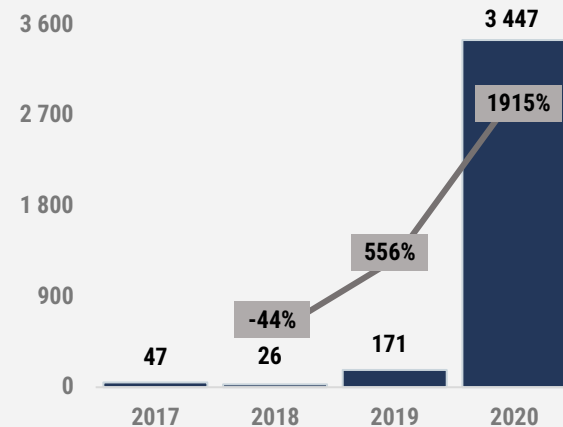

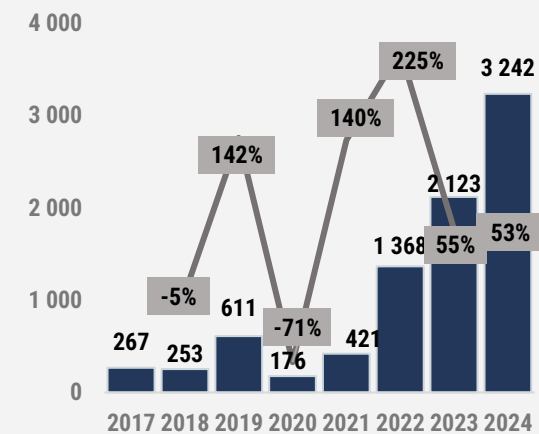
