
Roadmap

Allow more than 99 cash accounts - For PBA

With the PBA and other legislative changes, there is a requirement for more than 99 cash accounts within Jobpac. Previously cash accounts were defined through the system parameter maintenance by using system parameter CASH, as the primary cash account, and CASHnn as the additional cash accounts (where nn = 01-99). Now the cash accounts CASH-CASH99 will still be able to be maintained through the system parameter maintenance, and a new cash account maintenance program will be available to maintain those accounts plus up to 9899 other cash accounts.

Note: This Maintenance program can be setup as a standalone menu option if you are comfortable with CMS Menu Design. Or seek support if you need assistance with adding the new option.



• MFA 24 hour keep alive


Allow MFA (multi-factor authentication) to stay alive to avoid having to enter the code for the next 24 hours. To activate this feature you will need to raise a support case via a senior company role such as a CFO/CIO, or higher. If the support case is created by a less senior role, you will need to complete the authorisation form below and attach it to the case. This change requires company approval and impacts all users within the company that has MFA activated.

 As part of the GUI / WUI parity project we have added two new uploads to the WUI that previously only existed in the desktop version of Jobpac.






• P&L with EBITDA line descriptions

Based on feedback from initial modifications we have allowed the ability to enter your own descriptions for Profit lines on your P&L with EBITDA. EBITDA line text 'Earnings before tax, depn and amort.' can be soft coded via system parameter EBITDA.

- System parameter EBITDA/position 1-36:
 - Text to be printed on the EBITDA line.

Add job status column in BFM Contract Valuation job list screen.

Jobs that may have had a YTD impact on profit may be in a variety of Job Statuses. This modification makes it easier to see on the List screen for projects in Contract Valuation. Also included on the download.



• Approval Efficiencies when emailing the Approved PO or SC back to the Requestor

Based on Feedback from previous enhancements in this area, it was too slow when activating the setting that automatically emailed the Approved SC and PO back to the Requestor on final approval. This was due to the interactive nature of the Job. We have changed this feature to work in the background and therefore preserving efficiency in the Approval process. If you have deactivated this feature in the past due to slowness, you may want to reactivate the feature and test in this release.




• One click Send for Approval and One click Print

We like to reduce clicks in every release and this release is no exception with the new one click send for Approval and one click Print features. Where previously you would need to go to Actions and then Send, now you will see the recognisable paper aeroplane icon and where you see this you can click on it to send. See the example screenshot below. The Print Icon will show where there is an appropriate print facility in the Actions list. In the example below the Print Icon will produce your PO and allow you to distribute it with one click.



• Show the Entered Date in Prepare Invoices for Approval screen.


The Entered Date can be accessed via the Received Date tab - toggle between Received Date and Entered Date using the Action option.



Replace the Related Content File Queue and Upload

The upload to Related Content has been upgraded to newer technology that not only keeps our architecture up to date but adds a picture file preview if the file to upload is an image and also a status bar on each file to be uploaded. All other functionality in terms of viewing content and context linking remains unchanged.





• Integration of Jobpac Connect to 'Viewpoint TEAM' for mobile Project Management

Modifications have been included in this release to integrate Enterprises, Jobs, Users to Viewpoint TEAM. In addition we have provided deeplinks from TEAM back to Jobpac if you are using both products in a browser. This means you will be able to raise variations, PO's, and enter forecasts in Jobpac without leaving the Viewpoint Team Project Management Platform. We plan to officially launch this feature in June when documentation is complete. Stay tuned!

• Security - Password length increased to 10 characters

On next Password change users will be required to increase their password length to 10 characters. This requirement is part of SSO project alignment






Clicking on 'Forgot your password?' will present the following screen where it will prompt the user for their Jobpac username.

There has been a need in Jobpac to allow mixed tax codes in subcontract agreements.








The tax codes will be visible in the DESCRIPTION tab in Subcontract Maintenance.




Tax code can be entered when adding new subcontract variation items through the Variation Register.





The tax codes will be visible when preparing the subcontract payments in the Original Works and Variation screens.



Note: When retention is held it is held proportionally against the claimed items. When retention is released it will be released top down through the SC Items against which there is held retention. The GST on the Retention release Invoice will be calculated as the addition of GST calculated against each item from which retention is released. This may lead to Retention Release Invoices with dissections of varied GST codes.

• Advanced approval enhancements - rearrange RMB options
