2019 Roadmap

- Changes to HELP (Higher Learning Loan Program) repayment thresholds and rate.
 - Tax Maintenance changed to allow access to HELP rates via new Action 'HELP Rates'.
 - Extra rows are now available to enter rates for:
 - Tax-free threshold claimed or foreign resident.
 - No tax-free threshold claimed.
 - Employee Maintenance changed to allow employees to use No tax-free threshold claimed.
 - Payroll processing will pick up the appropriate rates for the employee and amount being paid.
 - -
- NW OWP Modification and Leave Loading Legislation Requirements.
 - Annual leave rate The annual leave rate will be the greater of the employee's ordinary weekly pay or average weekly pay.
 - Ordinary weekly pay (OWP) is calculated as the total gross pay over 4 weeks prior to the end
 of the last payroll period and dividing by 4.
 - Average weekly earnings (AWE) is calculated as the total gross earnings over 12 months prior to the end of last payroll period and dividing by 52.

The weekly pay will be converted to hourly rate using the standard hours nominated on the employee maintenance. The hourly rate will be compared to the Employee rate. System will use the greater value for the annual leave rate.

- Sick leave and other leave Payment for sick and bereavement leave, public holidays and alternative holidays is calculated using relevant daily pay (RDP) or average daily pay (ADP)
 - RDP means paying an employee what they would have earned if they work on the day. As it is not possible for Jobpac to determine the employee relevant daily pay, we do not use RDP to calculate sick and other leave.
 - ADP is the daily average of the employee's gross earnings over the past 52 weeks. This is worked out by:
 - Adding up the employee's gross earnings over the past 52 weeks
 - Dividing the gross earnings by the number of whole or part days the employee either worked or was on paid leave.

ADP is then converted to hourly rate based on the employee standard hours and hourly rate will be compared to the employee's rate, the greater value will be used.

- The review leave rate program has been changed to show the ADP, OWP and AWE.
- If you select to review leave rate,
 - You can nominate to either use ADP, OWP or AWE to calculate rate.
 - You can change the hourly rate, worked hours in a day, days in a week or hours in week.
- Transaction Definition has been changed to remove relevant daily flag and to include 'Leave rate to use' (Holiday & Leave Rate).
- HP 8% on Gross Earnings You can now automate the HP 8% on Gross Earnings via Employee Allowance / Deductions. Transaction type must be LLD and "P" on P/A column.
