Anxiety and Division

MIDTERMS WILL TAKE PLACE AS AMERICANS HAVE DEEP CONCERNS ABOUT THE FUTURE



58% of Americans

say things in the U.S. are off on the wrong track

Causes of concern:

Economic concerns:

- > 81% believe the U.S. economy is likely to experience a **recession in 2022**
- > The **rising cost of food and gas due to inflation** is putting stress on American families who report cutting back on a variety of expenses

Russia's invasion of Ukraine:

- > 64% are concerned about Russia's influence around the world
- U.S. adults are split on what should be the bigger priority for the U.S. in response to Russia's invasion of Ukraine – sanctioning Russia as effectively as possible (51%) or limiting damage to the U.S. economy (45%)



DEEPLY EMOTIONAL ISSUES ARE BEING FOUGHT IN STATE LEGISLATURES ACROSS THE U.S.



School Curriculum

- Only 24% of Americans believe that schools in their areas spend too much time teaching about race, compared to 53% who believe they spend about the right amount or not enough time
- But **42 states** have introduced bills that would limit public schools' ability to teach about race, gender, and sexuality



Abortion Rights

A leaked draft opinion from Justice Alito suggests SCOTUS is set to overturn *Roe v. Wade* this summer. The decision would mean that abortion rights are no longer protected at the federal level; states will have the right to enact reaching restrictions.



Voting Rights

27 states have introduced bills with restrictive voting provisions including stricter voter ID requirements and limits to same-day voter registration



OVERTURNING ROE: STATES WILL HAVE THE RIGHT TO ENACT FAR REACHING RESTRICTIONS

- A leaked draft opinion from The Supreme Court is unprecedented. In response, Chief Justice John Roberts has launched an investigation.
- Pres. Biden's statement on the draft opinion stated that it will fall on voters to elect pro-choice officials to adopt legislation codifying *Roe v. Wade*.
- Senate Majority Leader Chuck Schumer (D) has vowed to introduce legislation to protect abortion rights at the federal level, but it likely won't pass a filibuster challenge.

Where Americans stand:

- > 25% believe abortions should always be legal with no restrictions
- > 33% believe abortions should be legal with some restrictions
- > 30% believe abortions should only be legal in special circumstances, such as when the life of the woman is in danger
- > 12% believe abortions should be illegal in any circumstance
- > 56% are more likely to support a political candidate who supports *Roe v. Wade* than one who opposes it
- > 75% of Independents would oppose a candidate who wants *Roe v. Wade* to be overturned








Ban enacted prior to *Roe* that was never removed


Passed bans or extreme limits on abortion that could be enforced without *Roe*

Presidential Performance

AMERICANS ARE DISSATISFIED WITH PRESIDENT BIDEN'S FIRST YEAR DESPITE NOTABLE ACCOMPLISHMENTS

56% thought Pres. Biden's first year was a failure

54% think Pres. Biden is not fulfilling campaign promises

52% think Pres. Biden is doing more to divide the nation that unite it

Signed into law during President Biden's first year:

American Rescue Plan Act: \$1.9 trillion focused on U.S. economic recovery from the COVID-19 pandemic including stimulus payments, increased unemployment benefits, and expansion of the child tax credit


Infrastructure Investment and Jobs Act: \$1.2 trillion for American "hard" infrastructure such as roads and bridges

Two stopgap bills to avoid government shutdown

Juneteenth National Independence Day Act: Established June 19 as a U.S. federal holiday commemorating the end of slavery in the U.S.

Uyghur Forced Labor Prevention Act: Banned imports from China's Xinjiang region unless proven they were not made with forced labor

APPROVAL RATINGS ARE DOWN AMONG BOTH DEMOCRATS AND INDEPENDENTS





REPUBLICANS ARE MORE ENTHUSIASTIC ABOUT VOTING IN 2022; YOUNG VOTERS May pose challenges for democrats

67% of Republicans

are very interested in the 2022 midterm elections

50% of **Democrats**

are very interested in the 2022 midterm elections

Young voters:

Concerns about turnout: Younger voters had strong turnout numbers in 2020, but only 36% of 18–29 year olds currently believe they will definitely/very likely vote in 2022.

Don't have strong party ties: Younger voters are less likely than older generations to identify with either party, and sizable numbers believe the Democratic and Republicans parties care more about the elite than people like them (39% and 51% respectively).


Student loans: 85% of young Americans support some form of government action on student loan debt, with 38% supporting total debt cancellation



THE GOP HAS HISTORICAL AND STRUCTURAL ADVANTAGES GOING INTO NOVEMBER



History

- The President's party historically loses seats – 27 on average.
- Only Clinton ('98) and Bush ('02) gained seats in the midterm election over the past 30 years. Both had approval ratings over 60%.



Redistricting

New state maps have been drawn after the 2020 census.

TX: +2 seats

CO, OR, FL, MT, NC: +1 each CA, IL, MI, NY, PA, OH, WV: -1 each




The Virginia and New Jersey Playbooks

- Biden won Virginia in 2020. The GOP candidate (Youngkin) won the Governor's race by 2 points – a shift of 12 points in the GOP's favor.
- Biden won New Jersey in 2020 by 17 points. The Democratic candidate (Murphy) won the Governor's race by 3 points – a shift of 14 points in the GOP's favor.

But who will break through in the primaries?

- > Pres. Trump's support for controversial primary challengers may cause headaches for the GOP.
- > Pundits are watching if Democrats run progressives or moderates in the battleground.




Change from old maps:

SENATE: REPUBLICANS ARE DEFENDING MORE SEATS BUT THEY ONLY NEED TO FLIP ONE



STATES TO WATCH

Only 5 seats are true toss-ups

- Two are held by the GOP:
- > Incumbent Sen. Ron Johnson (WI)
- > Retiring Sen. Pat Toomey (PA)
- Three are held by Democrats:
- Incumbents Sen. Mark Kelly (AZ), Raphael Warnock (GA) and Sen. Catherine Cortez Masto (NV)
- The GOP is targeting the seat held by **Sen. Maggie Hassan (NH)**



HOUSE: THE GOP ONLY NEEDS 9 SEATS TO TAKE CONTROL

The RNCC is targeting more seats than the DCCC:

- > Of the 31 seats the DCCC is targeting, 7 are suburban districts Democrats held before the 2020 election
- > The RNCC is targeting 72 seats:
 - 23 districts that Biden did not carry or that Biden carried by 5 points or less
 - 33 districts where Biden won by <10 points

Democrats are defending twice as many toss up seats as Republicans:

> 27 House seats are currently rated "toss ups" - 19 are held by Democrats and 8 are held by Republicans

Democrats are retiring in higher numbers (30 to 18), though most are in safe seats

- > Several Republicans are running for higher office including open Senate seats
- > Four of the Republicans retiring from public office voted to impeach Pres. Trump

ALL EYES WILL BE ON SUBURBAN VOTERS AND DISTRICTS HEADING INTO NOVEMBER

The suburbs have continued to grow in recent years.

- Throughout COVID-19, more Americans have been moving to the suburbs, particularly in the south and southwest.
- In two sunbelt states with toss up Senate elections Democrats have been improving their performance in the suburbs, specifically in Maricopa County, AZ and Clark County, NV.



- Suburban voters are focused on practical issues like the economy and education.
- They are concerned about rising crime, and don't respond to Democrats' calls to defund the police.
- These voters are also not excited by the Trump wing of the Republican party's extreme views on social issues.

Though the suburbs were important for Biden's win in 2020, Democrats will face challenges without Trump on the ticket.

- In 2020, 26% of Biden voters selected him because they did not like Trump's policies, compared to only 9% of Trump voters who cast their vote because of opposition to Biden.
- Republicans picked up 15 seats that were almost all in the suburbs in 2020.
- Suburban areas in Virginia were crucial to the Republican gubernatorial candidate Youngkin's win in 2021.
