- ❖ The staff and the students should be educated to prevent the usage of one time use and throwaway plastics in the premises as per Tamilnadu G.O M.S No: 84 date: 26.05.2018, Environment and Forest department.
- ❖ Adequate fire safety precautions should be made and NOC should be obtained from Fire and Rescue Department.
- ❖ Safe and protected drinking water alone should be supplied for consumption.
- ❖ The premises should be inspected periodically for mosquito breeding places and all measures should be taken to keep the premises mosquito free.
- ❖ For running a food establishment / canteen, permission should be obtained from the food safety department.
- ❖ Incinerator shall be installed for safe disposal of sanitary napkins.
- ❖ On no account sale of tobacco products should be permitted within the premises.
- ❖ Any occurrence of communicable disease should be notified to the Public Health Department.
- ❖ Necessary building plan approval should be obtained from concerned department to run the school.
- ❖ The certificate issued is liable to be cancelled at any time on infringement of any of the above said conditions and for improper maintenances of sanitation, improper maintenance of the building as well as urinals and toilets in the building.


