

Upcoming Medi-Cal Changes *(State and Federal Legislation)*

Background - Federal Changes

- H.R. 1 was signed into law on July 4th, 2025
 - Also known as the One Big Beautiful Bill (OBBBA)
- Includes substantial changes to Medi-Cal ranging from limitations on enrollment to redefining immigration statuses

Provisions Effective in 2026



Asset Limit Restored

Who is Impacted:

Individuals with disabilities, those over age 65, and certain family based Medi-Cal members

Asset limit for eligibility will be re-established for those that qualify for Medi-Cal due to disability, age, or Long- Term Care status

- \$130,000 for one person
- \$195,000 for two people
- \$65,000 for each additional household member



Asset Limit Restored

Who is Impacted:

Individuals with disabilities, those over age 65, and certain family based Medi-Cal members

Assets include:

- Bank Accounts
- Homes (personal residence is exempt)
- Land
- more than one vehicle

Exempt Assets:

- Personal residence
- One vehicle
- Household items



Enrollment Freeze for Individuals without Satisfactory Immigration Status

Who is Impacted:

Individuals without
Medi-Cal that are
age 19 and older
without
Satisfactory
Immigration Status

Beginning Jan 1, 2026, adults, age 19 and older, who do not have satisfactory immigration status

- Only eligible to enroll in restricted-scope Medi-Cal benefits
 - emergency services
 - Pregnancy and postpartum services



Enrollment Freeze for Undocumented Individuals enrolled in Full Scope Medi-Cal

Who is Impacted:

Medi-Cal members age 19 and older without Satisfactory Immigration Status For individuals age 19 and older without Satisfactory Immigration Status and are enrolled in full-scope Medi-Cal before Jan 1st, 2026

- Full coverage will continue (be frozen) as long as benefits are not discontinued.
- If Medi-Cal is discontinued for late or missing renewal, there will be a 90-day grace period to restore full-scope benefits.



Enrollment Freeze on Full-Scope Medi- Cal for Undocumented Individuals

Who is Impacted:

Medi-Cal members age 19 and older without Satisfactory Immigration Status Important for Medi-Cal members without SIS to complete Annual Renewals

- Read mail sent by Social Services and
- Provide any renewal packets, forms, or verifications requested by Social Services
- Update Social Services of address changes as soon as possible to ensure you are receiving your mail



Loss of Adult Dental Coverage for Undocumented Adults

Who is Impacted:

Medi-Cal members age 19 and older (not pregnant) without Satisfactory Immigration Status

- Dental benefits will be discontinued for adults who do not have Satisfactory Immigration Status
- Emergency dental care will still be covered
 - Such as treatment for severe pain or infection and tooth extractions



Effective: Oct 1st, 2026

Amended Definition of "Qualified Non-Citizen"

Who is Impacted:

Medi-Cal members with refugee, asylee, parolee or other similar humanitarian immigration classifications

Establishes a new definition for "qualified non-citizen" (QNC) for federal Medi-Cal eligibility

Only the following QNC categories will remain eligible for federal Medi-Cal:

- Lawful Permanent Residents who have been in the US for more than 5 years
- Specified Cuban or Haitian Entrants
- Migrants legally residing in the US and its territories under a Compact of Free Association
 - Palau, Micronesia, Marshall Islands
- Non-citizen Medi-Cal members who do not meet the new qualified definition may only qualify for state-funded coverage



Provisions Effective in 2027



Work/Community Engagement Requirement

Who is Impacted:

Medi-Cal members age 19 to 64 at application and each redetermination

Requires 80 hours monthly in one of the following activities:

- Work (seasonal work will be averaged over the last 6 months)
- Monthly earned income is at least 80 times the federal hourly minimum wage (\$580)
- Enrolled at least half-time in an educational program
- Enrolled in a work or employment training program



Work/Community Engagement Requirement

Who is Impacted:

Medi-Cal members age 19 to 64

Exemptions for the work requirement include:

- Parent/guardian/caregiver of a dependent child age 13 or younger
- Parent/guardian/caregiver of a disabled individual
- Pregnant or Postpartum period
- Disabled Veterans

- Foster youth or former foster youth under age 26
- American Indians or Alaska Natives
- Incarcerated or recently released (within the past 90 days)



Work/Community Engagement Requirement

Who is Impacted:

Medi-Cal members age 19 to 64

Exemptions for work requirement:

- Currently meeting TANF (CalWORKS) or CalFresh work requirements
- Participating in drug addiction or alcohol treatment programs

- Has one of the following health conditions:
 - Blind or significant vision loss
 - Disabled, affecting work
 - Substance Use disorder
 - Serious medical/mental health conditions



Six-Month Renewals

Who is Impacted:

Medi-Cal members in the adult expansion group age 19 to 64

- Eligibility will be subject to a renewal every 6 months instead of every 12 months
- Process will be similar to the current annual renewal process
- Adults who fail to complete the renewal process will be discontinued



Monthly Premium Fee for Undocumented Adults

Who is Impacted:

All Medi-Cal members age 19 to 59 without Satisfactory Immigration Status (SIS) Adults age 19-59 without SIS will have a \$30 per month premium

Includes LPRs who have been in the US for less than 5 years

If the premium is not paid, Medi-Cal will be reduced to restricted-scope only

 Restricted scope covers emergency and pregnancyrelated services only

Provisions Effective in 2028



Effective: Oct 1st, 2028

Cost Sharing for Expansion Adults

Who is Impacted:

All Medi-Cal members with income between 100% FPL and 138% FPL A copay will be required for certain medical services for individuals above 100% FPL, excluding primary care, mental health, and substance use disorder treatment.

• Primary, prenatal, pediatric, mental-health, and emergency care remain exempt from copays.

Copays will range from \$1 to max \$35

Amount will be determined by the state



Key Actions to Emphasize for those without Satisfactory Immigration Status (age 19 and older)

Apply Before 2026

 Important to Apply for Medi-Cal before the end of the year to have full scope Medi-Cal

Stay Covered After 2026

- Important to keep Medi-Cal active to retain full scope coverage
- Be sure to complete all required paperwork such as renewal packets
- Provide all requested information/verifications



- BenefitsCal.com
 - Account can be set up by Medi-Cal Members
 - Can electronically send documents and messages to Social Services worker
 - Updates can be provided, such as address changes
 - Submit paperwork
 - Complete forms
