BIG NEWS FOR WHALES

...and seals, and penguins, and the millions of Greenpeace supporters who participated in our campaign to protect the Ross Sea! Known as the Last Ocean because it is the most pristine shallow sea left on earth, the Ross Sea is now also known for being the world's largest marine protected area.

In late October, the momentous agreement was made by Members of the Commission for the Conservation of Antarctic Marine Living Resources to safeguard 1.55 million km² of the Ross Sea in the Southern Ocean. Greenpeace has been fighting to protect the Ross Sea as a protected area since it was first proposed in 2011 - and even much before that, pushing policy makers since the early 2000s to establish sanctuaries in Antarctic waters.

This victory is groundbreaking in many ways, not just for its size. Most importantly, we were able to get the international community to agree to protect waters that are outside of any one country's jurisdiction, in the high seas. Areas beyond territorial waters have long been like the wild west in terms of lack of regulations, except with no sheriff. This is the kind of precedent that should help jumpstart a lot of other big wins for the ocean.

But our work is far from over. Two additional proposals for marine protected areas in East Antarctic waters and the Weddell Sea are still being discussed. With your continued support, Greenpeace will continue working to protect this precious habitat.
