# July Speakers: Candidates for the Charlotte County School Board District 1

*Geri Waksler* is a lawyer, businesswomen and long-time community volunteer and advocate. A Charlotte County resident for 34 years, she has been managing partner of two law firms and, together with her husband Joe, owned and operated Morton's Ace Hardware from 1984–2015.

For over 20 years, Geri has served local organizations focused on children and education. She is a co-founder of Charlotte Academy (now called Charlotte Preparatory School) and served on its board of directors for 7 years. She is a past-president of the board of the Boys and Girls Clubs of Charlotte County, Inc., a past-president and current board member of the Charlotte Local Education Foundation, and for the past 9 years has conducted weekly mentoring sessions with at-risk Charlotte County high school students.

Geri's husband and two sons all graduated from Charlotte County Public Schools. She is a 1998 graduate of Leadership Charlotte and a 2015 graduate of Leadership Florida and has served on its statewide Leadership Team for the past 3 years.



Cara Reynolds: I grew up in a small town just outside of Cleveland, Ohio. After graduating with my Bachelor of Science in Middle Grades Education, I moved to Charlotte County in late 2005, and was hired as a teacher at Port Charlotte Middle School.
