## June Speaker: Horatio Mihet, Esq., Vice President of Legal Affairs and Chief Litigation Counsel with Liberty Counsel



Horatio (Harry) Mihet is Vice President of Legal Affairs and Chief Litigation Counsel with Liberty Counsel, an international nonprofit litigation, education, and policy organization dedicated to advancing religious freedom, the sanctity of life, and the family. With offices in Florida, Virginia, Washington, D.C., and a presence in Israel, Liberty Counsel has hundreds of advocates around the world.

Harry grew up in communist Romania, where his father pastored seventeen, mostly underground churches. Harry and his entire family suffered great persecution. At the age of 12, Harry participated in the Christmas Revolution of 1989, when a spiritually starved nation rose up and overthrew the oppressive Communist regime. Shortly thereafter, through a series of miracles, God brought Harry's family to the United States.

Harry received his undergraduate degrees in Political Science and Criminology from the University of Florida. In 2002 he graduated *magna cum laude* from Duke University School of Law and spent the first 6 years of his legal career working for two of the largest law firms in the country, defending America's largest companies. Harry joined Liberty Counsel in 2008, after sensing God's call to defend our most cherished freedoms. Since then, Harry has participated in many critical issues, including the defense of pro-life Americans facing frivolous lawsuits by the Department of Justice; the defense of high school administrators charged with criminal contempt for the crime of "praying"; and the defense of Rowan County, Kentucky, clerk Kim Davis, who was jailed because of her conscience and religious beliefs regarding marriage.

Harry has appeared on countless national television outlets, including CNN, Fox News, CBS, NBC, ABC, as well as numerous radio programs. Harry and his wife, Tammie raise their two young boys in Florida.
