- The proposal should convey the analysis and thinking that has been done for the brand name and logo preparation, therefore written proposal with innovative design ideas will be more highly considered.
 - Best value for money is also a criterion.
 - Points will be awarded for each factor identified in the requirement of the bid proposal. The three companies with the most number of points will be identified and asked to present their art work proposal and from these presentations the final successful bidder will be chosen.

6. Delivery Method

- All logos and graphics must be copied to a compact disk in either .tiff or other form with a transparent background.
 - With the submission of the logos and the designs, the designers should submit a coversheet with the designer's name, contact details and an email address, price, along with a brief written explanation of the concepts used in the logo and the graphic designs.
 - The cover sheet must detail the colours and the font used in the logo and visual designs.

1. Background

The objective of the project is to significantly increase the use of banking system transactions for effecting or receiving payments for labor, goods and services nationwide through the implementation of a national inter-operable payments system that facilitates access to financial services and allows users to create and access their bank account using any mobile phone operator and cashing through any banking agent.

Terms of Reference

1.0 Introduction

Male' Health Services Corporation (MHSC) has been recently formed to provide the health services and health care facilities in Male', Hulhumale', and Villingili. The corporation would be taking over 5 entities including IGMH, Male' Health Centre, National Thalassemia Center, Hulhumale' Hospital, and Villingili Health Center. The company is in the initial stage of setting up a corporate environment and Governance structure as well a business model in which it will operate. In this respect the Board of Directors (BoD) of the company in consultation with the Ministry of Finance and Treasury (MoFT) has resolved to seek assistance from an external consultant with the main objective of setting up a proper business model/structure as well as policies and procedures required in setting it up.

2.0 Overall Guidelines

The project is divided into two phases, and the phases can be conducted simultaneously. Consultants may submit proposals for the two phases separately, and different consultants may be selected for the phases/or components of a phase, depending on the proposals being submitted.

Consultant should confer with relevant stakeholders; coordinate with Industry Associations / Member Business organizations and other associations / actors in value chain throughout the consultancy.

The design of the policies, protocols and interventions should focus on bringing in international best practices and approaches into the corporation.

3.0 Scope

 - The plan should be a feasible business model upon which the future direction of the MHSC will be based.
 - The plan should include a 5 year implementation plan for the recommended business model with a comprehensive market analysis and business potential including the steps needed for MHSC transition to the recommended business model;
 - The plan shall recommend systems and processes for resource mobilization and financial sustainability of MHSC

REQUIREMENTS

The basic requirement of the Bank of Maldives Plc is for the External Auditors to report on the truth and fairness of the financial statements of the Bank. This shall include audit of all its 25 Branches, Head Office Departments and Development Banking Cell. The audited Financial Statement and Management letter must submit on or before 28th February 2011.

SELECTION CRITERIA

The external audit of the Bank must be undertaken by an accounting firm whose principal is a member of an accredited professional body related to the audit profession that is affiliated with an international association such as the International Auditing and Assurance Standards Board (IAASB) and must be a license holder to operate in the Republic of Maldives.

- The firm must have some form of representation in the country for the duration of the audit.

manager for the assignment and detail their experience and qualifications.

METHODOLOGY AND BIDDING PROCESS

The Bid Committee of the Bank shall provide bidders with the information available on the Bank so that they can prepare their bids. The bidding process shall be open to international and domestic auditing firms whose principal is a member of an accredited professional body.
