Subject: Clarification on the status of expatriate members of Maldives Retirement Pension Scheme (MRPS)

The Maldives Retirement Pension Scheme (MRPS) is administered under the Pension Act of the Maldives. The Act mandates the participation of all employees including foreigners.

Under the first amendment made to The Pension Act, mandatory participation for the foreigners has been delayed up to 3 years impending the regulation for their participation as well as a mechanism for their payouts.

After the amendment, foreign employees who were already contributing to the scheme were given the option whether to stop or continue their contribution. The choice was left for the employee and the employer to decide upon mutual agreement. Most of the employers chose to stop the contribution effective May 2011.

Under the prevailing conditions, the amount In the Retirement Savings Account (RSA) can only be disbursed when a pensioner attains the pensionable age (65 years). However, sooner the foreigners' payout regulation gets finalised, we will be able to offer other alternatives.

In the meantime, we kindly request the expatriates who are leaving the Maldives, to provide their personal information to the Pension Administration Office by filling the 'Members Information Sheet'. The information sheet will be available from the pension office or can be downloaded from our website www.pension.gov.mv. This sheet would serve as a record as well as source from which we can obtain the contact details of the expatriates.
