The Ministry of Housing, Transport and Environment is seeking consultancy services to fill in the post of National Consultant – Conservation Specialist (Retainer Basis) through Atoll Ecosystem-Based Conservation of Globally Significant Biological Diversity in the Maldives' Baa Atoll project (AEC Project) implemented by this Ministry with the assistance from UNDP and Global Environment Facility. AEC project is a project on the conservation and sustainable use of globally significant biological diversity in the Maldives' Baa Atoll.

Description of Responsibilities
