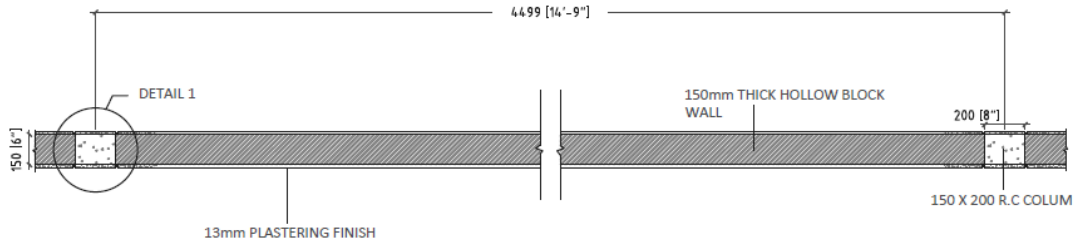

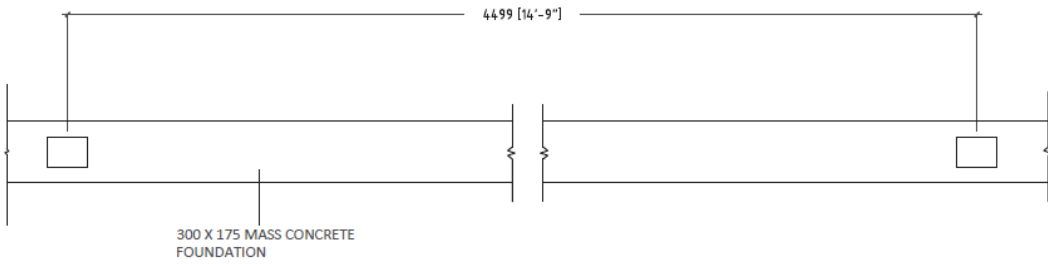


DETAL- COLUMN STUMP

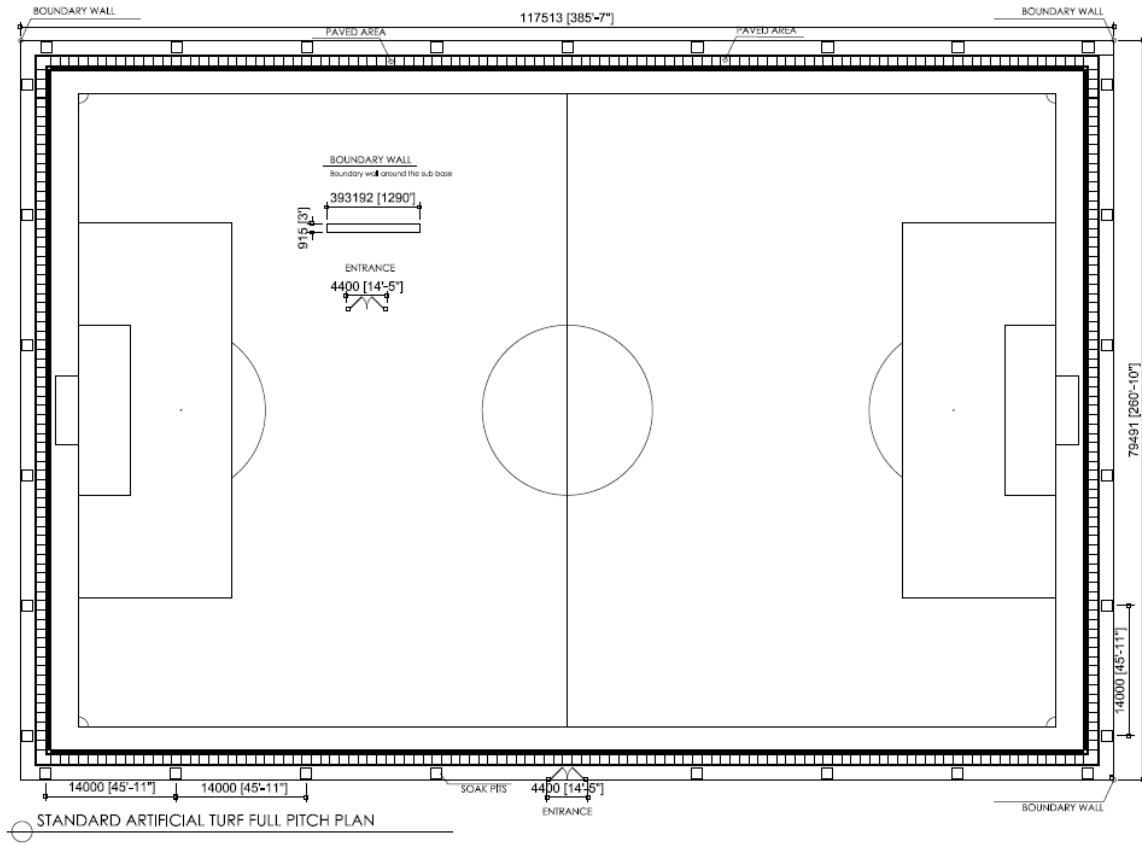


PLAN

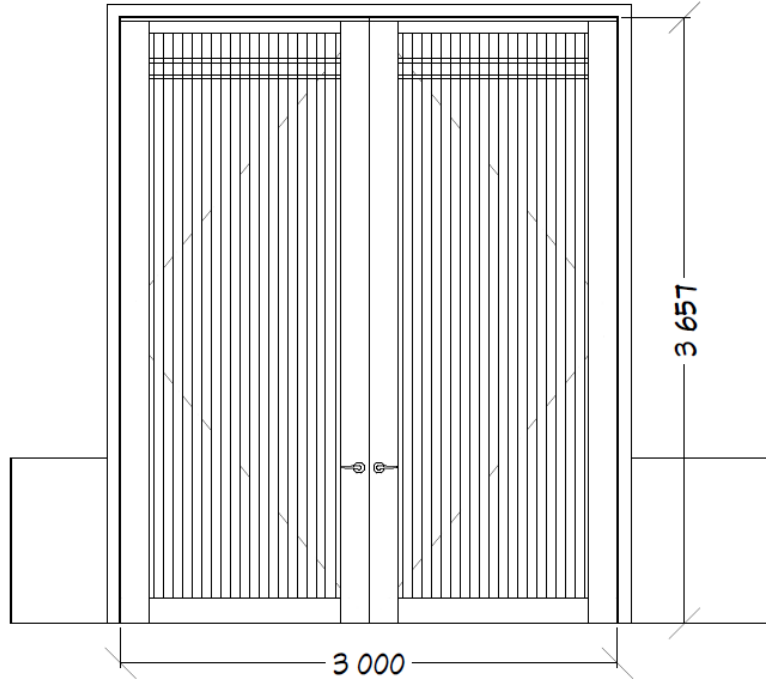
FOUNDATION PLAN

5th Floor Plan



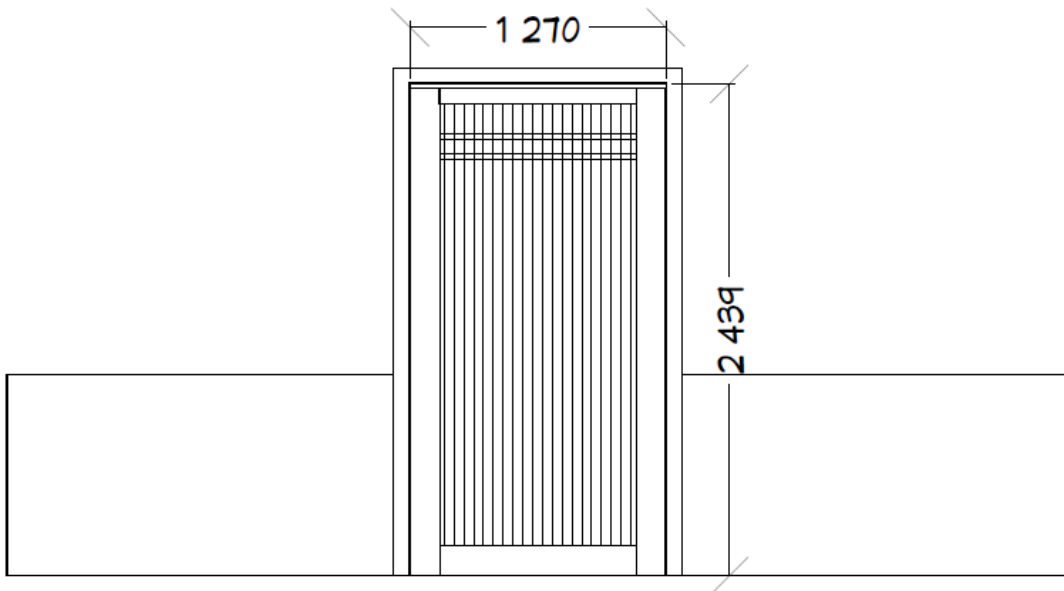

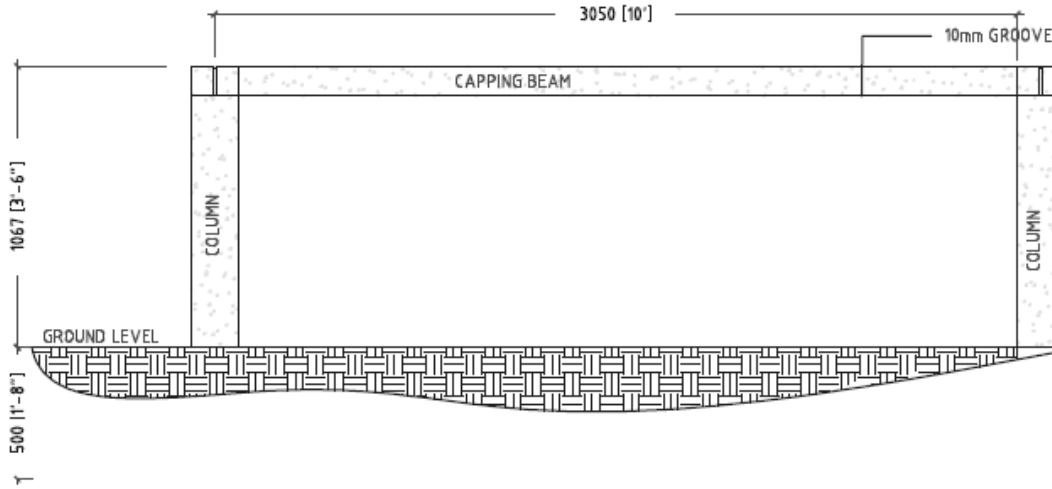

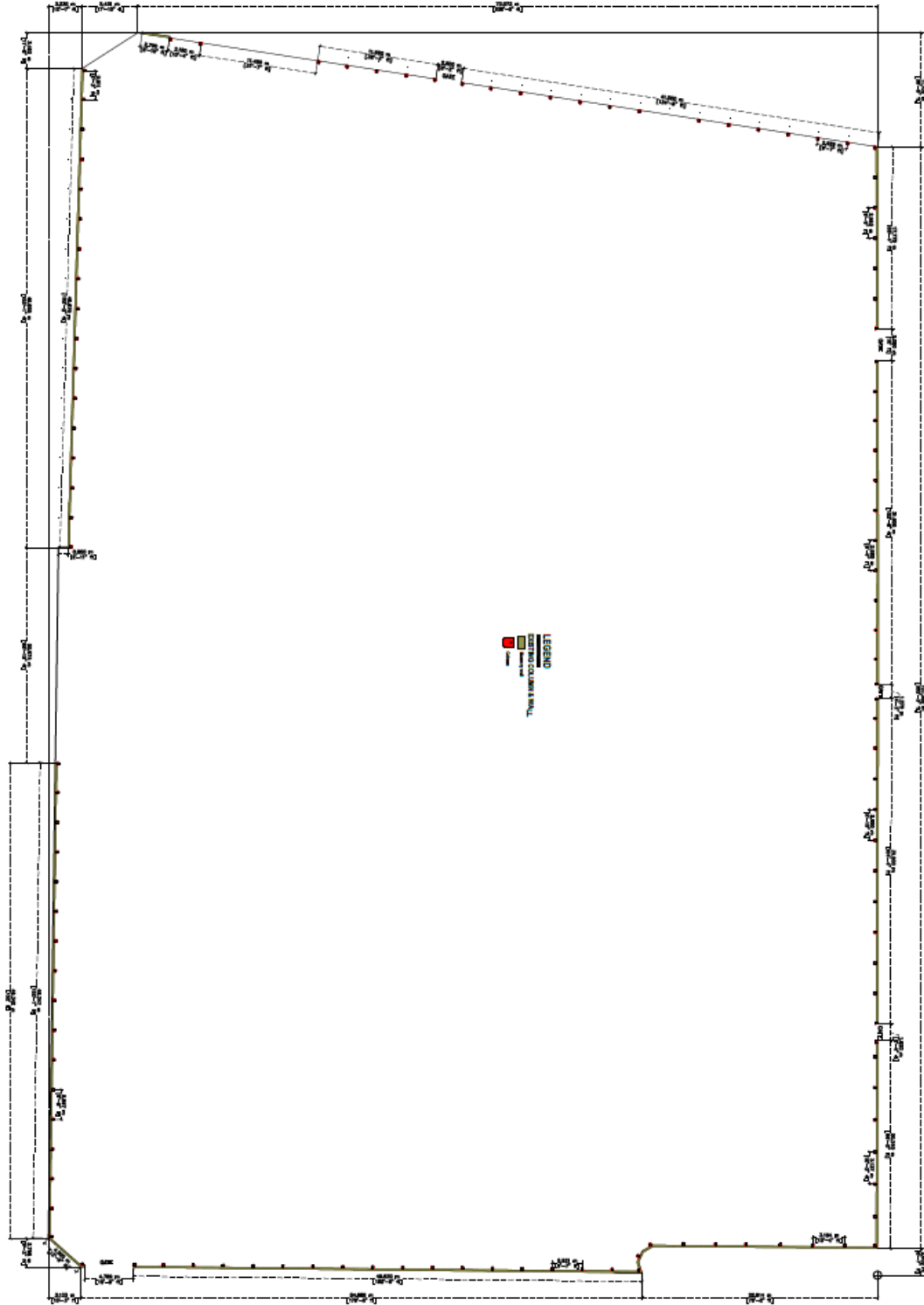

Bid Security Format

THE CONDITIONS of this obligation are:

A. If the Bidder:

- i. having been awarded a Notification of Award of the Bid by the Council during the period of Bid validity refuses to accept the Award for any reason
- ii. After being awarded the Notification of Award of the Bid by the Council during the period of Bid validity, refuses to fulfil the obligations required prior to signing the Agreement stated in the Bid Document of iulaan number: (IUL)341/341/2023/5
- iii. Refuses to sign the agreement during the period stated in the Bid Document of iulaan number: (IUL)341/341/2023/5

We undertake to pay to the Council the above amount upon receipt of its first written demand, without the Council having to substantiate its demand, provided that in its demand the Council will note that the amount claimed by it is owing to the occurrence of any of the above conditions.

This guarantee shall be governed by and construed in accordance with the laws of the Republic of Maldives.
