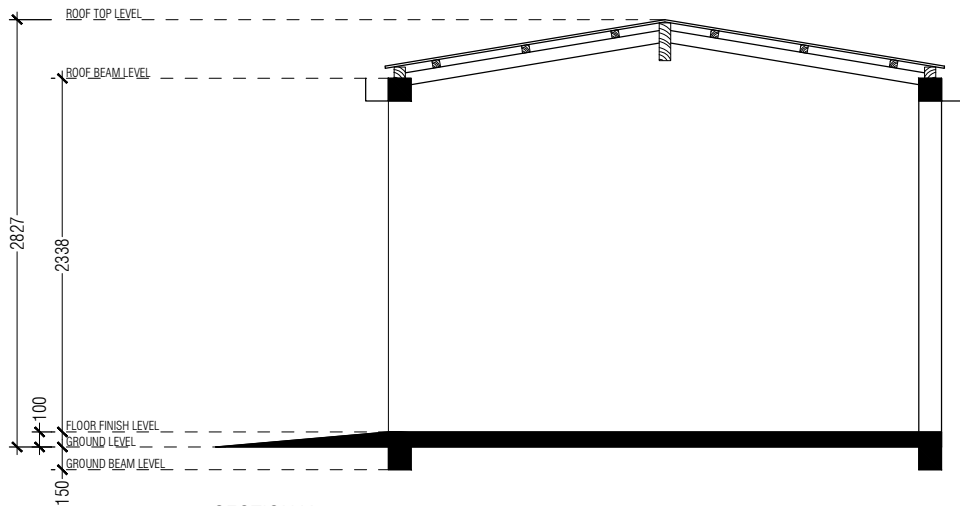


FOUNDATION AND COLUMN LAYOUT PLAN

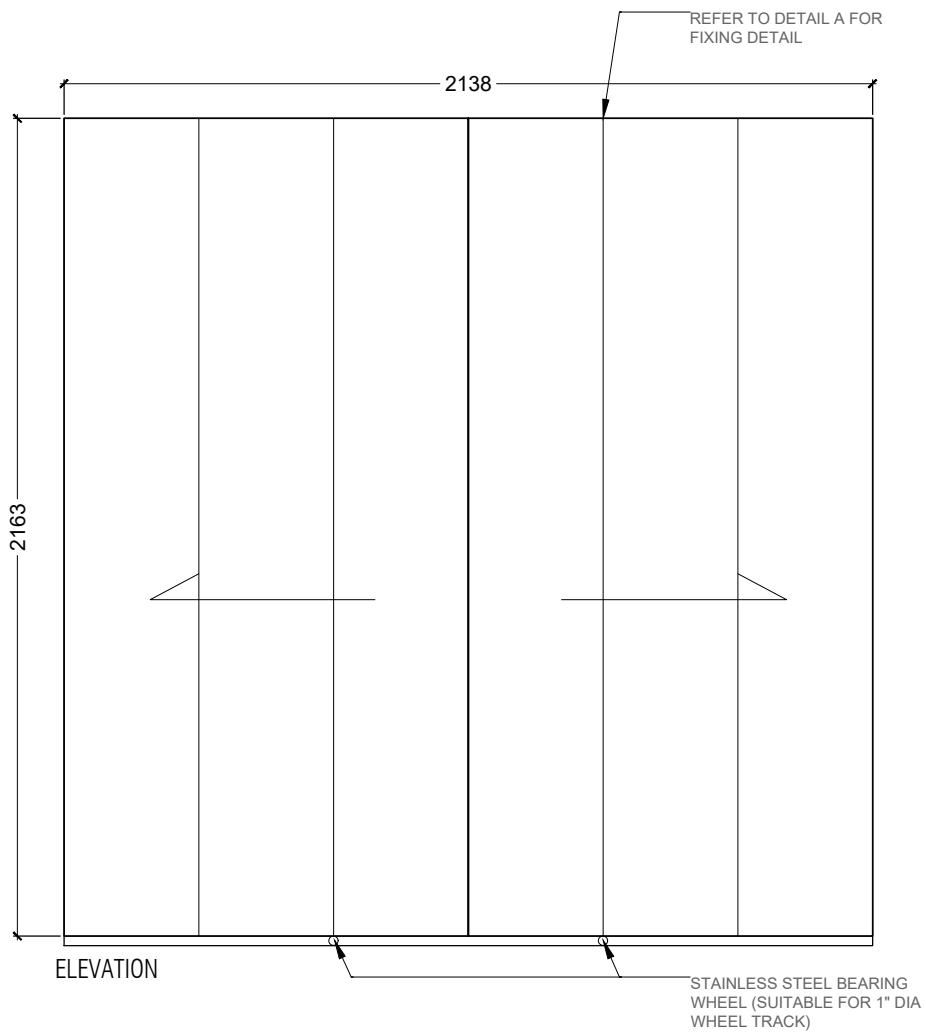

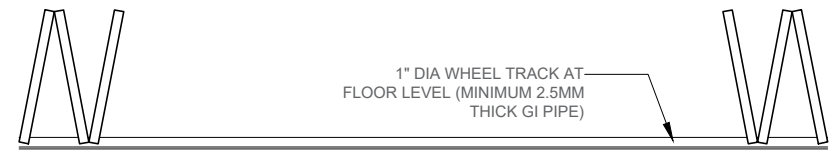

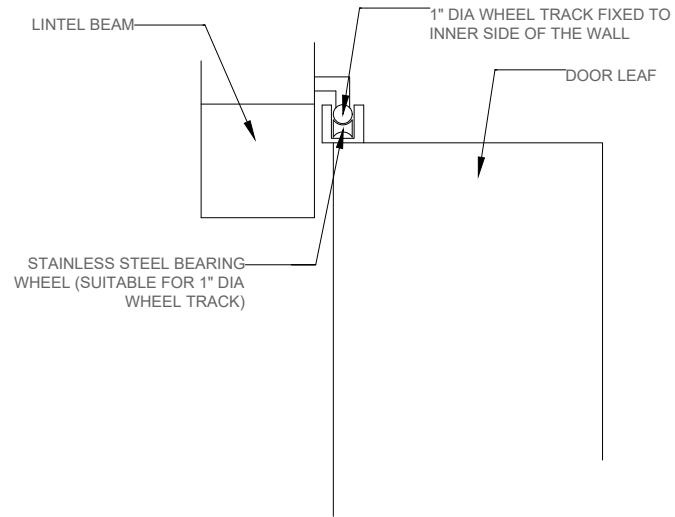




ELEVATION

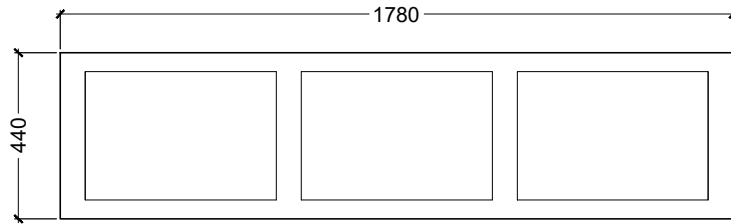

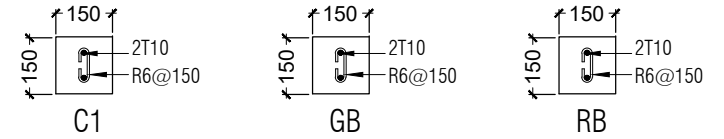
