سوال 2 - مساحت یک مثلث قائم‌الزاویه که وتر آن 100 و یکی از ضلع‌های آن 80 باشد.

80	$(\text{ارتفاع} \times \text{پایه} / 2) = (80 \times \text{ارتفاع}) / 2$	
20	$(\text{مساحت قائم‌الزاویه} / \text{ارتفاع} - \text{مساحت قائم‌الزاویه}) \times 2 = (20 / \text{ارتفاع} - 20) \times 2$	
100	جمع	

**\*تذکره:** مساحت یک مثلث قائم‌الزاویه برابر است با حاصلضرب یکی از ضلع‌های آن در دیگری و تقسیم بر دو. (3.3) اگر فرض کنیم که یکی از ضلع‌های مثلث قائم‌الزاویه 80 و مساحت آن 20 باشد، داریم:

$20 = (80 \times \text{ارتفاع}) / 2$  →  $\text{ارتفاع} = 0.5$

پس مساحت مثلث قائم‌الزاویه برابر است با  $(100 \times 0.5) / 2 = 25$ .

مساحت قائم‌الزاویه دیگر برابر است با  $(80 \times 0.5) / 2 = 20$ .

بنابراین مساحت کل برابر است با  $25 + 20 = 45$ .
