

Technical Requirements:

- 1- Cut, Fill, and Shape the Subgrade and Compact to get the specified cross elevation and CBR of minimum 60% for the carriageways.
- 2- Construction of 150mm thick Cement Stabilized Base Course.
- 3- Application of Prime Coat (MC-30) at 1.0 liters/m²
- 4- Construction of 50mm thick Asphalt Wearing Course.

Responsibilities of Client:

- 1- Site for installation of the Asphalt plant and storing all Machineries will be provided by the Client.
- 2- Electric Power for operating the Equipment and Machineries will be provided by the Client.
- 3- Providing all raw materials required for construction of Carriageway.

Responsibilities of Contractor:

- 1- Contractor is required to provide all required equipment, machineries, and staffs for construction of the Carriageway.
- 2- Salaries including food and accommodation for the staffs have to be provided by the Contractor.
- 3- Mobilization and Demobilization cost have to be borne by the Contractor.
- 4- Fuel required for operating equipment and machineries have to provided by the Contractor.

Documents that need to be submitted as a minimum:

- 1- Company Registration Certificate.
- 2- GST Registration Certificate.
- 3- Details of Equipment and Machineries (specifying present location, registration certificates / import documentation).

Minimum Equipment and Machineries Requirement:

- Asphalt Plant, Asphalt Paver, Tandem Roller, Pneumatic Roller, Bitumen Sprayer, Dump Trucks, Loader/Excavator/Grader
- 4- Details of Manpower (CV).Minimum Manpower Requirement:
- Road Engineer, Site Supervisors, Operators (Plant, Paver, Rollers, Sprayers, Trucks, Loader/Excavator/Grader), Rake man, Screed man, Laborers.
- 5- Experience records of similar works in past two years.
- 6- Bid Security of MVR 15,000.00 (Fifteen Thousand Rufiyaa) with validity of 20 days shall be submitted along with the bid.

Notes:

- 1- All works have to be completed within 30 days of receiving Instruction to Mobilization. If works are not completed within 30 days, 0.25% of the total contract price shall be deducted per calendar day.
- 2- Price should be submitted in Maldivian Ruffiyaa (MVR).
