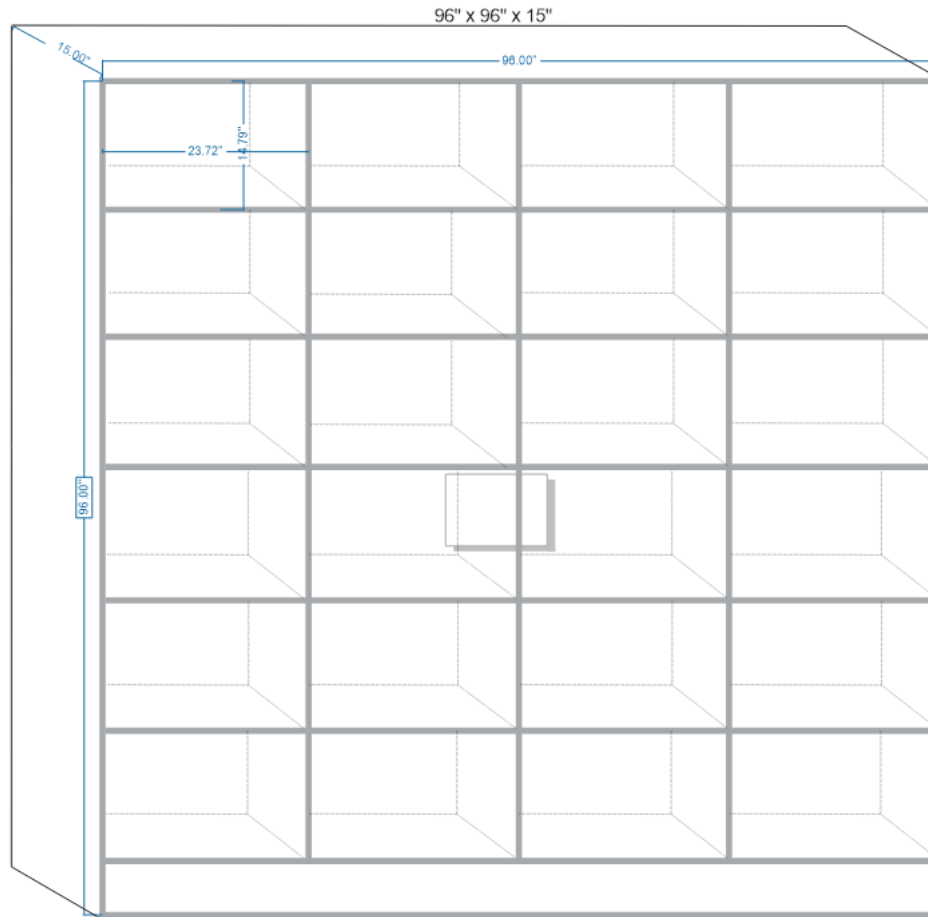

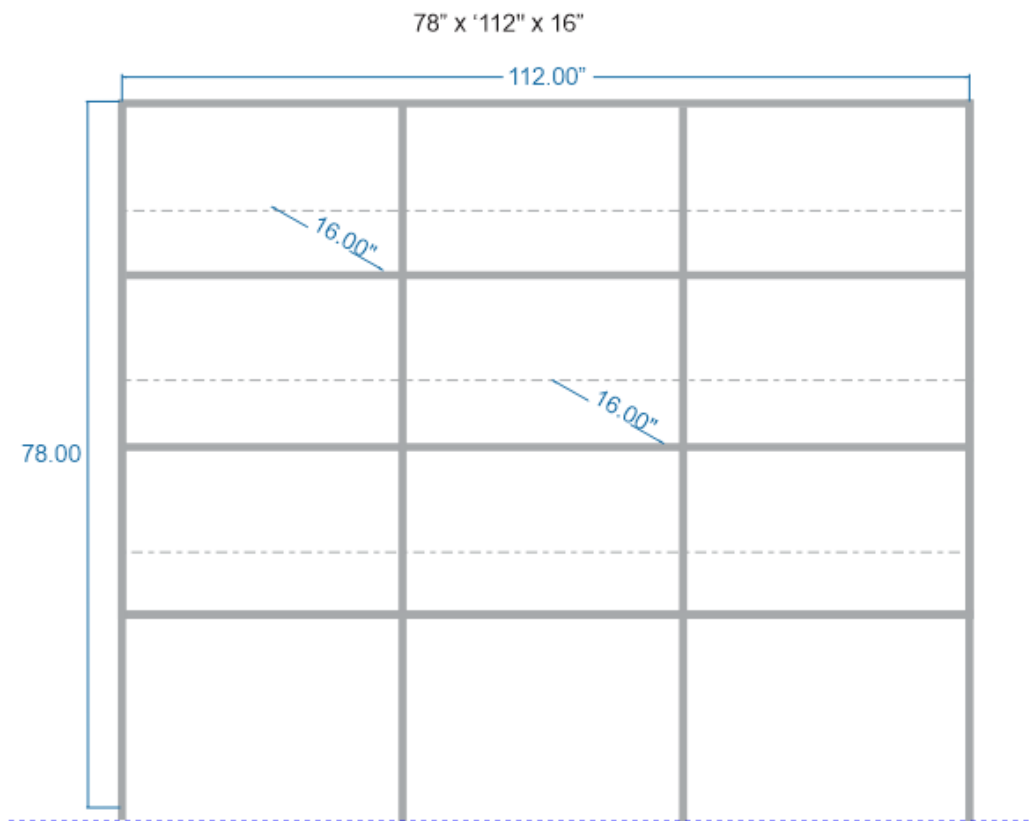
Science Lab Cupboard with Door
