Section III: Technical Information

Information Sheet – S.Hulhumeedhoo Outfall Rectification

Objective of the project is to refurbish the existing sewer system in S.Hulhumeedhoo. Under the scope of works is laying of new outfall line by horizontal drilling method as per the specification mentioned below. And, connecting to existing outfall line and removal of existing pipeline and blocks from lagoon.

Scope of works

- Contractor shall price for all materials, pipes fitting, transportation, labour, equipment's, site clearance, drilling, anchoring of outfall pipe, laying of pipes etc.
- HDPE Black Pipe and fitting PN16, and SDR11 shall be used.
- It is the sole responsibility of the contractor to obtain the necessary approvals form the relevant Government authorities, however the Client will assist the contractor in obtaining the relevant approvals.
- Drilling and laying 331m of DN225mm HDPE pipe adjacent to the existing sea outfall pipe in STP. And casting and fixing of anchor blocks at diffuser point.
- Outfall pipeline must be butt welded and joined in flanged connected sections.
- Fixing of diffuser at pipe end at a depth of 5.5m from mean sea level.
- Connection of newly laid outfall line to old line near the shoreline point as instructed by engineer.
- Clearance of old outfall pipe and damaged/old blocks from the lagoon area as instructed by site engineer.
- The following technical documents are attached with information sheet.
 - Location of sea outfall.
- Contractor shall provide the following documents after completion of civil works.
 - As-built drawings of newly laid pipeline.
 - Pictures and videos of fixed pipeline and diffuser.
