Invitation for a bid

Project title: Interoperable Criminal Justice Data Management System

<u>Statement of work</u>: Procurement of Milestone Products

Project summary

Lack of accurate crime data is a long pending problem of the Criminal Justice System in the Maldives. Over the years several discussions have been held to overcome this with little success. A major reason why no substantial improvement in crime data collection and dissemination has been materialized include the fact that there is no leading agency responsible for crime data as crime records involve several government and state agencies. The various stakeholders of the criminal justice system, such as the Police, Prosecutor General, Judiciary and Prisons as well as social services institutions have different mandates and requirements that needs to be catered for. Because many of these stakeholders have already developed their own systems in isolation, merging these or bringing changes to make an interoperable system has remained an unachieved vision.

Yet, the need for such a system is undisputed. Both the government of the Maldives and international donor agencies are invested in improving the quality of available crime and justice data and agree that a more interoperable system is the solution. Different key works are already in motion for the implementation of this system. One of the key components among the system implementation is acquiring software licensing and training required for the system.
