



## TERMS OF REFERENCE

### Project Coordinator

**Project name:** “Strengthening health system to effectively respond to Covid-19 situation; through early detection and, appropriate care and support for vulnerable and disadvantaged populations” under the program “Covid-19 Pandemic Emergency Prevention and control at country and regional level in SAARC”

#### 1- Background

Health protection agency intends to hire a **project Coordinator** in coordinating the project “Strengthening health system to effectively respond to Covid-19 situation; through early detection and, appropriate care and support for vulnerable and disadvantaged populations” in the Maldives. The successful candidate will work under direct supervision of the National Programme Manager at Health Protection Agency.

#### 2- Scope

**Projects implementation:** to ensure smooth project implementation, including planning, coordination, resource management, monitoring & evaluation of project related activities, and reporting to donors and other stakeholders.

#### Duties and responsibilities

- Acts as the main/key person to implement the project and share workload with project assistants
- Handle key communication/correspondence and documentation related to the project
- Organize and lead regular team meetings (physical and virtual), and coordination meetings
- Provide support to team members in compiling project reports
- Develop specifications for bid documents, ToRs, SoPs and other documents related to the project.
- Identify, network and coordinate with implementing partners
- Implement monitoring and evaluation activities
- Prepare and timely submission of project progress (including financial) reports
- Track progress of implementation of activities
- Handle media coverage/publicity (including social media), related to the project
- Conduct orientation sessions, and present project related information in meetings and other platforms, when required
- Compile training materials and information packages required for trainings and orientations
- Review and revise project workplans
- Carryout any other relevant tasks assigned by Health protection Agency.

- Excellent interpersonal and communication skills.
- Demonstrated capacity to timely delivery of assigned responsibilities and meeting targets
- Experience in working with projects/programs addressing/targeting migrants' health would be an added advantage
- Ability and sensitivity to work with a wide range of partners/stakeholders including Government, INGOs and private sector
- Excellent interpersonal skills, proven networking, team-building, organizational and communication skills.

6 months, initial, and can be extended to one year.
