### Submission Requirements

#### Presentation

- Authors are expected to submit editable word files of their papers/articles via email, to [international.affairs@agoffice.gov.mv](mailto:international.affairs@agoffice.gov.mv) including the following details of the Author(s):
  - Full name and affiliations,
  - Correspondence details (Contact number, email address)
- All papers/articles should be of a minimum 3000 words (counted excluding referencing) , constitute of a main title and a short abstract of not more than 150 words relating to the subject matter discussed in the paper/article.
- Authors may decide to include several subheadings within the paper/article for further reader engagement.
- The paper/article should be in either Dhivehi or English Language, and shall conform to acceptable grammatical standard.
- All papers/Articles written in English shall be in Times New Roman font, Font Size 12pts and where the paper/article is in Dhivehi it shall be in Faruma font, Font Size 12 pts, at a line spacing of 1.5. Text should not be indented with each subheading, but should be justified at the left-hand margin.

#### Referencing

- All papers/articles submitted shall be referenced properly using the OSCOLA referencing system.

- URLs to the sources should be provided where necessary.

- Full citation of the cases shall be written in italics in the main body of the paper/article as well as in the footnotes.

### Responsibility of Contributors

- All papers/articles submitted shall be accompanied with a declaration of the author that the research or work presented is original, not under consideration by another journal/publisher, and have acquired the necessary permissions if a previously published material is being reproduced.
- Paper/article may consider alternative jurisdictions within the ambit of the theme or subject matter designated for the particular edition, however, authors are encouraged to afford special attention to implications/issues within the Maldivian legal system.
- Authors may indicate the section of the Law Journal they wish their paper/article to be published, however the editorial team retains the authority, for purposes of coherence or any other reason, to forgo the suggestion put forth by the author.
- It is the author's responsibility to ensure that all the citation and references are correct. The author shall ensure that that the material presented is not defamatory or litigious.
- Author shall be responsible to acquire the necessary ethical/ copyright clearances from all relevant parties before a paper is submitted.
- Once a paper/article is submitted to be published in the Law Journal, particular piece will be reviewed by the editorial panel. All authors are expected to engage with the editorial board, accept editorial changes and the decisions to publish or not to publish a submission.

### Editorial guidelines

- Target audience for the journal is educational institutions in Maldives, law students, lawyers, academicians and personnel of the legal fraternity. This Law Journal envisages to thematically consolidate legal literature into one compilation.
- Submissions to the Law Journal will be reviewed by an editorial panel, on the content, arguments, extent of critical analysis, grammar and quality of language.
- The review process will be in a total of three phases;

- i. Editorial board to suggest changes to presentation, arrangement and comment on quality of content;
  - ii. follow up changes from the first review ;
  - iii. final proof from the reviewer and the author.
- Editorial panel expects papers/articles to be of a professional standard with clear and concise expression and style. Arguments should be well developed, backed by evidence and timely.
  - All authors are encouraged to explore novel sectors of the Maldivian legal system, and present their findings in alignment with the theme for each edition.
