Technical information for H Frame Scaffolding



1. Main Frame made of galvanized steel with lockable pins to hold braces.

Width: About 125 cm

Height: Not less than 170 cm

Tube OD: About 45mm

Tube Thickness: Not less than 2mm

Material: Steel

Surface Type: Hot Dipped Galvanized

2. Cross brace: To hold the 2 main frames
3. Scaffolding plank: Aluminum plank to fit the length of the main frame
4. Join pin: To connect the main frames on top of the other
5. Caster Wheels: lockable and sturdy
6. Jack base: Scaffolding Adjustable Base Jack for H-Frame. About 12 to 18 inches long.
